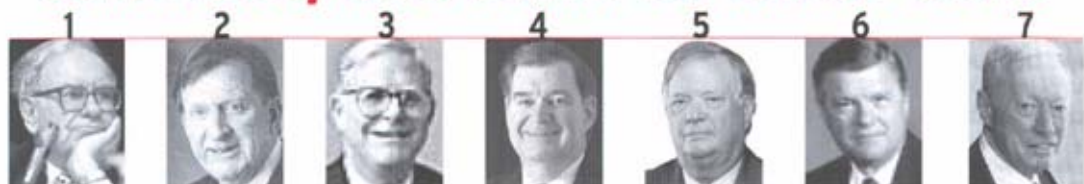

A Petition to SunTrust Banks:

Your bank boasts that it is "one of the nation's largest financial holding companies," with assets exceeding \$117 billion. You take special pride in your relationship with The Coca-Cola Co., extending back to Coke's first public stock offering in 1919. As the owner of 5% of Coca-Cola's common stock, SunTrust is Coke's second largest shareholder.

SunTrust's and Coke's leadership and ownership are so intertwined that it's hard to tell them apart. The seven individuals above are some of Coke's and SunTrust's top policymakers. In light of the overwhelming evidence that Coke bottlers in Colombia, South America, allow and encourage paramilitary terrorists to murder, torture and kidnap union leaders and organizers, SunTrust and these seven men, in particular, must be held accountable.

Coca-Cola always places its own selfish, profiteering agenda ahead of peoples' concerns. In the U.S., Coke workers have exposed rampant racial discrimination and inattention to workplace safety. Parents and pediatricians denounce Coke for aggressively marketing its soft drinks to children, fueling childhood obesity and diabetes. In India, Coke seizes and pollutes the water supplies of entire villages. In Africa, where Coke is the largest private employer, it treats the tragic HIV-AIDS epidemic as strictly a public relations problem.

Whenever Coca-Cola wants a quick infusion of cash – like a \$100 million line of credit or help with underwriting \$500 million in bonds, to cite two recent examples – SunTrust is eager to fork it over. But it's a different story for individuals and working families seeking such basic financial products as CDs, home equity loans and auto loans. Websites that monitor and compare bank rates consistently rank SunTrust's among the worst for consumers.

As more people learn how closely SunTrust is tied to Coke's wrongdoing, there will be a growing awareness of your failure to live up to your fiduciary responsibility to protect SunTrust's reputation. At the same time, your credibility with customers, potential customers and investors will surely suffer. If "The Real Thing" won't do the *right* thing in Colombia and elsewhere, SunTrust should sever all ties to Coca-Cola. Please let me know what you plan to do.
