This human tragedy started 30 years ago to the day when Leonard Peltier and others were arrested at Small Boy's Camp near Hinton, Alberta. He was



imprisoned in Canada for 10 months and then extradited to the United States to stand trial for two counts of first-degree murder in the killing of two FBI agents on Pine Ridge Reservation, South Dakota. In 1975, the United States was later forced to accept that the

affidavits they used to convince Canada to extradite him were false. Our lobby today is focused in Ottawa and across Canada asking Canada to condemn the U.S. actions and support the overwhelming world wide call for Leonard Peltier's freedom. Thirty years is enough for a crime that even U.S. prosecutors were forced to admit they cannot prove. Where there is no justice, there can be no peace. Join us in prayer and ceremony. We would ask all people to bring a gift for our traditional give-a-way. All people are welcome.
