

Politics in Vaughan has always been a rough-and-tumble affair, as was evident in the raucous scene at city council just days after Mayor Linda Jackson's 90-vote victory over Michael Di Biase in late 2006.

Supporters on both sides jammed council chambers at a special meeting called by then-mayor Di Biase, who requested a recount. The meeting had to be adjourned and police were called.

Today, Jackson finds herself facing possible dismissal from office, with charges expected to be laid under the Municipal **Elections Act regarding** campaign finance irregularities. An auditor's report alleged she had overspent her campaign limit of \$120,419 by at least 10 per cent, and possibly double that, while she campaigned on a promise to clean up troubled city hall. She also faces a coming audit on her office spending

The imbroglio is a continuation of the controversy that has dogged Jackson since the campaign.

Her predicament arises from the confluence of a tangled web of alliances and shifting allegiances at city hall. But primarily it's the result of actions begun by former Jackson supporters who have become disenchanted with her performance since the election, such as Gino Ruffolo, Mary Ruffolo and Carrie Liddy. At least part of their motivation has to do with Jackson's failure to press through with her campaign call for a public inquiry into allegations of corruption and other issues in city government.

Jackson's problems are amplified by the fact that she faces a council that, save one member, publicly endorsed Di Biase in the election.

Gino Ruffolo and Mary Ruffolo Former Jackson supporters who have turned on her

Mary Ruffolo launched a sexual harassment lawsuit against the city after quitting her job; the suit was settled out of court.

Couple is the subject of a gag order requested by the City of Vaughan; the city wants an injunction against them because of the number of information requests they have filed.

Gino, together with formerJackson supporter Quintino Mastroguiseppe, sought and won the audit of Jackson's campaign expenses. Audit led to hiring of independent prosecutor to lay Municipal Elections Act charges.

Gino has also filed in court allegations that Jackson was in conflict of interest when she voted in favour of the city's lawsuit against him and his wife.

Paul Donofrio

Former city employee, supported by Ruffolo and Liddy

Fired by the city, he filed a wrongful dismissal lawsuit and raised questions about invoicing practices in the city's fleet department.

He was the subject of private emails between Jackson and an unnamed York Region police officer, copies of which mysteriously landed on Di Biase's doorstep during the election campaign, causing an uproar. Jackson said they'd been stolen. Opponents questioned whether her personal contact with an officer who was privy to the investigation gave her an advantage in the election, which she fought largely on a platform of fighting corruption at

Campese also sits on board of Conservative Party in Vaughan. Sought an audit of Councillor DiVona, but was turned down by council. Is appealing that decision in court, along with two others.



Paul De Buono

President of Vaughan Watch, watchdog group of which he is the main . member

Sought an audit of Councillor Tony Carella and regional councillor Gino Rosati, but was denied by council. Has yet to decide whether to appeal decision in court.
