THODORIS ILIOPOULOS WINS HIS FREEDOM

After 49 days of hungerstrike, Greek anarchist Thodoris Iliopoulos is now free! On the 10 July 2009 Thodoris Iliopoulos. the last anarchist prisoner remaining in custody in Greece following the December Uprising of last year, started a hunger strike in protest against his continuing detention. Thodoris was detained on 3 trumped up charges, the only witness being a police officer, and he has been in prison under pre-trial detention ever since. On the 8th July bail judges denied Thodoris' petition for release from the Court Prisons of Koridalos. Athens, on the grounds that Iliopoulos is an anarchist and therefore a "danger for democracy."

He went on hunger strike on 10 July and for more than a month the authorities refused to provide him with proper medical support at a public hospital and instead kept him in the under-funded and under-equipped prison's medical room.

Anarchist comrades in Greece and abroad quickly mobilised in solidarity. and later leftist and communist political

parties also declared their support. As the voices demanding his release were becoming more and more, and as his case was being picked up by progressive media (due to massive protests and other solidarity actions that couldn't be left unreported) the government couldn't ignore the protests any more and set him free at last.

Free, but with a few conditions; he isn't allowed to leave the country and every fortnight he has to report to the local police station. He was set free without the need for bail payment.

It should be made clear that Theodoros Iliopoulos won thanks to his determination and to the Greek and international solidarity movement in his support.

Meanwhile, in Naxos, a small island in Greece, immigrants went on hunger strike today to protest about the denial of their human rights. The social war continues...

IMPRISONED RUSSIAN ANTI-FASCIST'S APPEAL REJECTED

The cou0rt has ruled to uphold the conviction of Alexei Bychin on Tuesday, in an appeal hearing that only lasted ten minutes, according to the imprisoned antifascist's lawyer, "They didn't listen to any of our arguments." The defense had asked for the conviction to be changed from "conscious bodily injury, dangerous to a person's life" to "excess of selfdefense". Bychin was sentenced to five years in a maximum-security prison on May 8 for stabbing two men in the city centre last year, while he insisted that he acted in self-defense as they attacked him. One of the men, who had allegedly been marching, shouting "Sieg Heil" and making Nazi salutes, turned out to be a police trainee.

An expert analysis presented by the defense showed that Bychin had a cut on his arm from a broken bottle that one of the alleged attackers had been holding. "After they pushed Bychin against the wall, one of them hit him on the head with a broken bottle and Bychin covered his head with his arms" she said. "It was disregarded by the court as irrelevant." The defense also presented a witness who said he saw Bychin being assaulted by two men, but the appeal court dismissed his testimony, because he saw the fight from a distance and could not clearly see the faces of the people involved.

Over the past three years, numerous incidents of the police arresting and beating antifascists and anarchists during rallies have been reported. Bychin carried a knife for self-defense, as many antifascists have done since 20-year-old anti-fascist punk musician Timur Kacharava was stabbed to death by a dozen Nazi skinheads in St Petersburg's city centre on Nov. 13, 2005. A fellow

activist Maxim Zgibai sustained multiple knife wounds and severe brain damage but survived this attack.

NEW ATTEMPT BY THE PRISON SYSTEM TO SABOTAGE JOHN BOWDEN'S PAROLE HEARING

"The contents of a prison intelligence report is the latest attempt to prevent my release. Essentially the strategy is the same as in 2007 - to try and persuade the parole board that I am linked to an illegal group on the outside (in 2007 it was a terrorist or paramilitary group, now it's a criminal or "gang-land" fraternity) and therefore represent a risk to public safety. The source of the allegations is senior prison staff who used the identity of people who have visited me in prison to claim an association with illegal groups. In 2007 "evidence" of my involvement with a "terrorist organisation" was a visit I'd received from two members of the Anarchist Black Cross, in 2008 "evidence" of my involvement in the Glasgow underworld was a visit I'd received from an ex-prisoner who I'd served time with.

When considering the release of a life sentence prisoner the parole board must consider public safety and whether the prisoner continues to represent a risk to the community. After almost 3 decades in jail and five years of regular access to the community in work placements and frequent home leaves, there was no serious suggestion that I presented any sort of risk to the community. Yet in 2007 a report submitted to the parole board by Matt Stillman contained the allegation that I was linked to a "terrorist" and "paramilitary" group.

As a consequence my parole hearing that year was postponed and I was returned to a maximumsecurity iail. Following an investigation the allegation was completely discredited, and I was returned to an open jail. In July 2009 prior to another parole hearing the report to the parole board claimed I had connections to wellknown gangland figures from the Glasgow area. As in 2007, there exists absolutely no evidence to support such an allegation. (...) What chiefly characterises their "intelligence" on me is a focus on my political attitude and opposition towards the prison system. Even my writings about the prison system are considered a "risk factor". In August 2008 I contributed an article on the history of the struggle for prisoners' rights in the newspaper Insidetime. The purpose behind treating such writings as a "risk factor" is twofold: to manu-facture vet another sham argument against my release, and to deter other prisoners from publicly voicing criticisms of the prison system."

GOVERNMENT DRUGS POLICY UNLAWFUL

Casev Hardison, 38, a US citizen serving 20 years for the manufacture of LSD and other psychedelic-type drugs, has today submitted an appeal against his conviction based on evidence that the Misuse of Drugs Act is being mal-administered by the Home Secretary. The government themselves have admitted that: "The distinction between legal and illegal substances is not unequivocally based on pharmacology, economic or risk benefit analysis. It is...based in large part on historical and cultural precedents." Hardison's appeal questions why the tolerance of substances such as alcohol is not extended to the equally or lessharmful psychedelic-type drugs of his indictment.

Should his appeal succeed, the government will be forced to prohibit alcohol and tobacco equally, or regulate the possession, production and commerce of dangerous or otherwise harmful drugs in a rational and objective manner.

Hardison states that the underregulation of alcohol and tobacco
activities has contributed to over a
million deaths in the United Kingdom
alone and the over-regulation of the
equally or less-harmful 'controlled'
drug activities has criminalised
millions of otherwise law-abiding
persons, clogged our courts and
prison system, and fuelled an
unregulated black market governed
only by the law of unintended
consequences. Hardison believes his
appeal is in the public interest.
