Method & Rationale

Overall, 1008 adults in Australia were surveyed via an online survey between 25th February and 1st March 2010.

According to Dr Jon Krosnick of Stamford University, a leading analyst of comparative research design, in a paper published in December 2008 (National Surveys Via RDD Telephone Interviewing vs. the Internet: Comparing Sample Representativeness and Response Quality), online respondent can be more accurate and more honest than when responding to many other survey methods.

A sample size of 1000 means a margin of error of +/-1.4 - +/-3.10 at the 95% confidence level. When looking at sub-samples, the margin of error is larger. Tabled below is a guide to confidence levels for various sample sizes.

Margin of Error at 95% Confidence Level

The questionnaire consisted of closed-ended questions about using illegal drugs and people's attitudes to illegal drugs in Australian society. A copy of the questionnaire is provided at Appendix 1.

All respondents were members of the SurveyVillage Panel, operated by Yellow Squares for the purpose of market and social research only. Randomly selected panel members were invited to complete the survey via an email which contained a link to the survey. Each panel member was given a small incentive for completing the survey and reminder emails were used to increase response rates.

SurveyVillage is a research panel with over 60,000 members, who currently respond to surveys conducted online, by telephone, by mail and are also often recruited for focus groups.

Because panel members complete a profile when they join the panel this source can be sampled in the same way as with a telephone survey, i.e. by City and State. Quotas were used to ensure the correct balance of men and women in each state and territory, as well as a representative distribution by age group.

Recruitment to SurveyVillage is done via a combination of sources and 80% of this is done online. Various methods of online recruitment are used such as;

1. Affiliate promotions with a diverse range of over 300 website's





- 2. Referral programmes with bonus incentives for the referring panellist (refer a friend)
- 3. Online paid content (similar to infomercials)
- 4. Advertising on social networking sites such as Facebook and Twitter.

Methods of recruitment not done online includes:

- 5. Recruiting at the Back-end of CATI surveys
- 6. Magazine/journal advertising
- 7. Bounty bag promotion (New mothers/National)
- 8. Shop-a-docket (National)
- 9. Yellow envelope (National promo mailer)
- 10. Community notices (National)

The survey results have been weighted to the most recent ABS (Australian Bureau of Statistics) population statistics by location, gender and age group.

McNair Ingenuity Research is accredited under AS ISO 20252, the new standard for market research in Australia. McNair Ingenuity Research's quality processes are independently audited to ensure the highest standard of research quality.

Results referenced to this survey can be phrased as follows:

Australia wide survey of 1008 adults conducted by McNair Ingenuity Research, AS ISO 20252 accredited research agency, via an online survey among surveyvillage panel members.



- Overall, 63% of respondents (which equates to approx 10.3 million Australian adults) said 'Yes', they did have friends that had tried or used illegal drugs.
 - Males (66% 'Yes') were more likely than females (59% 'Yes') to have friends who have tried or used illegal drugs.
 - The 55+ age group were least likely to have friends who have tried or used illegal drugs (43% 'Yes').
 - Respondents from QLD (71% 'Yes') were more likely to say they had friends who had tried or used illegal drugs, compared with the other States.
 - Respondents from non-metro areas were more likely to have friends who have tried or used illegal drugs (69% 'Yes'), compared with metro areas (59%).
- Overall, 37% of respondents (which equates to approx 6 million Australian adults) said to the best of their knowledge, none of their friends had ever tried or used illegal drugs.
- 1% of respondents refused to answer this question.

- Overall, 42% of respondents (which equates to approx 6.9 million Australian adults) said 'Yes', they have personally tried or used illegal drugs.
 - Males (47% 'Yes') were more likely than females (37% 'Yes') to have tried or used illegal drugs.
 - The 55+ age group were least likely to have tried or used illegal drugs (21% 'Yes').
 - Respondents from QLD (52% 'Yes') were more likely to have tried or used illegal drugs, compared with the other States.
 - Respondents from non-metro areas were more likely to have tried or used illegal drugs (48% 'Yes'), compared with metro areas (38% 'Yes').
- Overall, 57% of respondents (which equates to approx 9.4 million Australian adults) said they had never tried or used illegal drugs.
- 1% of respondents refused to answer this question.

- Overall, 22% of respondents (which equates to approx 3.7 million Australian adults) said 'Yes', they have taken or used a prescription drug that was not prescribed for them.
 - Compared with other age groups, those in the 30-39 age group were more likely to have taken or used a prescription drug that was not prescribed for them (31% 'Yes')
 - Of the 5 largest capital cities, respondents from Perth were most likely to have taken or used a prescription drug that was not prescribed for them (32% 'Yes')
- Overall, 78% of respondents (which equates to approx 12.8 million Australian adults) said they had never taken or used a prescription drug that was not prescribed to them.
- Less than 1% of respondents refused to answer this question.

- Overall, 21% of respondents (which equates to approx 3.5 million Australian adults) said they had used an illegal drug in the last 5 years and 12% had used an illegal drug in the last year (approx 2 million Australian adults).
- The most common illegal drug used was marijuana, with 19% of respondents admitting to using marijuana in the last 5 years and 10% using it in the last year.

- Males were more likely than females to have used illegal drugs in the last 5 years (Males 26%, Females 16%) and the last year (Males 16%, Females 8%).
- 21% of respondents in the 30-39 age group had used illegal drugs in the last year, while only 2% of the 55+ age group had used.
- Respondents from the SA/NT region were most likely to have used illegal drugs in the last year, with 19% saying they had used an illegal drug that recently. In the VIC/Tas region, 9% said they had used.
- 10% of respondents with children at home had used an illegal drug in the last year.


- Of those who had tried or used illegal drugs ('Yes' to Q2) and/or taken prescription drugs not prescribed to them ('Yes' to Q3):







The large majority of respondents (91%) agree that some illegal drugs cause more harm than others






Q9. The following questions are about *decriminalising* illegal drug use in Australia.

If illegal drug use was decriminalised:



- a. Do you think our society would be worse off?
- 49% of respondents think our society <u>would be worse off</u> if illegal drug use was decriminalised.
- 38% of respondents think our society <u>would not</u> be worse off if illegal drug use was decriminalised.
- 13% said 'don't know'.




















Unweighted Respondent Profile

Appendix 2: National Drug Strategy Household Survey

The National Drug Strategy Household Survey is commissioned by the Australian Government Department of Health and Ageing and has been conducted approximately every 3 years since 1985.

The most recent survey for which results are available was conducted in 2007. It was managed by the Australian Institute of Health and Welfare supported by a Technical Advisory Group. Two methods of data collection were used: Drop and Collect and Computer Assisted Telephone Interviewing (CATI).

The drop and collect method was administered by Roy Morgan Research. Using this method, data was collected from a national random selection of households, using self-completion booklets. A total of 19,818 responses were collected using this method, from people 12 years or older.

The CATI method was administered by the Social Research Centre and data was collected from a national random selection of households. A total of 3,538 responses were collected using this method, from people 12 years or older.

Below is a brief comparison of the two surveys:
