The Impact

NILC seeks to ensure that immigrants are treated fairly in the courts and the workplace, and that they are able to provide and care for their families. A few of our accomplishments over the past decade include:

- Protecting the rights of Central American refugees to apply for asylum.
- Helping preserve prenatal care for immigrant women in California.
- Helping restore Supplemental Security Income disability benefits and food stamps for many immigrants unfairly targeted by the 1996 welfare law.
- Defending the rights of asylum-seekers to work in the U.S.
- Preventing employers from using workers' immigration status to retaliate against them for filing labor violation lawsuits.
- Protecting the right of U.S. citizen infants born to undocumented immigrant mothers to obtain health care.
- Organizing legal defense teams and supporting local efforts to defend the rights of workers detained in immigration raids.

Multiple Strategies

Policy Research & Analysis

We analyze legislative and regulatory changes that affect the lives of low-income immigrants and their families. We try to ensure that the needs and concerns of immigrants are heard by policymakers, and help immigrant advocates voice their perspectives regarding policy changes at the local, state, and federal levels.

Impact Litigation

We conduct impact litigation to challenge policies and laws that violate the rights of low-income immigrants. We work closely with other public interest lawyers and private law firms working pro bono to develop legal strategies that bolster the policy work and organizing campaigns of immigrants and their supporters.

Legal Analysis & Strategic Advice

We respond to thousands of requests each year for legal advice and assistance. These include answering questions about the impact of laws and policies affecting immigrants, reviewing research and educational materials for technical accuracy, and helping think through organizing and advocacy campaign strategies.

Training & Education

We educate thousands of advocates across the country each year through trainings and conference presentations. Every two years, we convene the National Low-Income Immigrants' Rights Conference. Our highly regarded trainings not only inform advocates about laws and policies affecting immigrants, they also create important opportunities for participants to meet each other and to strategize.

Publications & Resources

Trusted as sources of accurate information on the latest legal and policy developments affecting low-income immigrants, our advocacy guides, fact sheets, analyses, and community education materials are regularly used by advocates, policymakers, the media, and others. Coalition-Building

We have helped assemble several important coalitions to address complex welfare implementation issues, identify responses to policy and service gaps, and fight the exploitation of low-wage immigrant workers. We form strategic alliances with other national, state, and local immigrant rights advocates to develop joint policy agendas, advocacy strategies, and organizing campaigns.
