**Tenor Soloists:** Due to the changes made at the 2010 AGM, all amateur level tenor drummers are requested to review the new tenor requirements to evaluate your correct grade. Any previous Grade 1 or 2 tenor drummer may register in any grade without special permission of the Executive Committee for 2011 only.

**Your solo competition dues are \$25.00 and \$10.00 for each additional membership in the same family, residing at the same address. To avoid the \$10.00 late fee per member, please remit your dues online or to the WUSPBA Treasurer prior to Tuesday, January 15, 2011 at:**
