Initial proposals summary

Who we are and what we do

The Boundary Commission for England is an independent and impartial non-departmental public body which is responsible for reviewing Parliamentary constituency boundaries in England.

2013 Review

We have the task of periodically reviewing the boundaries of all the Parliamentary constituencies in England. We are currently conducting a review on the basis of new rules laid down by Parliament. These rules involve a significant reduction in the number of constituencies in England (from 533 to 502), and require that every constituency – apart from two specified exceptions – must have an electorate that is no smaller than 72,810 and no larger than 80,473 (please refer to *A guide to the 2013 Review* for details of how this has been calculated).

Initial proposals

We have now completed the first stage of the review process and have published our initial proposals for the new Parliamentary constituency boundaries in England. Information about the proposed constituencies is now available on our website or in hard copy at a local ‘place of deposit’ near you.

What is changing in the South West?

The South West region has been allocated 53 constituencies – a reduction of two from the current arrangement.

Our proposals leave 14 of the 55 existing constituencies unchanged.

As it has not always been possible to allocate whole numbers of constituencies to individual counties, we have grouped some local

authority areas into sub-regions. The number of constituencies allocated to each sub-region is determined by the electorate of the combined local authorities.

In North Somerset, the existing two constituencies are unchanged.

Additionally, we propose no change to the boundaries of the two existing constituencies in the Borough of Swindon.

In the City of Bristol, two of the four existing constituencies are unaltered, while the remaining two are changed only by the transfer of one ward. In the County of Gloucestershire, two of the six existing constituencies are unaltered, two are changed only by a small ward boundary change, while two are changed only by the transfer of one ward.

More substantial change is required, however, in other parts of the region in order to comply with the new rules.

We have proposed one constituency that contains electors from both Cornwall and Devon, which crosses the boundary in the north of the two counties combining the towns of Bude and Bideford.

Another proposed constituency contains electors from both Dorset and Wiltshire, which combines the towns of Shaftesbury and Warminster.

Additionally, we propose that electors from the north east of the County of Somerset are combined with some electors from Bath and North East Somerset in one constituency, while other electors from Bath and North East Somerset are combined with electors from South Gloucestershire.

How to have your say

We are consulting on our initial proposals for a 12-week period, from 13 September 2011 to 5 December 2011. We encourage everyone to use this opportunity to contribute to the design of the new constituencies – the more public views we hear, the more informed our decisions will be when analysing all the views we receive.

We ask everyone wishing to contribute to the design of the new constituencies to first read the *Initial proposals* report and accompanying maps before responding to us.

In particular, we would like to know:

- if you agree in full, in part or not at all with our initial proposals for the South West region;
- which sub-regions you agree with and why;
- which sub-regions you disagree with and why; and

- if you can propose alternatives for areas you disagree with that meet the statutory rules we set out in our report.

1. What is the Boundary Commission for England?

1. The Boundary Commission for England (BCE) is an independent and impartial non-departmental public body, which is required by Parliament to review Parliamentary constituency boundaries in England. We conduct a review of all the constituencies in England every five years. Our role is to make recommendations to Parliament for new constituency boundaries.

2. The Chair of the Commission is the Speaker of the House of Commons, but by convention he or she does not participate in the formulation of the Commission's recommendations, nor in the conduct of the review. The Deputy Chair, Mr Justice Sales, and two further Commissioners take decisions on recommendations for new constituency boundaries. Further information about the Commissioners can be found in the 'About us' section of our website.¹

2. Background to the 2013 Review

4. In February 2011, the UK Parliament passed legislation² stating that all four Boundary Commissions covering the UK (there are separate Commissions for Scotland, Wales, and Northern Ireland) must conduct a review of Parliamentary constituency boundaries, and make recommendations to the Government, by October 2013. The four Commissions work separately, and this report covers only the work of the BCE and, in particular, introduces our initial proposals for the South West region.

5. Parliamentary constituency boundaries are important, as they define the area that a Member of Parliament will represent once elected to Parliament. The next General Election is expected to be in 2015 (as, at the time of writing and subject to legislation, the Government intends to introduce ‘fixed-term’ Parliaments – i.e. that last for five years). Therefore any recommendations we make, if accepted, are likely to be used for the first time at the General Election in 2015.

6. The legislation we work to states that there will be 600 Parliamentary constituencies covering the UK – a reduction of 50 from the current number. For England, that means that the number of constituencies must reduce from 533 to 502. There are also new rules that the Commission has to adhere to when conducting the Review – a full set of rules can be found in the BCE’s *A guide to the 2013 Review*,³ published in the summer of 2011, but they are also summarised later in this chapter. Most significantly, the rules state that every constituency we recommend (with the exception of two covering the Isle of Wight) must contain between 72,810 and 80,473 electors.

7. This is a significant change to the old rules under which Parliamentary boundary reviews took place, where achieving as close as possible to the average number of electors in each constituency was an aim but not an overriding legal necessity. For example, in England, constituencies currently range in electorate size from 55,077 to 110,924. Achieving a more even distribution of electors in every constituency across England, together with the reduction in the total number of constituencies, means that a significant amount of change to the existing map of constituencies is inevitable.

8. *A guide to the 2013 Review* contains further detailed background, and explains all the policies and procedures that we are following in conducting the Review, in greater depth than in this consultation document. We encourage anyone wishing to be involved in the Review to read this document to enable greater understanding of the rules and constraints placed on the Commission, especially if they are intending to comment on our initial proposals.

The rules in the legislation

9. The rules contained in the legislation state that every constituency in England (except two covering the Isle of Wight) must have an electorate of between 72,810 and 80,473 – that is 5% either side of the **electoral quota of 76,641**. The legislation also states that when deciding on boundaries, the Commission may also take into account:

- a. special geographical considerations, including the size, shape and accessibility of a constituency;

- b. local government boundaries as they existed on 6 May 2010;
- c. boundaries of existing constituencies; and
- d. any local ties that would be broken by changes in constituencies.

10. It is essential to understand that none of the factors mentioned in the list above overrides the necessity to achieve an electorate in each constituency that is within the range allowed, as explained previously. In particular, it should be noted that we are obliged to take into account local government boundaries as they existed in May 2010. Our initial proposals for the region and the accompanying maps are based on the wards as they existed in May 2010. *A guide to the 2013 Review* outlines further our policy on how, and to what extent, we take into account local government boundaries. We propose to use the local government districts and wards as at May 2010 as the basic building blocks for construction of constituencies.

11. We have also taken into account the boundaries of existing constituencies so far as we can. We have tried to retain existing constituencies as part of our initial proposals where possible, so long as the other factors can also be satisfied. As mentioned earlier in this chapter, because of the scale of change required to fulfil the obligations imposed on us by the new rules, this has proved difficult. Our initial proposals retain 25% of the existing constituencies in the South West region – the remainder are new constituencies (although in a number of cases we have been able to limit the changes to existing constituencies, making only minor changes as necessary to enable us to comply with the new rules).

The use of the regions used for European elections

12. Our proposals are based on the nine regions used for European elections. This report relates to the South West region. There are eight other separate reports containing our initial proposals for the other regions. In early 2011, following a consultation exercise on the issues, we decided to use these regions as a basis for working out our initial proposals. You can find more details in *A guide to the 2013 Review* and on our website. While this approach does not prevent anyone from making proposals to us that cross regional boundaries (for example, between the South West region and the South East region), in light of the reasons we have set out for the region-based approach and the level of support for this approach expressed in response to our consultation, we would need to have compelling reasons provided to us in order to persuade us to depart from the region-based approach.

Timetable for the 2013 Review

Stage one – initial proposals

13. In March 2011 we published breakdowns of the electorate for each ward, local authority area, and existing constituency, which were prepared using electorate data provided by local authorities and the Office for National Statistics. These breakdowns are available on our website.⁴ The Commission spent a number of months considering the factors outlined above and drawing up our initial proposals. We published our initial proposals for consultation for each of England's nine regions on 13 September 2011.

Stage two – consultation on initial proposals

14. We are consulting on our initial proposals for 12 weeks, until 5 December 2011. Chapter 4 outlines how you can contribute during the consultation period. We are also hosting four public hearings in the South West, at which people can give their views (see chapter 4). Once the consultation has closed, the Commission will collate all the responses received, including transcripts of the public hearings.

Stage three – consultation on representations received

15. The legislation requires us to publish all the representations we receive on our initial proposals. This publication will mark the start of a four-week period, likely to be in spring 2012, during which anyone can make further written representations with respect to the representations we have received and published. Once we have all the representations from both consultation periods, the Commission will analyse those representations and decide whether changes should be made to the initial proposals.

Stage four – publication of revised proposals

16. If we decide that the evidence presented to us is such that it is appropriate to change our initial proposals, then we must (under the legislation) publish our revised proposals for the areas concerned, and consult on them for a further period of eight weeks. This is likely to be towards the end of 2012. During that consultation period, there is no provision for further public hearings, nor is there a repeat of the four-week period for commenting on the representations of others.

Stage five – final recommendations

17. Finally, following the consultation on revised proposals, we will consider all the evidence received at this stage, and throughout the Review, before making final recommendations to the Government. The legislation states we must do this by 1 October 2013. Further details about what the Government and Parliament must do to implement our recommendations are contained in *A guide to the 2013 Review*.

18. At the launch of each stage of consultation we will be taking all reasonable steps to publicise our proposals so that as many people as possible are aware of the consultation, and can take the opportunity to contribute to our review of constituencies.

3. Initial proposals for the South West region

19. The South West region comprises the counties of Devon, Dorset, Somerset, and Gloucestershire (which are covered by a mix of district and county councils, and unitary authorities), and the unitary authorities of Bristol, Bath and North East Somerset, Cornwall, the Isles of Scilly, North Somerset, South Gloucestershire, Swindon, and Wiltshire.

20. The region currently has 55 constituencies. Of these, only 23 constituencies have electorates within 5% of the electoral quota. The electorates of 26 constituencies fall below the 5% limit, while the electorates of six fall above the upper limit. As discussed in chapter 2, following our consultation on using the regions as the basis for our initial proposals, we have taken an initial decision that the South West region is to be allocated 53 constituencies, a reduction of two.

21. In seeking to produce initial proposals for the region in which 53 whole constituencies, each with an electorate within 5% of the electoral quota, could be proposed, we first considered whether, and how, the local authority areas could usefully be grouped into sub-regions. We were mindful of seeking to respect, where we could, the external boundaries of local authorities. Our approach when grouping local authority areas together in sub-regions was based on trying to respect county boundaries wherever possible and on achieving (where we could) obvious practical groupings such as those dictated in some part by the geography of the area.

22. Our division of the South West region into sub-regions is a purely practical approach. Respondents to our consultation are welcome to make counter-proposals based on other groupings of counties and unitary authorities, if the statutory factors can be better reflected in those counter-proposals.

23. If considered alone, the electorate of the County of Cornwall (including the electorate of the Isles of Scilly), at nearly 420,000, would result in the allocation of just under 5.5 constituencies to the county. It is not possible to develop a proposal in which either five or six whole constituencies, each with electorates within 5% of the electoral quota, are contained within the county boundary. The electorate of the County of Devon (including the electorates of the unitary authorities within it), at nearly 875,000, would indicate an allocation of 11.4 constituencies. While it would be possible to develop proposals in which 11 whole constituencies are contained within the Devon county boundary, doing so would make it particularly difficult to respect local ties and to avoid the division of wards. We therefore included the counties of Cornwall and Devon (and the unitary authorities within them) in one sub-region, to which we have allocated 17 constituencies. Consequently, our proposals include one constituency that crosses the boundary between these two counties.

24. We also found that neither the electorate of the County of Dorset (including the electorates of the unitary authorities within it) nor of the County of Wiltshire (including the electorate of the Borough of Swindon) were such that we could develop proposals in which a whole number of constituencies with electorates within 5% of the electoral quota were contained within the respective county boundaries. By combining the areas in one sub-region (with a total electorate of just over 1 million) to which we allocated 14 constituencies, it was possible to develop initial proposals in which the boundary between these two counties is crossed once.

25. The electorate of the unitary authority of the City of Bristol, at just over 300,000, allowed us to develop a proposal in which four constituencies are contained within the city boundary. Similarly, the electorate

of the unitary authority of North Somerset, at just over 150,000, allowed us to propose two constituencies wholly contained within the district boundary, while the electorate of the County of Gloucestershire, at just over 460,000, allows the allocation of six whole constituencies within the county boundary.

26. The electorates of the remaining county (Somerset) and unitary authorities (South Gloucestershire, and Bath and North East Somerset), however, are such that it is not possible to develop a proposal in which a whole number of constituencies with electorates within 5% of the electoral quota can be allocated to each. Having identified the sub-regions described previously, it was necessary to group these authorities in one sub-region (the electorate of which totals nearly 750,000), to which we allocated ten constituencies. One of these crosses the county boundary between Somerset and Bath and North East Somerset, and another crosses the boundary between Bath and North East Somerset and South Gloucestershire.

27. The use of the term 'ward' throughout this document should be taken to mean electoral division in reference to the county unitary authorities of Cornwall and Wiltshire.

Initial proposals for the Cornwall and Devon sub-region

28. This sub-region comprises the County of Devon and the unitary authorities of Cornwall, Isles of Scilly, Plymouth, and Torbay. There are currently 18 constituencies in this sub-region, only six of which (St Austell and Newquay, Exeter, North Devon, Tiverton and Honiton, Torbay, and Torridge and West Devon) have electorates within 5% of the electoral quota. The remaining 12 constituencies have electorates below 5% of the electoral quota.

29. Our initial proposals allocate 17 constituencies to this sub-region, a reduction of one from the current arrangement.

30. A key consideration when developing proposals in this sub-region was identifying the most appropriate point at which to propose the necessary cross-county constituency between Cornwall and Devon. Details of our reasoning and a description of the proposed constituency are discussed later in this chapter.

31. We considered whether we could leave unchanged any of the six existing constituencies that have electorates within 5% of the electoral quota. However, in order to develop initial proposals in which all the constituency electorates were within 5% of the electoral quota, and to facilitate the reduction in allocated constituencies by one, it was necessary to alter the boundaries of two of the existing constituencies – St Austell and Newquay, and Torridge and West Devon. Our initial proposals leave the existing constituencies of Exeter, North Devon, Tiverton and Honiton, and Torbay unchanged.

32. Due to the small electorate of the existing St Ives constituency, we propose that it extends along the coast to incorporate the entirety of St Ives Bay and the town of Hayle, with which there are close geographic and communication links. Our proposed constituency boundary also reflects local government ward boundary alterations in the area in 2009, ensuring that the constituency and ward boundaries are coterminous.

33. Similarly, due to the small electorate of the existing Camborne and Redruth constituency, exacerbated by the inclusion of Hayle in St Ives, we propose that it is extended along the south coast to incorporate the towns of Falmouth and Penryn. Consequently, our proposed name for the constituency is Falmouth and Camborne.

34. We noted that, in general, the communication links within the County of Cornwall follow the east-west direction of the coastlines, and we propose that this is reflected in the shape of the remaining constituencies.

35. We therefore propose a constituency that stretches along the north coast of the county from Port Isaac to Portreath, to incorporate the towns of Newquay and Padstow, and extends inland to incorporate the towns of Wadebridge and Bodmin and the surrounding moor, with which there are strong communication links. Our proposed name for the constituency is Bodmin and Newquay.

36. To the south, we propose a constituency that stretches along the south coast incorporating the towns of St Austell and Truro, which are connected by the A390 that crosses the constituency. Our proposed name for this constituency is Truro and St Austell.

37. We propose that the boundary of the existing constituency of South East Cornwall remains largely unaltered, but for a necessary amendment to increase the electorate, specifically the inclusion of the towns of Downgate and Fowey, and for minor changes to take account of local government ward boundary changes in the area. Additionally, we propose that the constituency be renamed Liskeard, to reflect the main town in the area.

38. As discussed, it is not possible to propose a whole number of constituencies with electorates within 5% of the electoral quota within the County of Cornwall. We therefore propose a constituency which contains electors from both Cornwall and Devon. In proposing this constituency, we consider that the most suitable point at which to cross the boundary is the north of both counties, rather than traversing the River Tamar between Plymouth and Saltash, at which

point the river, although bridged, presents a far more significant boundary between the two counties. Additionally, we sought to ensure the inclusion of as equal a number of electors as possible from each county in the constituency. The constituency stretches along the north coast from Port Isaac Bay to Bideford Bar and is composed of some wards (comprising 35,272 electors) that are currently included in the North Cornwall constituency and some (comprising 39,413 electors) that are included in the existing Torridge and West Devon constituency. The A39 provides a strong communication link along the north coast of the constituency, linking the towns of Bideford in Devon with Bude and Camelford in Cornwall. Our proposed name for this constituency is Bideford and Bude, which we believe gives recognition to the main towns on each side of the county boundary.

39. In Devon, our proposals do not alter the boundaries of the existing constituencies of Exeter, North Devon, Tiverton and Honiton, and Torbay. Additionally, a number of our proposed constituencies, particularly in the east of the county, are largely similar to the existing constituencies apart from the necessary transfer of a small number of wards to ensure that electorates fall within 5% of the electoral quota. Relatively significant alterations are required, however, in the west of the county as a consequence of the proposed cross-county constituency.

40. In Plymouth the small electorates of both constituencies require a reconfiguration of the wards within the city. All but one of the wards that are currently included in the Plymouth, Moor View constituency are combined with the Devonport and Stoke areas of the city in our proposed Plymouth Devonport constituency. Other than the Moor View and Plympton areas in the north of the city, the remaining City of Plymouth wards are combined in our proposed Plymouth Sutton constituency. Additionally,

this constituency extends beyond Plymstock and towards the River Yealm to incorporate the South Hams district ward of Wembury and Brixton, which is connected to the City of Plymouth via established geographic and communications links.

41. The four remaining City of Plymouth wards, specifically the suburb of Moor View and the town of Plympton, are combined with the area surrounding the towns of Tavistock (currently located in the Torridge and West Devon constituency) and Okehampton (currently located in the Central Devon constituency) in our proposed Tavistock and Plympton constituency. The A386 runs north-south throughout the constituency, connecting the towns of Okehampton and Tavistock with the outskirts of Plymouth. Additionally, the A30 runs east-west, connecting areas in the north of the constituency.

42. We consider that the use of commas in existing constituency names is currently inconsistent and does not aid clarity. We have therefore taken a policy decision that commas will no longer be included in the names of constituencies and this is reflected in our proposed constituency names within the City of Plymouth.

43. To compensate in part for the inclusion of Okehampton in the Tavistock and Plympton constituency, our proposed Central Devon constituency expands north to incorporate six Torridge district wards currently located in the Torridge and West Devon constituency, and south to incorporate the Teignbridge district ward of Kenton with Starcross. Additionally, in order to increase the electorate of the East Devon constituency, the East Devon district ward of Exe Valley is transferred from Central Devon. Consequently we are able to respect the district boundary between East Devon and Mid Devon at this point, and the East Devon constituency is otherwise unchanged.

44. The boundary of Newton Abbot remains largely the same as that of the existing constituency apart from amendments to allow for the inclusion of the Kenton with Starcross ward elsewhere (see discussion of Central Devon above) and to increase the electorate through the expansion south to incorporate the towns of Marlton and Blagdon, which are currently located in the Totnes constituency.

45. As the existing Totnes constituency has the smallest electorate of any in the county, we propose that all but two (see discussion of Newton Abbot above) of the wards currently contained within it are included with the town of Ivybridge and surrounding area in our proposed Totnes and Ivybridge constituency.

Initial proposals for the Dorset and Wiltshire sub-region

46. There are currently 15 constituencies in the sub-region comprising the County of Dorset and the unitary authorities of Bournemouth, Poole, Swindon, and Wiltshire. Eight of these constituencies have electorates within 5% of the electoral quota; the electorates of the remaining seven constituencies fall below the 5% limit.

47. Our initial proposals allocate 14 constituencies to the sub-region, a reduction of one from the current arrangement.

48. We considered whether we could leave unchanged any of the eight constituencies which have electorates within 5% of the electoral quota. However, in order to develop proposals in which all the constituency electorates are within 5% of the electoral quota, and to facilitate the reduction in allocated constituencies by one, it was necessary to alter the boundaries of four, leaving unchanged the existing constituencies of North Swindon, South Swindon, South Dorset, and West Dorset.

49. As mentioned above, within Dorset we propose no change to the existing constituencies of West Dorset and South Dorset.

50. The electorates of the unitary authorities of Poole and Bournemouth are such that it is not possible to allocate a whole number of constituencies to either – nor would the combined electorate enable us to allocate a whole number of constituencies if we were to consider them together. As the existing electorates of both Poole and Bournemouth West are too small, it is necessary to propose a reconfiguration of the wards within the unitary authorities with the consequence that amendments are also made to Bournemouth East, despite its electorate falling within 5% of the electoral quota.

51. Our proposed Poole constituency is similar to the existing constituency but extends north to incorporate Broadstone. Additionally, the wards of Branksome West and Newtown are transferred to our proposed Bournemouth West constituency, both to increase the electorate and in order that the town of Branksome is not divided between two constituencies. Change to the existing boundary between the constituencies of Bournemouth West and Bournemouth East is minimal, with the latter extending westwards to incorporate the ward of Winton East, to compensate for the electors who have been transferred to the former constituency.

52. In order to increase the electorate of the existing Christchurch constituency, we propose its expansion. Due to the electoral and geographical size of the wards in the area, we propose that it stretches northwards to incorporate Verwood and Alderholt, with which there are established communication links, rather than westwards to incorporate the area surrounding Stapehill and West Parley as at present.

53. We propose that the area surrounding Stapehill and West Parley is instead included in a constituency which combines the area surrounding the towns of Wareham, Bere Regis, and Wimborne Minster, currently located in the Mid Dorset and North Poole constituency, with the area surrounding Blandford Forum, currently located in the North Dorset constituency. Our proposed name for the resulting constituency is Blandford and Wimborne.

54. The remaining wards that are currently contained in the constituency of North Dorset, specifically the town of Shaftesbury and the surrounding area, are combined with the Wiltshire towns of Warminster and Westbury in a constituency that we propose is named Warminster and Shaftesbury. We consider that this is the most appropriate point at which to propose a cross-county constituency, due to the strong established communication links between these two towns and the surrounding area, specifically the north-south transit route of the A350.

55. As discussed previously, the boundaries of the existing constituencies of North Swindon and South Swindon are unaltered, though we propose, for consistency, that they be renamed Swindon North and Swindon South respectively. Our approach to renaming existing constituencies is described in *A guide to the 2013 Review*.

56. Due to the small electorate of the existing North Wiltshire constituency, we propose some change to the boundary. We propose that it extends south to incorporate the relatively large number of electors within Chippenham, rather than including the town of Calne as at present. Consequently, we propose that the constituency be named Chippenham.

57. We propose that the towns of Melksham and Bradford-on-Avon, which are currently located in the Chippenham constituency, are included in our proposed Trowbridge constituency with the town of Trowbridge. There are strong geographic and communication links between the three towns.

58. As the electorate of the existing Devizes constituency is too small, it is necessary to extend the boundary to incorporate the town of Calne and the surrounding area, which is in close proximity to the town of Devizes. It is proposed that the area surrounding Durrington, currently located in the Devizes constituency, is instead transferred to the Salisbury constituency in order to increase its electorate. Additionally, our proposed Salisbury constituency extends west to include the town of Tisbury. These communities are linked to the centre of Salisbury by the various transport links that extend from the city.

Initial proposals for the Gloucestershire sub-region

59. There are currently six constituencies in this sub-region, which comprises the County of Gloucestershire. Four of these (Cheltenham, The Cotswolds, Stroud, and Tewkesbury) have electorates within 5% of the electoral quota. When developing the initial proposals, we were able to leave unchanged the boundaries of two of these constituencies – Cheltenham and Tewkesbury – while the Stroud and The Cotswolds constituencies differ only to take account of a very small ward boundary alteration between them.

60. We propose minimal change to the remaining two constituencies, to ensure that the electorates of both fall within 5% of the electoral quota. At present, the electorate of the Forest of Dean constituency falls below the lower 5% limit, while that of the Gloucester constituency is above the upper 5% limit.

61. We therefore propose that the Forest of Dean constituency should be extended across the River Severn to incorporate the Gloucester city ward of Westgate. Due to the national boundary with Wales that forms the western boundary of the existing Forest of Dean constituency, and the River Severn which forms much of the eastern boundary, we are limited as to what amendments we can propose in order to increase the electorate. While we recognise the geographical coherence of the existing Forest of Dean constituency, we consider that the inclusion of Westgate represents the only viable option to achieve an electorate within the 5% limit, without proposing a scenario in which wards are divided between two constituencies. The inclusion of the Westgate ward in the Forest of Dean constituency reduces the electorate of the Gloucester constituency such that it is not necessary to propose any further change.

Initial proposals for the City of Bristol sub-region

62. There are currently four constituencies within this sub-region, which covers the unitary authority of the City of Bristol. Two of these have electorates within 5% of the electoral quota (Bristol South and Bristol North West). When developing the initial proposals, we were able to leave the boundaries of these two constituencies unchanged.

63. We propose minimal change to the remaining two constituencies, to ensure that the electorates of both fall within 5% of the electoral quota. At present, the electorate of Bristol East constituency falls below the lower 5% limit, while that of Bristol West is above the upper limit. We therefore propose that the boundary between the two constituencies is amended and that Bristol East extends to include the Easton ward that is currently located in the Bristol West constituency. We do not propose any further change.

Initial proposals for the North Somerset sub-region

64. There are currently two constituencies within this sub-region, which covers the unitary authority of North Somerset – North Somerset and Weston-Super-Mare – both of which have electorates within 5% of the electoral quota. We do not consider it necessary to propose any change.

Initial proposals for the Somerset, Bath and North East Somerset, and South Gloucestershire sub-region

65. There are currently ten constituencies in the sub-region comprising the County of Somerset and the unitary authorities of Bath and North East Somerset, and South Gloucestershire, one of which (Wells) has an electorate within 5% of the electoral quota. Five of the existing constituencies (all of which are located in either Bath and North East Somerset or South Gloucestershire) have electorates that fall below the lower 5% limit, while four (all of which are located in Somerset) have electorates that are above the upper 5% limit. We do not propose to alter the allocation of ten constituencies for this sub-region.

66. We considered whether we could leave the one constituency with an electorate within 5% of the electoral quota unchanged. However, this did not prove possible, as we found it was necessary to propose amendments to all existing constituencies in order to equalise the electorates throughout the sub-region and to ensure that each constituency had an electorate within 5%.

67. As discussed above, the electorate of each of the three local authority areas is such that it is not possible to propose a whole number of constituencies within any of the three. Additionally, the geography of the area and the regional boundary to the east limit

our options for proposals if we are to avoid crossing the boundaries with neighbouring sub-regions, the consequence of which would be our being able to retain fewer of the existing constituencies.

68. It is therefore necessary to propose some significant alterations within the sub-region, the result of which is that: two constituencies are wholly contained within South Gloucestershire; one crosses the boundary between South Gloucestershire, and Bath and North East Somerset; one constituency is wholly contained in Bath and North East Somerset; one crosses the boundary between Bath and North East Somerset, and Somerset; and five are wholly contained within Somerset.

69. We considered that the most appropriate point at which to cross the boundary between South Gloucestershire, and Bath and North East Somerset was between Kingswood and Keynsham, due to the proximity of the towns and the established communication links between the two. Our proposed name for the resulting constituency is Kingswood and Keynsham.

70. Elsewhere in South Gloucestershire, the towns of Filton and Bradley Stoke, currently located in the Filton and Bradley Stoke constituency, are combined with the town of Thornbury and the surrounding area, currently located in the Thornbury and Yate constituency, in our proposed constituency of Thornbury and Filton. The town of Yate is instead combined with the area surrounding Mangotsfield, with which it has close communication links, in our proposed Yate constituency.

71. Within Bath and North East Somerset, it is necessary to increase the electorate of the existing constituency of Bath. We propose that it is expanded to include the Bathavon North and Bathavon South wards that encircle

much of the city and with which there are strong geographic and communication links.

72. The remaining Bath and North East Somerset wards, specifically the towns of Midsomer Norton and Paulton and the surrounding area, are combined with the towns from the Somerset District of Mendip, specifically Frome and Shepton Mallet, both of which are connected to the communities in the north of the constituency by established communication links. We propose that the resulting constituency is named North East Somerset.

73. Elsewhere in Somerset, the large electorate of the existing Taunton Deane constituency requires the transfer of some wards elsewhere. In order to avoid breaching the district boundary between Taunton Deane and South Somerset, we propose that three wards currently located in the Taunton Deane constituency are instead included in our proposed Bridgwater and West Somerset constituency. Additionally, as the constituency no longer contains all the Taunton Deane borough wards, we propose that it is renamed Taunton, to reflect the major centre of population.

74. Due to the large electorate of the existing Bridgwater and West Somerset constituency, exacerbated by the inclusion of the three Taunton Deane district wards which include Wiveliscombe, Milverton, and Bishop's Lydeard, we propose that it no longer extends to incorporate the Huntspill Level and the area surrounding Woolavington and North Petherton.

75. Instead, this area is combined with wards from Wells and the surrounding area in our proposed Wells constituency, which also differs from the existing constituency in that it no longer contains the town of Glastonbury and the surrounding area.

76. We propose that, due to the large electorate of the existing constituency of Yeovil, the towns of Ilminster and South Petherton are instead included in our proposed Glastonbury and Wincanton constituency. This constituency also contains the towns of Glastonbury and Street and the surrounding area, and a number of wards that are currently located in the Somerton and Frome constituency. Our proposed Yeovil constituency is otherwise unchanged.

4. How to have your say

77. We are consulting on our initial proposals for a 12-week period, from 13 September 2011 to 5 December 2011. We encourage everyone to use this opportunity to contribute to the design of the new constituencies – the more public views we hear, the more informed our decisions will be when analysing all the views we receive.

78. In particular, we ask people to bear in mind the tight constraints placed on the Commission by the rules set by Parliament, as well as the decisions we have taken regarding adoption of a regional approach and use of local government wards discussed in chapter 2 and in the BCE's *A guide to the 2013 Review*. Most importantly:

- a. We cannot recommend constituencies that have electorates that are more or less than 5% from the electoral quota (apart from the two covering the Isle of Wight).
- b. We are basing our initial proposals on local government ward boundaries (as at May 2010) as the building blocks of constituencies. Our view is that, in the absence of exceptional and compelling circumstances, it would not be appropriate to divide wards in cases where it is possible to construct constituencies that meet the 5% statutory requirement without doing so.
- c. We have constructed constituencies within regions, so as not to cross regional boundaries. Compelling reasons would need to be given to persuade us that we should depart from this approach.

79. These issues mean that we encourage people who are making a representation on a specific area to bear in mind the knock-on effects of their proposals. The Commission must look at the recommendations for new constituencies across the whole region (and, indeed, across England). We therefore

ask everyone wishing to respond to our consultation to bear in mind the impact of their counter-proposals on neighbouring constituencies, and on those further afield across the region.

How can you give us your views?

80. There are two ways you can give us your views on our initial proposals: in writing (including by email or through the online form on our website), or in person at one of a series of public hearings we are conducting during the consultation period. People are welcome to both attend a hearing and send us a written representation.

Written representations

81. We encourage everyone to make use of our consultation website, at www.consultation.boundarycommissionforengland.independent.gov.uk, when contributing to our consultation. The website contains all the *Initial proposals* reports and maps, the electorate sizes of every ward and an online facility where you can have your say on our initial proposals.

83. We encourage everyone, before submitting a representation, to read our approach to data protection and, in

particular, the publication of all representations and personal data within them. This is available at www.consultation.boundarycommissionforengland.independent.gov.uk, or by phoning 020 7276 1102.

Public hearings

84. The Commission will be holding public hearings across all the English regions. In the South West region we will be hosting four public hearings during the consultation period. Our website (www.consultation.boundarycommissionforengland.independent.gov.uk) has more details of these hearings, and an opportunity to register to attend and speak. 85. The purpose of the hearings is for people to have an opportunity to make representations orally to an Assistant Commissioner, who will chair the hearings and subsequently provide the Commission with a report on their findings. The hearings differ from the way we used to conduct ‘public inquiries’ in past reviews – these were much more judicial in style, with people being allowed to cross-examine each other. The new legislation that Parliament has introduced specifically rules out such inquiries, specifying instead that we host public hearings. These are intended purely as a way for people to make representations orally, direct to representatives of the Commission, as well as to provide an opportunity for the Commission to explain its proposals.

86. It is important to stress that all representations, whether they have been submitted through the online facility on our website, made in person at a hearing or sent to us in writing or by email, will be given equal consideration by the Commission. Therefore it does not matter if you are unable to attend or speak at a public hearing – even after the last public hearing in the South West region has been completed on 18 November 2011, you will still have two weeks left to submit your views to us. By statute, time for the public hearings is strictly limited and you may wish to ensure that your full representations about our proposals are made to us in writing.

What do we want views on?

88. While you are welcome to write to us on any issue regarding our initial proposals, it would aid our understanding and analysis if you, when contributing, followed the

structured approach available on our consultation website at www.consultation.boundarycommissionforengland.independent.gov.uk. This structured approach is also outlined below and available in our separate summary leaflet (copies of which are available in places of deposit and on our website). We encourage anyone wishing to contribute to the formation of our final recommendations to follow this approach. The structured approach will also allow us more easily to identify representations on specific areas, or from specific people, during the subsequent four-week period of consultation (referred to in chapter 2).

89. We would particularly like to ask two things of those considering responding to our consultation. First, if you support our proposals, please tell us so, as well as telling us where you object to them. Past experience suggests that too often people who are happy with our proposals do not respond in support, while those who object to them do respond to make their points. That can give a rather distorted view of the balance of public support or objection to proposals, and those who support our initial proposals may then be disappointed if they are subsequently revised in light of the consultation responses. Second, if you are considering objecting to our proposals, do please use the resources (maps and electorate figures) available on our website and at the places of deposit to put forward counter-proposals that are in accordance with the rules to which we are working.

90. Specifically, while anyone is welcome to submit views in whatever format, we are looking for views structured around the following questions:

- a. Do you agree in full, in part or not at all with our initial proposals for the South West region?
 - b. Which sub-regions do you agree with and why?
 - c. Which sub-regions do you disagree with and why?
 - d. What are your alternatives for areas you disagree with that meet the statutory rules set out in chapter 2?
91. Above all, however, we encourage everyone to have their say on our initial proposals and, in doing so, to become involved in drawing the map of new Parliamentary constituencies. The more views we get on our initial proposals, the more informed our consideration in developing those proposals will be, and the better we will be able to reflect the public's views in the final recommendations we present in 2013.

Glossary

Assistant Commissioner	Independent person appointed at the request of the BCE to assist it with the discharge of its functions.
Borough constituency abbreviated to BC	Parliamentary constituency containing a predominantly urban area.
County constituency abbreviated to CC	Parliamentary constituency containing more than a small rural element.
Designation	Classification as either a borough constituency or as a county constituency.
Electorate	The number of registered Parliamentary electors in a given area.
(Statutory) Electorate range	The statutory rule that requires the electorate of every constituency (as at the review date) to be within 5% of the UK electoral quota.
Final recommendations	The recommendations submitted in a formal final report to the Government at the end of a review. They may – or may not – have been revised since the initial proposals in any given area.
General review	Major review of all Parliamentary constituencies in England at the same time. From 2011 all Parliamentary constituency reviews are general reviews.
Initial proposals	First formal proposals published by the BCE during the review for public consultation.
Public hearing	Formal opportunity in a given area for people to make oral representations, chaired by an Assistant Commissioner. In each region of England there may be no fewer than two and no more than five hearings, and each may last a maximum of two days.
Representations	The views provided by an individual, group or organisation to the BCE on its initial or revised proposals, either for or against, including counter-proposals and petitions.
Review date	Proposals must be based on the numbers of electors on the electoral registers on this date, which is defined in the Act as the date two years and ten months before the final report is to be submitted (i.e. 1 December 2010 for the review that is to conclude with a final report by 1 October 2013).
Revised proposals	The initial proposals as subsequently revised.
UK electoral quota	The average number of electors in a constituency, found by dividing the total electorate of the UK (less that of the four specific ‘protected’ constituencies) by 596.
Unitary authority	An area where there is only one tier of local council (above any parish or town council). This contrasts with those ‘shire district’ areas that have two tiers (i.e. both a non-metropolitan county council and a district/borough/city council).
