# **Biography**

Born 9 November 1955, Sale, Vic.

Educated at St Patrick's College, Sale where he was Year 12 Dux and School Captain. He holds BA, LLB degrees from the University of Melbourne and an LLM from Monash University.

From 1979-85 he was research solicitor and then judge's associate to Sir James Gobbo, and from 1985-1991 worked as a barrister specialising in health law and bioethics. In 1991 he was elected MHR for Menzies and has since held the ministerial portfolios of Ageing and (since 2003) Workplace Relations and Employment.

In his spare time he and his wife, Margaret, conduct marriage education seminars. (Michelle Grattan 'A quiet man's revolution', Melbourne Age, 13 Nov. 2004)

## Of note

- Co-founder and Secretary, Lyons Forum, a now-defunct 'club' for Coalition right-wingers. (Grattan op cit.; Niki Savva 'The God squad', Age, 2 Apr. 1997)
- Seconded a motion by Paul Filing, MHR (Moore, WA), seeking to end all Australian trials of the RU-486 'abortion pill'. (*Right to Life News*, Sept. 1994, 2)
- Sponsored 1996 private member's bill overturning Northern Territory's euthanasia legislation. In one interview, Andrews controversially claimed that '[w]ith the advancement of pain relief, there was no need to fear an agonising death'.

- **'... the AFA is Australia's leading family advocacy group.'** Created by the late B.A. Santamaria's National Civic Council, the AFA is very active in the fight for the traditional heterosexual family to the exclusion of all other family models. Leading lobbyists against recognition of same-sex relationships and adoption rights, and in favour of extensive film and television censorship.

**'Endeavour Forum was set up to counter feminism, defend the unborn and the traditional family.'** Agitates against the rights of single mothers, any availability of abortion, and favours homosexual behaviour being deemed 'a manifestation of a psychiatric disorder'.

#### Family Council of Victoria (FCV)

**'...support for the institution of the family.'** Far right political lobby group, fights for men's status as the head of the 'natural' family. Seeks to equate homosexuality with rapists, child abusers, paedophiles. Believes that: 'For years now the public school system has been force-feeding our children a steady diet of pro-homosexual propaganda'. Family Councils exist in several states.
