Subject: Peer-review of the Draft Voluntary Guidelines for the Consideration of Biodiversity in Environmental Impact Assessments (EIAs) and Strategic Environmental Assessments (SEAs) in Marine and Coastal Areas

Dear Madam/Sir,

In decision X/29, the Conference of the Parties to the Convention on Biological Diversity requested the Executive Secretary to facilitate the development of voluntary guidelines for the consideration of biodiversity in environmental impact assessments (EIAs) and strategic environmental assessments (SEAs) in marine and coastal areas using the guidance in annexes II, III and IV to the Manila workshop report (UNEP/CBD/SBSTTA/14/INF/5), and provide for technical peer review of those guidelines. Upon the request by COP 10, these draft voluntary guidelines, after incorporating the comments and suggestions through technical peer review, will be submitted for consideration to the 16th meeting of the Subsidiary Body on Scientific, Technical and Technological Advice (SBSTTA), scheduled for April 2012. COP 10 also recognized that these guidelines would be most useful for activities that are currently unregulated with no process of assessing impacts.

Pursuant to above requests, the Secretariat has prepared, with the assistance of a team of consultants, draft voluntary guidelines for the consideration of biodiversity in EIAs and SEAs in marine and coastal areas using the guidance in Annexes II, III and IV to the Manila Workshop Report (UNEP/CBD/SBSTTA/14/INF/5). In preparing the draft guidelines, all the guidance and concerns raised in Annexes II, III and IV to the Manila Workshop report (UNEP/CBD/SBSTTA/14/INF/5) were considered and addressed.
