## INTRODUCTION

1. This report has been prepared pursuant to decision III/24 of the Conference of the Parties, which requested the Executive Secretary to prepare a quarterly report on the administration of the Convention including such matters as the staff list, status of contributions, progress on the implementation of the medium term work programme and financial expenditure report. The requirements to report on a regular basis to the Parties were further elaborated under the Administrative Arrangements between the Secretariat and UNEP, which were endorsed by the Conference of the Parties in decision IV/17.
2. The Executive Secretary has therefore, prepared the 44<sup>th</sup> edition of the Quarterly Report which contains a summary of key activities in implementing the decisions of the Conference of the Parties and other relevant matters during the period 1 January to 31 March 2009.

### I. OFFICE OF THE EXECUTIVE SECRETARY

#### MEETINGS

3. The Secretariat organized the following meetings:

##### **Group of Technical and Legal Experts on ABS – Tokyo, Japan**

4. The Conference of the Parties, in its decision IX/12, paragraph 11, decided, inter alia, to establish a group of technical and legal experts to further examine the issue of compliance in order to assist the Ad Hoc Open-ended Working Group on Access and Benefit-sharing in the elaboration and negotiation of the international regime on access and benefit-sharing. Following the kind invitation of the Government of Japan, the meeting of the group of legal and technical experts was held on 27-30 January 2009 in Tokyo, Japan.

5. The Expert Group examined the issues set out in its terms of reference, in accordance with decision IX/12, annex II, IA, paragraph 1. These included measures available or that could be developed in public and private international law in order to ensure compliance with national access and benefit-sharing legislation as well as mutually agreed terms regarding access and benefit-sharing; voluntary measures to enhance the compliance of users; how an internationally agreed definition of misappropriation and misuse could support compliance; how compliance measures could take account of customary law; and, whether particular compliance measures are need for research with non-commercial intent.

##### **Global Partnership on Cities and Biodiversity**

6. Following Decision IX/28 on Cities and Local Authorities, the Secretariat has been facilitating and guiding the activities of the Global Partnership on Cities and Biodiversity on the road to Nagoya. During the first quarter of the year, the Secretariat held one expert workshop in collaboration with the Government of Singapore on 10-12 February and two meetings via teleconference with the members of the Partnership to report on their activities. The first teleconference was held on 14 January, with 18 participants from 9 institutions. The group discussed a number of issues including: update on the preparations of the First Technical Expert Workshop on the Singapore Index on Cities' Biodiversity (CBI); update on the preparation of the Global Partnership on Cities and Biodiversity meeting to take place in Curitiba; discussions on how to involve other national, regional and international partners, and 2010 activities to be organized by all cities. Following the Singapore workshop (final report accessible at: <http://www.cbd.int/doc/meetings/city/ewdcbi-01/official/ewdcbi-01-03-en.doc>), the group held its second meeting via teleconference on 16 March, with the participation

of 21 representatives of member institutions. The partnership is currently working on follow up activities on the CBI, a publication on cities' best practices and case studies, its participation at ICLEI's World Congress in Edmonton in June and events leading up to Shanghai World Expo 2010, amongst others. A representative from Natural England-UK provided important inputs on the UK's experience in encouraging its local authorities to contribute to the implementation of the CBD at the local level. The Partnership plans to involve other Parties in preparations for the Nagoya Biodiversity City Summit in 2010.

### **First Meeting of the Friends of the Co-Chairs on Liability and Redress under the Cartagena Protocol on Biosafety – Mexico City, Mexico**

7. On 23-27 February, the First Meeting of the Friends of the Co-Chairs on Liability and Redress under the Cartagena Protocol on Biosafety was convened at the Ministry of Foreign Affairs in Mexico City, Mexico to further negotiate international rules and procedures on liability and redress for damage resulting from transboundary movements of living modified organisms (LMOs) in the context of the Protocol, based on the proposed operational texts on liability and redress, contained in the Annex to decision BSIV/12 on Liability and Redress. The participants produced a draft text for a supplementary protocol on liability and redress to the Biosafety Protocol, which will serve as basis for further consideration at the second meeting of the Group of Friends of the Co-Chairs, scheduled to be held in early 2010 in Kuala Lumpur, Malaysia.

### **Business and Biodiversity meeting via teleconference**

8. On 4 February, the Secretariat hosted a meeting via teleconference with the Steering Committee for the Business and the 2010 Biodiversity Challenge meeting, to be held in Asia in November 2009. Sixteen members representing government, NGOs, and the private sector took part in the meeting to decide on a venue and discuss potential agenda items. It was decided that the meeting should be held in Jakarta, Indonesia. While many agenda topics were suggested, all agreed that the meeting should be broken down by sector so as to facilitate exchange of experiences and identify the way forward for increased integration of biodiversity considerations in each sector. The Steering Committee will meet again in April to finalise the meeting agenda and identify potential speakers.

### **Third meeting of the COP Bureau – Nairobi, Kenya**

9. The third meeting of the COP-9 Bureau was held on 13 February 2009 at the United Nations Office in Nairobi, Kenya, back to back with the 25th session of the Governing Council / Global Ministerial Environment Forum (GC/GMEF) of the United Nations Environment Programme (UNEP). Issues discussed included: the revision of the Strategic Plan of the Convention, the preparations for the Eminent Persons Workshop in March 2009, the preparations for COP-10 meeting, among other issues. A briefing on developments in relation to the implementation of the Bonn Mandate on access and benefit-sharing was made by the two ABS Co-Chairs. The CBD Executive Secretariat provided an update on the status of availability of financial resources for the implementation of COP-9 decisions and meetings.

10. The COP Bureau meeting was preceded by an ABS Workshop organised for the Bureau members. Some members of the COP Bureau, as well as staff from the CBD Secretariat, also participated in the technical meeting of the United Nations Environment Management Group held on 14-15 February 2009 in Nairobi, Kenya.

#### **Fourth meeting of the COP Bureau – Paris, France**

11. The COP 9 Bureau held its fourth meeting on 30 March in Paris, France, prior to the informal regional consultations with the two ABS Co-Chairs as well as the seventh meeting the Ad hoc Open-ended Working on Access and Benefit-Sharing (WGABS-7). The Bureau members discussed the organization of work for the WGABS-7 meeting, as well as key message of the Bureau members to the regional groups. Other items discussed at the meeting include: availability of financial resources for the implementation of COP-9 decisions, outcome of the high-level meeting on the 2010 biodiversity target and post-2010 targets, preparations for the COPMOP5 and COP10 meetings, and the UNGA high-level meeting on biodiversity in 2010, among other issues.

12. **The Secretariat also organized the following meetings:** Online Conference on Capacity-building for Integration of Biosafety into National Development Plans (19 January – 6 February 2009); First Regional Real-time Online Conferences on Risk Assessment and Risk Management under the Cartagena Protocol on Biosafety: Europe (28 January 2009); Capacity Development Workshop for the Pacific on NBSAPs, the Mainstreaming of Biodiversity and the Integration of Climate Change (2-6 February, Nadi, Fiji); First Regional Real-time Online Conferences on Risk Assessment and Risk Management under the Cartagena Protocol on Biosafety: Latin America (3 February); Capacity-building workshop for the Pacific region for implementation of the Programme of Work on Protected Areas (9-12 February, Nadi, Fiji); First Regional Real-time Online Conferences on Risk Assessment and Risk Management under the Cartagena Protocol on Biosafety: Africa (10 February); Expert Workshop on the Development of the City Biodiversity Index (10-12 February, Singapore City, Singapore); Online Discussion Forum on Article 10 (c) (11 February-11 March 2009); First Regional Real-time Online Conferences on Risk Assessment and Risk Management under the Cartagena Protocol on Biosafety: Asia (17 February); Fifth Coordination Meeting for Governments and Organizations Implementing or Funding Biosafety Capacity-building Activities (9-11 March, San Jose, Costa Rica); Capacity Development Workshop for Central Asia on NBSAPs and the Mainstreaming of Biodiversity (9-13 March, Ramsar, Iran); and the sixth meeting of the Liaison Group on Capacity-building for Biosafety (12-13 March, San Jose, Costa Rica).

#### **REPRESENTATION**

13. Between January and March 2009, the Secretariat engaged and contributed to a number of important meetings of relevance to the work of the Convention and its Cartagena Protocol on Biosafety. Details can be seen in Annex I to this report.

#### **MEMORANDA OF COOPERATION/UNDERSTANDING**

##### **Secretariat of the Pacific Regional Environment Programme**

14. The Secretariat of the Pacific Regional Environment Programme (SPREP) signed a revised Memorandum of Understanding with the Secretariat of the Convention on Biological Diversity (SCBD) on 16 February. The objective of agreement is to further enhance collaboration between the two institutions, as per the agreed SCBD/SPREP work plan contained in Annex 1 of the agreement.

#### **MEETINGS OF THE EXECUTIVE SECRETARY**

15. In the first quarter of 2009, the Executive Secretary met with a number of senior representatives from Parties, other Governments, organizations and institutions, to further enhance and strengthen collaboration as well as increase public awareness of the Convention on Biological Diversity and its Cartagena Protocol on Biosafety.

16. During the reporting period, the Executive Secretary welcomed the visit of the Director of the United Nations Forum on Forests, as well as the two ABS Co-Chairs. Senior Government representatives also paid a visit to the Secretariat, including: the Director of Biodiversity and Policy Division at the Ministry of Environment of Japan, the New Zealand High Commissioner to Canada, senior staff from BMZ-Germany, the new Ambassador of Austria to Canada, senior representatives from the *Québec Ministère de la Culture, des communications et de la condition féminine*, delegation from the United Kingdom and delegation from Ecuador. The Executive Secretary also welcomed the visit of senior officials from the Embassy of *Cote d'Ivoire* in Ottawa, together with the Canada Research Chair for Ethnoecology and Biodiversity Conservation/*Université de Montréal*, to discuss preparations for the International Congress on Biological and Cultural Diversity to be held in 2010 and the Secretariat's involvement in the meeting. Representatives from Environment Canada, Parks Canada, IUCN-WCPA, and TNC also visited the Secretariat to discuss PoWPA developments including post 2010.

17. The following also visited the Secretariat: staff from Airbus to discuss The Green Wave initiative, Head of the Public Awareness Unit at Bioersivity International, senior representatives from The Nature Conservancy, a staff member from the Scientific and Technical Advisory Panel of the Global Environment Facility, Executive Secretary of the Consortium for the Barcode of Life, the Executive Director of the Global Mountain Biodiversity Assessment/University of Basel, representatives of the Census of Marine Life, students from the *Collège Édouard Montpetit* in Montréal, the President of Agriculture & Biotechnology Strategies Inc., staff from the Mountain Forum Secretariat, the head of Hart Resources, and representatives from the Canadian Museum of Nature and *Muséums Nature de Montréal*.

18. In February, the CBD Executive Secretary participated in the 25th session of the United Nations Environment Programme Governing Council/Global Ministerial Environment Forum (GC-25/GMEF), held in Nairobi, Kenya from 16-20 February. In the margins of the GC-25/GMEF meeting, meetings were held with: UNEP Executive Director, UNEP Deputy Executive Director, relevant staff of the Poverty and Environment Initiative in UNEP, Associate Director and Head of UNITAR's Environment Unit, as well as with a number of Environment Ministers. The Executive Secretary also took part in a number of side events in the margins of the GC-25/GMEF, including: "The Green Customs Initiative: Capacity Building for Environmental Security" organized by the Czech Republic; the Ministerial-level roundtable on "Global crisis: national chaos?" - Towards a "green economy"; and the Ministerial-level roundtable on "International Environmental Governance (IEG) - Help or Hindrance?" - IEG from a country perspective. The Executive Secretary also attended a briefing made by the ABS Co-Chairs to the staff of UNEP-DELDC and UNEP Regional Directors on the status and process of the regional ABS consultations. A meeting was also held between the three Executive Secretaries of the Rio Conventions and the EU Presidency. A decision on the International Year of Biodiversity was adopted at the GC-25/GMEF.

19. Prior to the GC-25/GMEF meeting, at the invitation of the UNEP Executive Director and South Africa's Deputy Minister for Environmental Affairs and Tourism, the Executive Secretary attended the High-level Gender and Environment Forum held on 15 February.

## II. IMPLEMENTATION OF THE ADMINISTRATIVE ARRANGEMENTS

### a. Personnel Arrangements

20. During the period January – March 2009, there were 29 Professional staff members regularized on posts approved under the Convention. There was one vacant post. Additionally, 5 professional staff members are regularized on posts funded from other sources.

21. Under the Convention there were 21 General Service staff members regularized on posts funded by the core budget, and 2 vacant posts for which recruitment is in progress. Additionally, 11 staff members are regularized on posts funded from other sources.
22. During the period under review for the Biosafety Protocol there were 7 Professional staff members regularized on posts approved by the COP/MOP. There were 3 General Service staff members regularized on posts funded by the core budget and one vacant post under recruitment.
23. For more information, please refer to the attached staff list and organigram (Annex II Appendix 1, and Annex III respectively).

#### **b. Financial Arrangements**

24. With regard to budgetary matters, as at 31 March 2009, of the total pledged contributions of US\$10,505,772 for 2009 to the General Trust Fund for the Convention on Biological Diversity (BY Trust Fund), the total contributions received amounted to US\$5,986,158 of which \$2,045,707 were 2009 pledges paid in 2008, and \$3,940,451 were pledges paid in 2009 for 2009 and future years. Details of the BY Trust Fund are contained in Annex VI.
25. Several Parties have contributed additional voluntary funds in support of approved activities under the Convention (BE Trust Fund). As of 31 March 2009, the total pledged for 2009 amounts to US\$1,283,299 of which \$738,046 has been received. Total unpaid pledges for 2009 and prior years to the BE Trust Fund is US\$967,305. Details of the BE Trust Fund are contained in Annex IV.
26. As at 31 March 2009, US\$191,816 has been pledged in 2009 as additional voluntary contributions to facilitate the participation of Parties to the Convention Process (BZ Trust Fund). To date, US\$127,877 has been received. Total unpaid pledges for 2009 and prior years, to the BZ Trust Fund, amount to US\$218,710. Details of the BZ Trust Fund are contained in Annex V.
27. As at 31 March 2009, of the total pledged contributions of US\$1,959,177 for 2009 to the General Trust Fund for the Core Programme Budget for the Biosafety Protocol (BG Trust Fund), total contributions received is US\$1,105,304, of which US\$831,158 was received in advance of 2009 and US\$274,146 has been received in 2009 for 2009 and future years. Details of the BG Trust Fund are contained in Annex VII.
28. As at 31 March 2009, no Parties have pledged and/or contributed to the Special Voluntary Trust Fund for Additional Voluntary Contributions in support of Approved Activities of the Cartagena Protocol on Biosafety, (BH Trust Fund). Total unpaid pledges for prior years, to the BH Trust Fund, amounts to US\$186,636. Details of the BH Trust Fund are contained in Annex VIII.
29. As at 31 March 2009, no Parties have pledged and/or contributed to the Special Voluntary Trust Fund for Facilitating Participation of Developing Country Parties in the Cartagena Protocol on Biosafety, (BI Trust Fund). Total unpaid pledges for prior years, to the BI Trust Fund, amounts to US\$52,343. Details of the BI Trust Fund are contained in Annex IX.
30. As at 31 March 2009 no pledges have been received for the General Trust Fund for Voluntary Contributions to Facilitate the Participation of Indigenous and Local Communities in the Work of the Convention on Biological Diversity (VB Trust Fund) in 2009. Details of the VB Trust Fund are contained in Annex X.



### III. IMPLEMENTATION OF THE DECISIONS OF THE CONFERENCE OF THE PARTIES

#### **VII/12 and VIII/10: Sustainable Use of Biodiversity**

31. In response to decisions VII/12 and VIII/10, the Secretariat carried out the following activities:
- a. Issued notification 2009-22, inviting CBD National Focal Points and relevant organizations to submit information on the implementation of relevant decisions of the COP on sustainable use, as well as on the application of the Addis Ababa Principles and Guidelines, including progress made, challenges, obstacles and capacity-building needs. Relevant organizations were also invited to provide overall information on the status and trends of sustainable use of biological diversity.
  - b. Attended the “Satoyama Initiative International Workshop” convened by the Ministry of the Environment of Japan, held on 6 March 2009 in Tokyo. The Satoyama Initiative is intended to develop and propose a model of sustainable management of natural resources. More information on the workshop can be found at: <http://www.env.go.jp/en/headline/headline.php?serial=1000>.

#### **VII/4, VIII/20 and IX/19: Biological Diversity of Inland Waters**

32. In response to decisions VII/4, VIII/20 and IX/19, the Secretariat carried out the following activities:
- a. Finalised its comments on, and inputs to, all chapters of the Third World Water Development Report (WWDR3);
  - b. In collaboration with UNEP, prepared a supplementary report to the WWDR3 on “Water Security and Ecosystem Services - The critical connection” to enhance awareness of the need to consider water-related issues, and integrated water resources management, from the perspective of managing the multiple ecosystem services that water provides or underpins;
  - c. In collaboration with UNEP, developed a briefing note for the UNEP Governing Council on water, environment and sustainable development linkages;
  - d. Commenced the drafting of background information in preparation for the in-depth review to be undertaken at SBSTTA-14, including summarising the outcomes of the WWDR3, undertaking a review of activities of relevant partners and an analysis of the third national reports; and
  - e. A member of the Secretariat attended (i) an expert meeting on water and ecosystem services organised by UNEP and held at UNEP-WCMC, 09-11 January, (ii) the Third World Water Forum held in Istanbul, Turkey, 16-22 March, and (iii) the fifteenth meeting of the Scientific and Technical Review Panel of the Ramsar Convention, Gland, Switzerland, from 28 March to 03 April.

### **VII/9 VII/31 and IX/3: Global Strategy for Plant Conservation**

33. In response to decisions VII/31 VII/9 and IX/3, the Secretariat:
- a. Completed editing and layout of the English version of the Plant Conservation Report and made it available at <http://www.cbd.int/doc/publications/plant-conservation-report-en.pdf>;
  - b. Initiated the in-house translation of the Plant Conservation Report into French and Spanish;
  - c. Prepared and posted an online survey of the Global Strategy for Plant Conservation in view of its updating beyond 2010;
  - d. Issued notification 2009-023, informing CBD, SBSTTA and GSPC focal points as well as relevant organizations of the Liaison Group Meeting of the Global Strategy for Plant Conservation, jointly organized by the CBD and the Global Partnership for Plant Conservation, from 26 to 28 May 2009 in Dublin, Republic of Ireland, and inviting them to submit nominations.

### **VII/27: Mountain Biological Diversity**

34. In response to decision VII/27, the Secretariat carried out the following activities:
- a. Requested Parties, relevant organizations, experts and other related Conventions for inputs for preparing the in-depth review of the implementation of the programme of work on mountain biological diversity by SBSTTA-14 and COP-10;
  - b. Held discussions with the Mountain Research Initiative, the International Centre for Integrated Mountain Development, the Carpathian and the Alpine Conventions on the *modus operandi* of preparing for the in-depth review;
  - c. The Executive Secretary of the Global Mountain Biodiversity Assessment, Coordinator, Mountain Partnership and the Executive Secretary of the Mountain Forum visited Montreal to discuss further collaboration in implementing the programme of work on mountain biological diversity and preparations for the in -depth review.

### **VII/28, VIII/24 and IX/18: Protected Areas**

35. In response to requests in decisions VII/28, VIII/24 and IX/18, the Secretariat carried out the following activities:

- a. Prepared and organized the Pacific Islands sub regional workshop on capacity-building for the implementation of the programme of work on protected areas under the Convention on Biological Diversity, held from 9 to 12 February 2009 in Nadi, Fiji, jointly with the Secretariat of the Pacific Regional Environment Programme (SPREP), the Government of Fiji and PoWPA FRIENDS. The workshop was attended by government-nominated experts from Cook Islands, Federated States of Micronesia, Fiji, Kiribati, Marshall Islands, Nauru, Niue, Palau, Samoa, Solomon Islands, Tonga, Tuvalu, and Vanuatu. - b. Initiated action for recruiting the Coordinator (L-4) and Web Manger (L-2) under the Life Web initiative, including screening of applicants and interviewing of shortlisted candidates;
- c. Organized the kick-off meeting on the LifeWeb and Protected Areas web portals to bring together the team members to share a common view of the project and to discuss the implementation strategy;
- d. Held discussions with TNC, WWF, Equilibrium research regarding development of a user-friendly and comprehensive website on protected areas and the development of streamlined reporting process of on the implementation of the programme of work on protected areas (PoWPA)
- e. Interacted with Governments of Australia, Belgium, and Canada, as well as the German Federal Agency for Nature Conservation, soliciting financial assistance for the organization of regional capacity-building and review workshops on the implementation of PoWPA;
- f. Held discussions with Environment Canada, Parks Canada, and IUCN-WCPA on preparations and next steps for the in -depth review of the Programme of work on protected areas by SBSTTA 14 and COP 10;
- g. Interacted with the Government of India in view of the organization of an Asian regional workshop on protected areas in 2009 and prepared a draft host country agreement;
- h. Received an informal offer from the Minister of the Environment of the Government of Cote d'Ivoire to host a regional workshop on protected areas in Abidjan
- i. Coordinating preparation of two sub-chapters of Chapter 8 on protected areas chapter of the TEEB D1 report.

#### **VIII/1 and IX/21: Island biodiversity**

36. In response to decisions IX/21 and VIII/1, the Secretariat carried out the following activities:
- a. Contributed to the implementation of the Global Islands Database (GID), a project of the Global Islands Partnership (GLISPA), by participating in an online demonstration and exchange led by UNEP-WCMC. The GID project is supported by the Government of Italy, and will be an important tool for island decision-makers in regional and national planning, and particularly for creating ecological corridors and regional networks of protected areas.
  - b. Enhanced cooperation with the Secretariat of the Pacific Regional Environment Programme by signing an MOU, as defined in paragraph 7 of decision IX/21. The objective of the MOU is to collaborate closely on issues of common interest relating to the three objectives of the convention. Joint activities listed in the MOU include active involvement in GLISPA activities and on issues related to invasive alien species. Furthermore, the secretariats jointly organized the following workshops:
    - i. Sub-regional workshop on National Biodiversity Strategies and Action Plans and biodiversity mainstreaming for the Pacific;

- ii. Capacity building workshop for integrating climate change in implementation of the CBD in small island development states;
  - iii. Indigenous communities, tourism and biodiversity workshop series.
- c. Collaborated with partners from relevant organizations to update the Global Island Partnership (GLISPA) web page and posted GLISPA communication materials on the web page.

#### **VIII/19 and IX/5: Forest Biodiversity**

37. In response to decisions IX/5 and VIII/19 the Secretariat:

- a. Is participating in the Global Environment Facility (GEF) Technical Advisory Group (TAG) to develop the strategic framework on sustainable forest management for the next GEF replenishment period;
- b. Participated in the World Forest Week/19<sup>th</sup> Session of the FAO Committee on Forestry, and organized a sub-plenary event on Ecosystem-based Adaptation, as well as several side events;
- c. Issued the third volume of the e-Newsletter on efforts to reduce emissions from deforestation and forest degradation (REDD & Biodiversity e-Newsletter);
- d. Issued a notification to all members of the Collaborative Partnership on Forests regarding three regional/thematic workshops on forest biodiversity planned in 2009, and invited their participation and other contributions;
- e. Secured funding from the Centre for International Forestry Research (CIFOR) for the printing of Technical Series nr 33 “The Conservation and Sustainable Use of Wildlife-based Resources – The Bushmeat Crisis” in Spanish;
- f. Collaborated with UN REDD Programme partners and the Group of International Observers to the Forest Carbon Partnership Facility on the preparation of pilot and demonstration activities, in particular with a view to the rights and knowledge of Indigenous Peoples;
- g. Provided peer-review to the IUFRO-led Science and Technology Initiative on Forests and Climate Adaptation;
- h. Welcomed the Director of the UN Forum on Forests Secretariat, Ms Jan McAlpine, at the Secretariat for a one-day visit to discuss options for closer collaboration.

#### **VIII/23, IX/1 and IX/2: Agricultural Biological Diversity and Biofuels and Biodiversity**

38. In response to decision IX/1, the Secretariat has:

- a. Finalised the draft joint work plan on biodiversity for food and agriculture with the FAO Commission on Genetic Resources for Food and Agriculture in collaboration with the FAO; and

- b. Attended a meeting of the expert group on soil biodiversity of the Joint Research Centre of the European Commission held in Ispra, Italy, 02 - 03 March; subjects discussed included prioritising research needs and the production of a book on soil biodiversity in Europe for which the Secretariat will prepare a chapter on the CBD and the international initiative on soil biodiversity;

39. In response to decision IX/2, the Secretariat:

- a. Liaised with a number of partners, including the Food and Agriculture Organization of the United Nations, in view of preparations for regional workshops on ways and means to promote the positive and minimize the negative impacts of the production and use of biofuels on biodiversity;
- b. Is liaising with Brazil and Thailand to explore the possibility of convening regional workshops on biofuels for the Latin America and Caribbean region and Asia and the Pacific region respectively
- c. Posted additional information on biofuels and biodiversity, including references to the submissions received, on the CBD website.

#### **IX/4: Invasive Alien Species**

40. In response to decision IX/4, the Secretariat:

- a. Completed the in house translation of French version of the brochure for the International Day for Biological Diversity in 2009 which will focus on invasive alien species;
- b. Updated the web site for International Day for Biological Diversity 2009 at <http://www.cbd.int/idb/2009>
- c. Prepared a report to the fourth session of the Commission on Phytosanitary Measures of the International Plant Protection Convention, which will be held from 30 March to 3 April 2009.
- d. Invasive alien species liaison group was established to exchange information and facilitate the communication among the secretariats of following organisations: the International Plant Protection Convention, the World Organisation for Animal Health, , Committee on Fisheries in FAO, World Trade Organisation Sanitary and Phytosanitary Measures, Convention on International Trade in Endangered Species of Wild Fauna and Flora, International Maritime Organisation, International Civil Aviation Organisation, Global Invasive Species Programme and The Invasive Species Specialist Group in the Species Survival Commission of The World Conservation Union;

#### **IX/7: Ecosystem Approach**

41. In response to decision IX/7 paragraph 5 the Secretariat:

- a. Prepared and disseminated the March 2009 issue of the Ecosystem Approach e-Newsletter, which is being issued on a quarterly basis, to CBD national focal points, SBSTTA focal points, and other relevant organizations and experts. For the publication

of the March issue, the Secretariat collaborated with experts from Governments, UNEP, UNDOALOS, and IUCN.

#### **IX/9: Process for the revision of the Strategic Plan**

42. In response to decision IX/9, the Secretariat:
- a. Extended the deadline for the submission of views on the updating and revision of the Strategic Plan of the Convention, solicited through notification 2008-151, until 31 March 2009 and sent reminders to many organisations in various sectors of relevance to biodiversity inviting them to participate in the e-forum;
  - b. Assisted in the preparation and organization of the Environment Management Group Technical Meeting held on 14 February 2009 in UNEP Headquarters, Nairobi, which led to the establishment of an Issue Management Group (IMG) on the 2010 and post-2010 biodiversity targets, which will meet on 8 April 2009 at UNESCO in Paris;
  - c. Participated in the meeting on “Sustainability beyond 2010” on the post 2010 target, organized by UNEP on 15 February 2009 in Nairobi;
  - d. Participated in the High-level working group on the 2010 target and post-2010 target(s) organized by the German COP Presidency from 9 to 10 March 2009 in Bonn;
  - e. Responded to requests and briefed visiting delegations (including Japan, New Zealand, United Kingdom) regarding the process and current status of the revision of the Strategic Plan;
  - f. Liaised with various partners, including UNEP and IUCN, to discuss the possibility of jointly organizing regional workshops on the revision of the Strategic Plan;
  - g. Initiated the preparation of a draft discussion paper containing a synthesis/analysis of issues relevant to the revision and updating of the Strategic Plan, to be made available in April 2009.

#### **IX/10: Preparation of the Third Edition of the Global Biodiversity Outlook**

43. In response to decision IX/10 the Secretariat:
- a. Continued with the drafting and internal review of sections of third edition of the Global Biodiversity Outlook 3 (GBO-3);
  - b. Continued with the collection of case studies and examples of activities aimed at reducing the rate of biodiversity loss;
  - c. Has begun to analyse the fourth National Reports that have been received to date (Cameroon, Cuba, Estonia, Kyrgyzstan and Niger);
  - d. Co-organized or participated in a number of events related to the updating of the Strategic Plan with implications for GBO-3 (see under decision IX/9);

- e. Maintained linkages with activities related to the updating of the Global Strategy for Plan Conservation (see under decision IX/3);
- f. Continued, in collaboration with a range of partners, to develop the strategy for International Year of Biodiversity (see under decisions IX/32 and IX/33);
- g. Continued to update the web pages on GBO-3;
- h. Contracted a consortium of experts led by DIVERSITAS-International and UNEP-WCMC to conduct an assessment on future biodiversity conditions;
- i. Invited the members of the 2010 Biodiversity Indicators Partnership to provide up-to-date scientific information on the 2010 indicators by 31 March 2009 so that it can be incorporated into the draft of GBO-3;
- j. Is pursuing the possibility of contracting a group of professional science writers to transform the draft of GBO-3 into a widely accessible format. A similar arrangement is being explored regarding the preparation of the graphics;
- k. Issued notification 2009-031, inviting CBD National Focal Points and SBSTTA Focal Points, other governments, relevant organizations, and indigenous and local communities to submit views on the scientific and technical aspects of the provisional framework of global headline indicators for assessing progress towards the achievement of the 2010 Biodiversity Target by participating in the online survey accessible at [http://www.surveymonkey.com/s.aspx?sm=J3TWJYEIRjot6G8UIZctkQ\\_3d\\_3d](http://www.surveymonkey.com/s.aspx?sm=J3TWJYEIRjot6G8UIZctkQ_3d_3d;);
- l. Participated in a Conservation Commons meeting on *inter alia* the analysis and visualization of the Global Biodiversity Information Facility's (GBIF) records relevant to GBO-3;
- m. Had discussions with representations of the Census of Marine Life (CoML) on the possibility of using CoML maps in GBO-3;
- n. Had discussions with representatives of the Mountain Forum Secretariat and the Mountain Partnership on GBO-3;
- o. Held a teleconference with a representative of Peace Child on the possibility of having them prepare a youth version of GBO-3;
- p. Held a teleconference with a representative the UNDP/GEF Small Grants Programme regarding case studies for possible use in GBO-3;
- q. Discussed with a representative of the Economics of Ecosystems and Biodiversity (TEEB) project matters related to the preparation of GBO-3, the timing of the two projects and possible opportunities for collaboration;
- r. Invited participants in the International Workshop on the Satoyama Initiative held in Japan on 6 March to consider submitting case studies on sustainable management and use of mixed landscapes as success stories for GBO-3
- s. Is exploring opportunities for collaboration with the Equator Initiative.

### **IX/15: Follow-up to the Millennium Ecosystem Assessment**

44. In response to decision IX/15 the Secretariat:
- a. Participated in a conference call organized by UNEP on 4 February 2009, which provided an update on the MA Secretariat, relevant ongoing activities of partners, and a discussion of the implications of the outcomes of the Ad hoc Intergovernmental and Multi-Stakeholder Meeting on an Intergovernmental Science-Policy Platform on Biodiversity and Ecosystems Services (IPBES) for the MA follow-up process;
  - b. Provided comments on the preliminary gap analysis for the purpose of facilitating the discussions on how to strengthen the science-policy interface (UNEP/GC.25/INF/30);
  - c. Arranged for a meeting at the margins of the seventh meeting of the Liaison Group of Biodiversity-related Conventions to discuss the preparations of the second Ad hoc Intergovernmental and Multi-Stakeholder Meeting on an IPBES.

### **IX/16: Biodiversity and Climate Change**

45. In response to decision IX/16 the following activities were carried out:
- a. A regional workshop was held on capacity building for the integration of climate change within National Biodiversity Strategy and Action Plans and implementation of the Convention in Pacific small island developing States from 2 to 6 February, 2009.
  - b. An online dialogue on the links between biodiversity, climate change adaptation and risks and vulnerabilities was held the 9 to 20 March in preparation for the second meeting of the Second Ad hoc Technical Expert Group on Biodiversity and Climate Change.
  - c. The Secretariat prepared a chapter on biodiversity and climate change for the FAO youth guide on climate change and food security.
  - d. A submission on Views on Issues relating to Indigenous Peoples and Local Communities for the Development and Application of Methodologies on reducing emissions from deforestation and forest degradation was presented to the Secretariat of the United Nations Framework Convention on Climate Change.
  - e. A submission on climate change, biodiversity and fisheries was presented to the Informal Coordination Meeting on Climate Change and Fisheries and Aquaculture convened by FAO, the World Bank and World Fish.
  - f. Participants were selected for the Second Ad hoc Technical Expert Group on Biodiversity and Climate Change which will be held the 18 to 22 April, 2009. Furthermore, the agenda and some background documents were prepared (<http://www.cbd.int/doc/?meeting=AHTEG-BDCC-02-02>).

### **IX/17: Biodiversity of Dry and Sub-humid Lands**

46. In response to decision IX/17, the following activities were carried out:



- a. A steering committee was established for the development of the Biodiversity for Development Good Practice Toolkit on Pastoralism. A draft framework and work plan was also developed for this project.
- b. A meeting was held with a knowledge management consultant on how to improve the effectiveness of the case study database on biodiversity and livelihoods in dry and sub-humid lands.
- c. A draft work plan was developed with the United Nations Convention to Combat Desertification on the implementation of the joint activities identified by COP.
- d. Outlines were prepared for three information notes to be considered by SBSTTA 15 on: the enhanced integration of climate change within the programme of work; the further elaboration of activities to support biodiversity conservation and sustainable use and the achievement of the Millennium Development Goals in dry and sub-humid lands and; the links between drought, biodiversity and climate change.

### **IX/20: Marine and Coastal Biological Diversity**

47. In response to decision IX/20, the Secretariat:

- a. Continued compiling relevant scientific information on the impacts of destructive fishing practices, unsustainable fishing, and illegal, unreported and unregulated (IUU) fishing on marine biodiversity and habitats. The Secretariat prepared, in consultation with UNEP and FAO, and posted on the CBD website Terms of References to hire a consultant. Arrangements for consultancy issuance is being finalized;
- b. Attended the first meeting of the Intersessional Technical Working Group on Ocean Fertilization (IMO Headquarter, London, UK; 9-13 February 2009) as well as the first meeting of the Intersessional Legal and Related Issues Working Group on Ocean Fertilization (IMO Headquarter, London, UK; 11-13 February 2009), providing necessary technical inputs, collecting information and collaborating with relevant organizations and partners. The Secretariat issued a consultancy contract to UNEP-WCMC to compile and synthesize relevant scientific information on potential impacts of direct human-induced ocean fertilization on marine biodiversity. The Secretariat also interacted with UNESCO-IOC providing inputs in IOC's preparation for a policy brief, "Summary for Policymakers on Ocean Fertilization";
- c. Issued a consultancy contract to UNEP-WCMC to compile and synthesize relevant scientific information on potential impacts of ocean acidification on marine biodiversity; and
- d. Established an e-forum to facilitate effective preparation for the expert workshop on scientific and technical guidance on the use of biogeographic classification systems and identification of marine areas beyond national jurisdiction in need of protection (Ottawa, Canada, 29 September – 2 October, 2009), inviting Parties, other Governments, and relevant organizations as well as relevant experts;
- e. Conducted a series of teleconference calls with various partners, such as IUCN, FAO, UNEP, UNDOALOS, International Seabed Authority, International Maritime

Organization, etc, to facilitate their contributions to and participation in the above-mentioned expert workshop;

- f. Had a meeting with the representatives of Census of Marine Life on 6 March 2009, at the Secretariat and discussed their potential contributions to: (i) the preparations for the in-depth review of the implementation of the programme of work, (ii) the above-mentioned Ottawa expert workshop, and (iii) the scientific synthesis of information on the impacts of ocean acidification.
- g. As part of a collaboration with the University of Sherbrooke, Canada, is supervising a student working on experiences with the criteria adopted by COP-9 for the identification of marine areas requiring protection.

### **IX/22: Global Taxonomy Initiative**

48. In response to decision IX/22 the Secretariat:

- a. Participated in the 25<sup>th</sup> meeting of the BioNET Fund Supervisory Board on 20 January 2009 in Egham, UK;
- b. Took part in the International Symposium for East and Southeast Asia Biodiversity Inventory Initiative held in Tokyo, Japan on 21 January 2009;
- c. Worked with experts in East and South East Asia to develop a strategic plan for East and South East Asia Biodiversity Inventory Initiative (ESABII) in Tokyo, Japan on 22 January 2009;
- d. Interacted with the Japanese government, ACEAN Center for Biodiversity and BioNET INTERNATIONAL to prepare for the ACEAN +3 Global Taxonomy Initiative Workshop to commemorate the International Day for Biological Diversity in 2009;
- e. Interacted with the Consortium for Barcode of Life, Census of Marine Life and other organisations to continue the monitoring of progress on the outcome oriented deliverables.

### **IX/27: Cooperation among Multilateral Environmental Agreements and other Organizations**

49. In accordance with the provisions of decision IX/27 the Secretariat:

- a. Liaised with the Secretariat of the Environment Management Group (EMG) in preparation of a technical meeting on the post 2010 targets of the CBD
- b. Participated in the technical meeting on the post 2010 targets of the CBD organized by the EMG (14 February 2009);
- c. Participated in the meeting organized by UNEP to brainstorm on the 2010 targets (15 February 2009);
- d. Prepared documentation for the seventh meeting of the Liaison Group of Biodiversity-related Conventions scheduled for 9 April 2009;

- e. Liaised with the EMG Secretariat in preparation of the first meeting of the Issue Management Group;
- f. Solicited views concerning the suitability of holding the seventh meeting of the Liaison Group of Biodiversity-related Conventions at the margins of the Seventh meeting of the Ad Hoc Open-ended Working Group on Access and Benefit-sharing (Paris, France, 2-7 April 2009);
- g. Participated in the Scientific Committee meeting of DIVERSITAS-International and liaised with DIVERSITAS members regarding inputs to the review of the 2010 biodiversity target and Strategic Plan of the Convention;

- j. As part of a collaboration with the University of Sherbrooke, is supervising a student working on CBD tools that could be used for capacity-building and awareness-raising in the health sector.
- k. Welcomed to the Secretariat Mr. Tsunao Watanabe, Director of the Biodiversity Policy Division of the Japanese Ministry of Environment (MOE) on 26 and 27 March 2009. The purpose of his visit was to discuss and provide updates on recent activities related to COP10 and to exchange views in order to strengthen collaboration between the MOE Japan and SCBD.

- b. Prepared a web page on emerging issues and posted the proposals received in response to the notification at <http://www.cbd.int/convention/emerging.shtml>.

### **IX/6: Incentive measures**

52. In the period under review, the Secretariat participated in a number of meetings relevant for advancing implementation of various elements of the programme of work on incentive measures.

53. The Secretariat participated in a United Nations interagency meeting, on 2-3 February 2009, in New York, USA. Organized by UNEP, the meeting convened interested UN agencies in order to review the draft of a commissioned report suggesting a Global Green New Deal. This report, which is part of UNEP's Green Economy Initiative, seeks to capitalize on the planned macroeconomic stimulus packages with a view to encourage public investments towards a greener economy. The meeting also identified the main messages to be included in a UN strategy paper based on the commissioned report.

54. The Secretariat participated in the expert workshop on a green development mechanism, from 9-10 February 2009, in Amsterdam, the Netherlands. This meeting was sponsored by the Dutch environment ministry and organized together with IFC, IUCN and UNEP, and in close cooperation with the Secretariat. The meeting reviewed the case for enhanced international funding for biodiversity conservation and sustainable use, and identified four concrete mechanisms for further consideration and analysis, as well as number of general issues which would need further consideration and analysis under any concrete instrument. The proposals will be further developed and fine-tuned, for consideration at the OECD workshop on new and innovative finance for biodiversity, which is tentatively planned to take place in July 2009.

55. The Secretariat is a member of the international advisory committee of the UNEP trade assessment project for biodiversity and, in this capacity, participated in the international review meeting of the project, from 18-20 March 2009, in Geneva, Switzerland. This 4-year project supports the preparation of integrated assessments of the impacts of trade policies on biodiversity in 6 ACP countries. The project foresees in its last phase the implementation of an integrated policy response of the findings of the assessment studies. The present meeting brought the six country teams together with the international advisory committee in order to (i) review and finalize the assessment studies, in particular the policy conclusions; (ii) develop, based on the countries' initial proposals, the integrated policy response and a project proposal for implementation of its first phase.

56. The Secretariat participated in the workshops on rewarding (unrewarded) benefits of ecosystems and biodiversity, and on perverse subsidies, organized under the second phase of "The Economics of Ecosystems and Biodiversity" Project, which took place on 11-12 February 2009 and on 23-24 March 2009, in Brussels, Belgium. The meetings convened relevant experts in the respective fields in order to identify key messages on the respective topics for the TEEB report for policy-makers, and to review the state of affairs in the preparation of the respective draft chapters of the report.

#### **IX/12: Access to genetic resources and benefit-sharing**

57. During this period, the following activities were carried out with a view to implementing COP decision IX/12:

58. The Secretariat prepared and serviced the Expert Group on Compliance, held from 27 to 30 January 2009, in Tokyo, Japan. The following activities were carried out:

- a. preparation of documentation for the meeting;
- b. coordination with host Government regarding the organization of the meeting and logistical arrangements;
- c. servicing of the meeting in Tokyo;
- d. preparation of the report of the meeting.

59. The Secretariat organized a "workshop on ABS" for the members of the COP Bureau at its meeting in Nairobi, on 13 February.

60. The Secretariat carried out preparations for the seventh meeting of the Working Group on ABS, held at UNESCO, in Paris, from 2 to 8 April 2009, including the following:

- a. Documentation for the meeting including pre-session documents and information documents in accordance with COP decision IX/12;
- b. preparation of statements, press release;
- c. logistical arrangements in collaboration with UNESCO.

61. The Secretariat participated in the briefing organized for the African Group under the auspices of the ABS Initiative for Africa, held on 31 March, prior to WG-ABS 7.

62. In accordance with paragraph 13 of decision IX/12, studies commissioned were finalized and made available as information documents for the WG-ABS 7.
63. Side-events were organized for the presentation of the studies commissioned by their respective authors during WG-ABS 7 and presentations on specific topics were also organized in accordance with decision IX/12.
64. A leaflet announcing the new web portal related to the negotiation of the international regime on ABS was prepared for the launching of the portal at WG-ABS 7.
65. A meeting of the Interagency Task Force on ABS was held on 1 April, prior to WG-ABS 7, in order to brief the Task Force regarding preparations for the WG-ABS and in order to obtain information regarding relevant developments in other forums.
66. A matrix was developed for the database on ABS measures in order to provide an overview of the main elements of ABS at national and regional levels.
67. A notification was made available to NFPs and relevant organizations regarding the nomination of experts and observers as well as the submission of information in preparation for the Expert Group on Traditional Knowledge associated with genetic resources to be held in Hyderabad, India, from 16 to 19 June 2009.

#### **IX/13: Article 8(j) and Related Provisions - VIII/14: Biological Diversity and Tourism**

##### **Indigenous Tourism and Biodiversity Web Site Award**

68. In December 2008, Planeta.com and the Secretariat of the Convention on Biological Diversity launched the Indigenous Tourism and Biodiversity Website Award, which was created in order to showcase best practices in web-based technologies helping indigenous people manage tourism in a biodiversity-friendly way. By January 2009, 15 indigenous-owned tourism businesses around the world were registered as nominees (see list on <http://planeta.wikispaces.com/itbw>) and by February 20th, the official jury and more than 200 people had voted and made their selection. The winners (see results on: <http://planeta.com>) were announced during a press conference at the Reisepavillion - International Fair for Alternative Travel in Munich, Germany.
69. The award is part of the Workshop Series on Indigenous Communities, Tourism and Biodiversity: New Information and Web-based Technologies, and contributes to Decision IX/13 E paragraph 7 on Article 8(j) and related provisions, which requests the Executive Secretary to convene, subject to the availability of financial resources, further regional and sub-regional workshops on community-friendly communication tools on traditional knowledge related to the conservation and sustainable use of biodiversity, and Decision VII/14 on Biological Diversity and Tourism, which invites, inter alia, relevant organizations to provide indigenous and local communities with capacity-building and financial resources to support their active participation in tourism policy-making, development planning, product development and management indicated by the CBD Tourism Guidelines.

#### **IX/25: South-south Cooperation on Biodiversity for Development - VIII/14: Biological Diversity and Tourism**

Reisepavillion - International Fair for Alternative Travel in Munich, Germany

70. The SCBD organized, jointly with UNEP and UNWTO a series of three roundtables on Sustainable Tourism, which took place during the Reise pavillion - International Fair for Alternative Travel in Munich, Germany (from 26 February to 2 March 2009). The first panel discussed "International initiatives on sustainable tourism", the second panel explored "Standards and certification for sustainable tourism", and the third panel, chaired by the Secretariat, presented: "Biodiversity and development – a training programme for sustainable tourism".

71. SCBD's involvement in the Munich Fair is part of the Biodiversity and Development unit's activities, and is in line with its objective to develop a Biodiversity and Development training set on CBD's thematic development areas. The first module of the training set will present a Toolkit of Good Practices' on Tourism for Development and Nature Conservation. During the Munich Fair, feedback and suggestions from 65 participants were sought primarily on training strategies and methodologies, and partnerships were outlined for testing the toolkit (UNEP/GEF project in Central and Eastern Europe, UNWTO Consulting Unit in Bonn, UNF/Rainforest Alliance project in Central America). Partnering agencies agree that the publication can be an "umbrella" reference to map available training programmes on more specific subjects – and identify gaps that need to be addressed. Efforts were also invested in incorporating the toolkit into existing projects and networks such as the Tourism Task Force of the Marrakech Initiative on Sustainable Production and Consumption (led by UNEP/DTIE and UNWTO), and the Education and Training Task Force of the Global Sustainable Tourism Criteria project funded by the UN Foundation (where the Secretariat is a member of the Steering Committee).

## OUTREACH AND MAJOR GROUPS

### **Implementation of the MOU between SCBD and UNDP on mainstreaming biodiversity in development**

72. Following COP-9, the SCBD and the United Nations Development Program (UNDP) concluded a Memorandum of Understanding (MOU) on mainstreaming biodiversity in development. This partnership is focused on capturing lessons from UNDP' and partner's work and experience in the field. The first area of focus of the MOU is integrating biodiversity and ecosystem goods and services in productive sectors. The second area is enhancing the incorporation of biodiversity and ecosystem services into national development strategies. Both aims will be attained based on evidence gathered from practice.

73. The MOU took operational shape on the first of March with the arrival at the SCBD of Linda Ghanime, on secondment from UNDP. Ms. Ghanime's one year assignment will deepen the sharing of experience between both institutions and in particular on how UNDP's on the ground work actively contributes to the Convention's implementation in developing countries. The collaboration also aims at developing a programme to further support the implementation of the Convention.

74. In this first month, a work program for implementation of the MOU was developed in consultation with SCBD programs of most direct relevance to meeting the development objectives of the CBD.

75. Exchange of ideas for collaborative activities and dialogues were launched with the UNDP UNEP PEI, the Small Grants program and the Equator Initiative.

76. Substantive input was provided to the preparation of the Expert meeting on Mainstreaming Biodiversity in Development Cooperation convened by the SCBD in May 2009.

### **IX/26: Promoting Business Engagement**

77. The Third Business and the 2010 Biodiversity Business Challenge Meeting
- The Secretariat is advancing the organisation of the third meeting on Business and the 2010 Biodiversity Challenge. A Steering Committee has been assembled with the 18 members coming from private, government, and NGO sectors. This committee has already met once to decide on venue for the meeting as well as outline a draft agenda.
  - The meeting will be held in Jakarta, Indonesia, 30 November 2009 to 2 December 2009. It will be held in partnership with UNEP's annual Business and Industry meetings and will include collaboration with IUCN.
78. The CBD Guide for Business on the Sustainable Use of Biological Diversity
- The Secretariat is preparing a Guide for Business on the Sustainable Use of Biological Diversity. The purpose of this initiative is to raise awareness of biodiversity issues within the business community as well as provide these stakeholders with information on how they can begin to address the issues.
  - A first draft of the Guide has been completed and is being revised internally.
  - Business stakeholders have been approached to provide input on the Guide once internal revisions have been completed.
  - The Secretariat is confirming partnerships with regional organisations that will be able to adapt the Guide to local business and biodiversity situations, translate it into local languages, as well as disseminate these via their web pages and networks.

### **IX/32: Programme of Work for Communication, Education and Public Awareness**

79. Integrating CEPA as a tool into the programme of work for ABS
- a. Decision IX/32 requested that the Executive Secretary to prepare and make available through the clearinghouse mechanism of the Convention, simple summaries of issues and discussions on the negotiation and elaboration of the international regime on access and benefit-sharing with the view to assist Parties in communicating the issues to relevant target groups, including decision makers, policy makers and the general public. To this end, the Secretariat created an information portal related to the Negotiations of the International Regime on ABS at <http://www.cbd.int/abs/ir> and released it to a selected audience in early March. The portal will officially be launched at the seventh meeting of the Working Group on ABS in Paris in early April.
  - b. The Secretariat also participated in a regional workshop on CEPA and ABS, organised by UNEP and the ABS Initiative for Africa from 9 to 12 March 2009. The workshop brought together communicators and ABS experts to develop communication strategies and messages for use during the negotiations as well as in support of capacity-development. The workshop was well-received by participants and by UNEP.
80. Implementation of the Priority Activities for the Programme of work on CEPA (Decision VIII/6 and IX/32)



- a. Priority Activity 3 – key messages. As part of the preparations for the IYB, the Secretariat is creating a series of fact sheets on the programmes of work of the Convention. These will be released at the end of the second quarter of 2009.
- b. Priority Activity 5 – toolkits. The CEPA toolkit, developed in partnership with the CEC of IUCN, continues to be used as part of the NBSAP process. It was disseminated to focal points of the CBD in early 2009. A Spanish translation was created by the CEC of IUCN and is to be posted on the CBD website. Thanks to resources from the government of France, a French version is under preparation and will be ready in May 2009.
- c. Priority Activity 6 – workshops. CEPA continues to be integrated into the NBSAP workshop process, through strategic communication modules and the participation of subject matter experts of the CEC of IUCN. As mentioned above, CEPA was the focus of the recent ABS workshop held in Nairobi. A regional workshop for CEPA in ASEAN states has been postponed to November, to allow it to coincide with the Business and Biodiversity Meeting being held in Jakarta.
- d. Priority Activity 8 – the International Day for Biological Diversity. Information materials for the IDB 2009 are under preparation. A booklet, a postcard, a bookmark and a poster are being prepared for printing and dispatch in the beginning of the second quarter of 2009. A webpage for the IDB 2009 under the theme of Invasive Alien Species went live in early 2009. UNEP has agreed to hold celebrations in Nairobi and in regional offices. The United Nations University will hold a seminar on IDB 2009. The Presidency of COP-9 has agreed to organise a high-level event on 22 May 2009.
- e. Priority Activity 10 – Mainstreaming Biodiversity into Education. With the support of the government of the Netherlands and the assistance of UNESCO, the CBD will participate in the mid-term conference for the Decade of Education for Sustainable Development, which began on 31 March 2009 and will continue until 2 April 2009. The Secretariat is organising a workshop on the theme of Mainstreaming Biodiversity into Education. Preparations are underway to develop a toolkit on biodiversity education. The toolkit will draw upon the experience of the Conference, as well as the expertise of UNESCO and the CEC of IUCN. The Secretariat has also been involved in the organization of the 5<sup>th</sup> World Environmental Education Congress, to take place in Montreal 11-15 May 2009. The Executive Secretary is the co-president for the event. An exhibition will be organised with UNEP.

### **IX/33: Preparations for the International Year of Biodiversity**

- a. The Implementation Plan for the IYB was revised and submitted to the Bureau and to partners for dissemination. In the wake of the recent UNGA and UNEP GC resolutions on the IYB, the Executive Secretary invited key partners to participate and coordinate their activities. To this end, letters were sent to Parties to the Convention, International Organizations, Non-governmental Organizations and other key partners. Suggested activities were also sent to Parties through an email list.
- b. Thanks to the financial support of the government of Canada, a firm was contracted to create the visual identity and branding for the IYB. The firm drew upon the results of the recent meeting of the high-level working group on the 2010 target, convened by the COP president, as well as existing research and the work of the EMG. Materials will be

disseminated to parties in the second quarter of 2009, with an official launch of the materials taking place on UN day in New York in October 2009.

- c. UNESCO has agreed to host the launch of the IYB in January 2010, including convening a scientific conference. Fundraising and joint activities are underway.
- d. The Secretariat was invited to participate, along with other UN Agencies in the common UN pavilion at the Shanghai Expo in 2010. The Secretariat will participate in the permanent and temporary exhibitions, and will co-organise events with partners. As the theme will be on cities and better living, the Secretariat will focus on its work with local partners and the role of cities in biodiversity conservation and sustainable use.

## IMPLEMENTATION AND TECHNICAL SUPPORT

### VIII/14: National reporting and the next Global Biodiversity Outlook

81. A reminder was sent to all Parties (except Estonia) in mid-January requesting them to advise on the status of the preparation of the fourth national report and to submit the report by the deadline (30 March 2009).

82. An update on the status of preparation of the fourth national report was provided to the COP 9 Bureau for its first meeting in 2009 in Nairobi. The update was based on the communication of the Secretariat with Parties in the past few months via email, phone calls, face-to-face discussions during regional and sub-regional workshops on NBSAPs and other meetings.

83. A reminder was sent to all the eligible countries that have not submitted requests for GEF funding for preparing the fourth national report. As of end of March 2009, a total of 90 eligible countries have been provided funds for their work on the 4NR, through Phases I and II of a medium-sized project. A proposal for Phase III has been prepared and submitted to the GEF Secretariat.

84. The Secretariat continues providing support to countries for preparing and finalizing the fourth national report, including through relevant regional and sub-regional workshops on NBSAPs. These include those organized for the Pacific Countries (Feb 9-13, Nadi, Fiji) and for the Central Asia (March 9-13, Ramsar, Iran). A workshop is being planned for least developed countries (4-8 May 2009, Addis Ababa, Ethiopia), which is made possible with the financial support of Norway and UNEP GEF as well as in-kind support from the Ethiopian Institute of Biodiversity Conservation, Ethiopian EPA and UNEP Addis Ababa Office.

85. Upon request, the Secretariat has helped review a number of draft fourth national reports and provided useful recommendations for their improvement.

86. As of end of March 2009 (deadline set in decision VIII/14), a total of 26 fourth national reports have been received. All the reports have been posted on the CBD website at <https://www.cbd.int/reports/search/?type=nr-04>. About 60 countries indicated that they would submit the 4NRs before the end of June 2009.

87. A communiqué has been issued by the CBD Executive Secretary, Mr. Ahmed Djoghlaif to congratulate those countries that have submitted their fourth national reports before and by the deadline, and urge all other countries to meet their reporting obligations under the Convention. In doing so, he underlined the importance of timely submission of the fourth national report for assessing the implementation of the Convention, particularly progress towards the 2010 target, as well as the processes

leading to 2010, including GBO 3. The COP 9 Bureau, while meeting ahead of ABS WG 7 (2-8 April 2008, Paris, France), also echoed the call by the Executive Secretary and urged countries in their respective regions to meet their reporting obligations in a timely manner.

88. Work on the 4NR portal is continuing, with more resource materials added and work ongoing to develop a database that allows countries to submit cases or case studies related to the 2010 target and the Strategic Plan. A new consultant has been selected to work further on the portal.

89. As requested, the Secretariat provided inputs to the trial consolidated reporting template to biodiversity-related conventions for Pacific Island Countries, which was developed by Australia together with PICs. The template was designed to increase reporting capacities of PICs and the trial use of this template has proven helpful. The Secretariat has also provided inputs to the workshop being planned by the ASEAN Centre for Biodiversity for the ASEAN member states (April 13-15, 2009, Hanoi, Vietnam).

### **VIII/8 and IX/8: National Biodiversity Strategies and Action Plans**

90. The workshop on NBSAPs, Mainstreaming and Integration of Climate Change for the Pacific region was held 3-7 February in Nadi, Fiji, with the participation from all Pacific Island Countries and Australia. The workshop was co-organized with the Secretariat of the Pacific Regional Environment Programme (SPREP) and in cooperation with the South Pacific Community and IUCN. Despite the inevitable capacity constraints with the small island developing countries, substantial progress in implementing the Convention was demonstrated. All but three countries of the sub-region have NBSAPs and the remaining ones have NBSAPs under development. Australia will soon send out its draft revised NBSAP for public consultation. Sessions were held on mainstreaming, ecosystem services, strategic environmental assessment, strategic communication, and the integration of climate change in NBSAPs, with some very practical exercises.

91. The regional capacity development workshop for Central Asia on NBSAP and Biodiversity Mainstreaming was held March 9-13 in Ramsar, Iran, in cooperation with the Ramsar Centre and the Government of the Islamic Republic of Iran. Participants were from Azerbaijan, Iran, Kazakhstan, Kyrgyzstan, Pakistan, Tajikistan, Turkmenistan and Uzbekistan. From Iran there were participants from the Ministries of Environment, Foreign Affairs and Agriculture, as well as provincial and local governments, universities and NGOs. All countries presented at the workshops have completed NBSAPs, but the extent of implementation varies. Some countries gave quantitative estimates of the state of implementation. A number of experts from Iran, Pakistan and Uzbekistan, made presentations on valuation of ecosystems, national capacity self-assessments, management plans for protected areas, the impacts of climate change, and community based sustainable use.

92. The Secretariat is continuing work to compile case studies, tools and guidance arising from the regional capacity development workshops.

### **IX/30: Scientific and Technical Cooperation and the Clearing-House Mechanism**

93. During the first quarter of 2009, activities related to the Clearing-House Mechanism (CHM) included the following website enhancements:

- a. A web portal is now available at [www.cbd.int/abs/ir](http://www.cbd.int/abs/ir) to provide information on the negotiations of the International Regime on ABS which is the main agenda item of the Seventh meeting of the Ad Hoc Open-ended Working Group on Access and Benefit Sharing (Paris, 2-8 April 2009).

- b. A web portal has been created at [www.cbd.int/idb/2009](http://www.cbd.int/idb/2009) to promote the 2009 celebrations of the International Day on Biodiversity with a thematic focus on Invasive Alien Species.
  - c. A first version of a calendar of events for the Liaison Group of the Biodiversity-Related Conventions is available at [www.cbd.int/blg/calendar](http://www.cbd.int/blg/calendar).
  - d. Given the strategic importance of COP decisions, the web section that presents them is under improvement. Part of this process consists of creating individual decision documents for easy thematic reference. COP 9 decisions documents are now available in all UN Languages, and English documents have been prepared for all CHM decisions. The process will continue in collaboration with the Conference and Editorial Services team subject to resource availability.
  - e. The systematic review and editing of the CBD web pages is ongoing, with a priority on verifying and editing existing content of the main portal pages and the most visited web pages.
  - f. Work has started to implement the LifeWeb mechanism for protected areas. Submission forms are under development for requests and donor profiles. A first operational version is expected during the next quarter.
  - g. A case studies database is under development to support the preparation of the Third Global Biodiversity Outlook (GBO3).
94. Several other CHM-related activities were also carried out and can be summarized as follows:
- a. A detailed analysis for an on-line submission system has been prepared and shared with the CHM Informal Advisory Committee.
  - b. A consultancy on knowledge and information management has started. Interviews and brainstorming discussions have taken place. An important aspect of the consultancy is to make recommendations for the future CHM knowledge base.
  - c. A database application has been implemented to keep track of key historical dates about national CHM websites and focal points. The purpose of this activity is to improve the preservation of institutional memory and enable the preparation of related statistics. The corresponding historical data compilation has started.
  - d. In order to enhance the CHM network, several CHM National Focal Points have been contacted and provided with some guidance regarding their CHM websites.
  - e. Time was also devoted to administrative processes for selecting the consultant for the web portal on the Fourth National Report, and the Associate Programme Officer for LifeWeb.

## BIOSAFETY

### THE CARTAGENA PROTOCOL ON BIOSAFETY

#### IV. IMPLEMENTATION OF THE DECISIONS OF THE CONFERENCE OF THE PARTIES SERVING AS THE MEETING OF THE PARTIES TO THE PROTOCOL

### **BS-II/2, BS-IV/4 and BS-IV/11: Operation and Activities of the Biosafety Clearing House (BCH)**

95. Following the recommendations from the last BCH-IAC meeting and in accordance with Programme Element 1 of the annex to BS-II/2, new common formats, aimed at improving the ease of reporting information onto the BCH, have been finalized and will be soon implemented in the BCH. In accordance with decision BS-IV/4 on the development of a new Roster of Biosafety Experts, 47 expert's CVs submitted by Parties or other Governments have been made available through the BCH at <https://bch.cbd.int/database/experts/>.

96. In pursuance of decision BS-IV/11, Programme element 3 of the annex to BS-II/2 and a request from the "Coordination Mechanism", the following two online forums were launched in January/February with satisfactory level of participation:

- The Online Forum on Capacity-Building, which hosted in 8 weeks eight different discussion groups. A total of 117 participants took part with 90 interventions.
- The Open-ended Online Expert Forum on Risk Assessment and Risk Management, which hosted in 6 weeks eight different discussion groups and four real-time regional conferences for Europe, Latin America, Asia and Africa. 18 National experts nominated by Parties or other Governments and 13 observers participated to the discussion groups with 88 interventions. Forty-nine national experts from 32 Governments plus 12 observers participated in the regional real-time conferences with more than 900 interventions.

97. In accordance with decision BS-IV/10 a third forum is in preparation with the aim to: (i) identify the relevant standards with regard to handling, transport, packaging and identification of living modified organisms; (ii) identify where gaps exist; and (iii) suggest possible modalities to fill the gaps. The Online Forum on Standards for LMO Shipments is scheduled from 1 April to 29 May 2009.

98. The BCH also continue to expand with various types of information including the capacity-building databases which includes public awareness projects, the biosafety-related organizations directory and the Biosafety Information Resource Center (BIRC) containing biosafety-related publications and information resources, with special focus on guidance material on risk assessment.

### **BS-IV/3 and BS-IV/4: Capacity Building**

99. The Secretariat organised an online conference on capacity-building for integration of biosafety into national development plans, strategies and programmes from 19 January to 6 February 2009. Participants shared experiences and lessons learned, reviewed the needs of countries, and explored ways of strengthening national capacities in this regard. A total of 23 messages were posted and are archived in the Biosafety Clearing-House at: [http://bch.cbd.int/onlineconferences/about\\_dev\\_cb.shtml](http://bch.cbd.int/onlineconferences/about_dev_cb.shtml). The outcomes of the conference provided in one of the background documents for the fifth coordination meeting.

100. The Secretariat also organised the fifth meeting for Governments and organizations implementing or funding biosafety capacity-building activities in collaboration with the Government of Costa Rica and the Inter-American Institute for Cooperation on Agriculture (IICA). The meeting was held in San José, Costa Rica, from 9 to 11 March 2009. The Governments of Germany and Norway and the African Union provided financial support for participants from developing countries and countries with economies in transition to participate in the meeting. A total of 47 participants from 22 governments and 15 organizations attended. The meeting adopted a set of action points to assist countries to build and/or strengthen their capacities in environmental risk assessment and post-release

monitoring of living modified organisms (LMOs) and in integration of biosafety into national development plans, such as the Poverty Reduction Strategy Papers (PRSPs) and national programmes for achieving the Millennium Development Goals. The meeting also approved two sets of guidelines, namely the “Interim Guiding Framework for Promoting Synergies and Complementarities Between Biosafety Capacity-Building Initiatives at the Country Level” and the “Draft Guidance on Promoting Regional and Subregional Initiatives and Approaches to Capacity-Building in Biosafety”. 101. The sixth meeting of the Liaison Group on Capacity-Building for Biosafety was held back-to-back with the fifth coordination meeting from 12 to 13 March 2009. It was attended by 22 participants from 14 governments and 8 organizations. The meeting recommended an initial draft of possible elements of the capacity-building component of the strategic plan for the Protocol and the new medium-term programme of work for COP-MOP. The meeting also reviewed and adopted a revised capacity-building needs-assessment questionnaire and process, and also the web-based reporting format for activities contributing to the implementation of the capacity-building Action Plan. #### **BS-IV/12: Liability and Redress**

102. The first meeting of the Friends of the Co-Chairs on Liability and Redress was held from 23 to 27 February 2009 in Mexico City, Mexico. The meeting further negotiated international rules and procedures on liability and redress for damage resulting from transboundary movements of living modified organisms in the context of the Protocol, based on the proposed operational texts contained in the Annex to the decision BS-IV/12 of the fourth meeting of the Parties to the Protocol. The Group agreed to work towards a legally binding instrument in the form of a supplementary protocol with the understanding that the final decision in this regard would only be taken by the Conference of the Parties serving as the meeting of the Parties to the Protocol. It produced a draft text for a supplementary protocol on liability and redress to the Biosafety Protocol, which will serve as a basis for further negotiations. The second meeting of the Group is scheduled for early next year.

#### **BS-IV/11: Risk Assessment and Risk Management**

103. The first series of Regional Real-time Online Conferences on Risk Assessment and Risk Management was held under the Open-Ended Online Expert Forum through the BCH. Four real-time conferences took place on 28 January (Europe), 3 February (Latin America), 10 February (Africa) and 17 February 2009 (Asia). A total of 49 national experts from 32 countries and 12 observers took part in the four real-time conferences and 910 interventions were posted.

104. The substantive issues discussed were the following:

- Development of a “roadmap”, such as a flowchart, on the necessary steps to conduct a risk assessment in accordance with Annex III to the Protocol;
- Development of further guidance material on specific aspects of risk assessment and risk management;
- Defining an action plan for the development of guidance materials on specific prioritized aspects as well as the “roadmap”.

105. The outcome of the real-time conferences will serve as one of the inputs of the deliberations by the Ad Hoc Technical Expert Group (AHTEG) on Risk Assessment and Risk Management, which is scheduled to meet from 20 to 24 April 2009 in Montreal, Canada.

106. In preparation for the AHTEG meeting, the following background documents were prepared: (i) Provisional Agenda, (ii) Annotations to the Provisional Agenda, (iii) Analysis of the Open-Ended Online Expert Forum on Risk Assessment and Risk Management, (iv) Compilation of Views and/or Information in Preparation for the Ad Hoc Technical Expert Group on Risk Assessment and Risk Management, (v) Transcript of the Discussion Groups under the Open-Ended Online Expert Forum on Risk Assessment and Risk Management, and (vi) Reports of the First Regional Real-time Conferences on Risk Assessment and Risk Management (Africa, Asia, Europe and Latin America).

107. The list of guidance materials available through the Biosafety Information Resources Centre (BIRC) of the BCH was expanded to reflect the recommendations made in submissions by Parties, other Governments and relevant organizations on views and information relevant to the work of the AHTEG, as well as the participants of the Online Forum. A document containing the updated list of guidance materials on risk assessment and risk management available through the BIRC is being prepared and will also serve as an input to the deliberations by the AHTEG.

#### **BS-IV/17: Public Awareness, Education and Participation**

108. The Secretariat advanced the implementation of the outreach strategy (2008-2012) to promote public awareness, education and participation. Some of the activities included: a continuation of the re-design and update of the Protocol website; development and dissemination of outreach materials including the COP-MOP 4 decisions booklet; maintenance of the electronic mailing service (RSS) which had 610 visitors with 21000 hits during the reporting period; and additions of records to the media database and the Biosafety Information Resource Center (BIRC). In addition, one presentation was given to 25 law students at the University of Ottawa in March.

#### **BS-II/6 and BS-IV/6 Cooperation with other organizations, conventions and initiatives**

109. The Secretariat participated in the Green Customs Initiative's annual Partners meeting which was held at the headquarters of the World Customs Organization in Brussels, Belgium from 26 to 27 January 2009. The meeting reviewed activities of the Partners and the Initiative in 2008 and planned activities for 2009.

110. The Executive Secretary submitted a written statement to delegates to the fourth meeting of the International Plant Protection Convention's Commission on Phytosanitary Measures and also submitted comments on the Draft Appendix to International Standard for Phytosanitary Measures (ISPM) No. 5, "Glossary of Phytosanitary Terms".

#### **BS-IV/8, BS-IV/9 and BS-IV/10 Handling, transport, packaging and identification of living modified organisms – paragraph 3 of Article 18**

111. The Secretariat launched the website for the Online Forum on Standards for LMO Shipments (Article 18.3) at [http://bch.cbd.int/onlineconferences/forum\\_art18.shtml](http://bch.cbd.int/onlineconferences/forum_art18.shtml). The Forum itself will be held from 18 to 29 May 2009.

**Status of Ratification or Accession to the Protocol**

112. As of 31 March 2009, with the recent ratifications of Malawi, Pakistan and the Comoros, 156 Parties to the CBD have acceded to or ratified the Protocol. The list of Parties is available on the website: <http://www.cbd.int/biosafety/signinglist.shtml>.

## ANNEX II

### Status of Implementation of the Agreed Administrative Arrangements

#### I Personnel Arrangements

1. During the reporting period, the Secretariat had 36 regularized Professional staff members and 24 regularized General Service staff members funded from the core budget. There were 1 Professional and 3 general service vacant posts for which recruitment/selection is in progress. Additionally, 5 professional posts and 11 General Service posts were funded from other sources. For more information, please refer to the attached staff list and organigram (Appendix 1 and Annex II respectively).

#### II Contributions and Funds

2. During the first quarter of 2009, thirteen pledges of additional voluntary funds in support of approved activities under the Convention (**BE Trust Fund**) were recorded. Belgium pledged EUR30,000 for the Global Life Web Project, Canada pledged: US\$30,000 towards the Marine Expert Meeting on Ecologically and Biologically Significant Areas and CAD\$100,000 for the 2010 Target, NBSAPs and IYB, CIFOR pledged US\$ 4,000 towards the printing of the CBD Technical Series # 33 on Bushmeat, in English and Spanish, Finland pledged EUR30,000 towards the 2<sup>nd</sup> Meeting of the AHTEG on Biodiversity and Climate Change, Germany pledged: EUR397,640 towards the Life Web Initiative, EUR46,213 for the COP Bureau Meeting, US\$235,755 for an SCBD Liaison Officer and EUR108,352 towards the High Level Working Group Meeting on 2010 Biodiversity Target and Post 2010 Target, Japan pledged: US\$56,523 towards the secondment of an Associate Programme Officer, US\$50,000 towards the Conference Costs of ABS-9 and US\$20,000 towards the SBSTTA-14 Meeting and Kew Gardens pledged GBP2,000 for the Travel costs of Delegates from Tropical African Countries.

3. For 2009 a total of US\$1,283,299 has been pledged to the BE Trust Fund, of which US\$738,046 or 58% has been collected as at 31 March 2009. Full details of the pledges and contributions to the BE Trust Fund are reflected in Annex IV.

4. The total amount pledged for the **BY Trust Fund** in 2009 is US\$10,505,772. Of this amount, US\$4,971,276 or 47% has been received as at 31 March 2009. A total of US\$1,014,882 has also been collected in 2009 as advance payments for 2010 and future years. Additionally, US\$1,061,200 has been pledged as additional contributions to the BY Trust Fund for 2009. US\$21,241 has also been collected in 2009 for prior years. Full details of the pledges and contributions to the BY Trust Fund are reflected in Annex VI.

5. As at 31 March 2009, US\$191,816 has been pledged for 2009 as additional voluntary contributions to facilitate the Participation of Parties in the Convention process (**BZ Trust Fund**). Full details of the pledges and contributions to the BZ Trust Fund are reflected in Annex V.

6. As at 31 March 2009, contributions to the BZ Trust Fund in 2009 amounted to US\$127,877 or 67% of the total pledged for 2009. A total of US\$218,710 remains outstanding for the BZ Trust Fund for 2009 and prior years. Full details of the pledges and contributions to the BZ Trust Fund are reflected in Annex V.

7. As at 31 March 2009, a total of sixty-two (62) countries have paid US\$1,099,442 to the **BG Trust Fund**, representing 56% of pledges for 2009. A total of US\$5,862 has also been collected in 2009

as advance payments for 2010 and future years. US\$48,587 has also been collected in 2009 for prior years. Full details of the pledges and contributions to the BG Trust Fund are reflected in Annex VII.

8. As at 31 March 2009, no Parties have pledged and/or contributed to the Special Voluntary Trust Fund for Additional voluntary Contributions in Support of Approved Activities of the Cartagena Protocol on Biosafety, (**BH Trust Fund**) in 2009. Full details of the pledges and contributions to the BH Trust Fund are reflected in Annex VIII.

9. As at 31 March 2009, no Parties have pledged and/or contributed to the Special Voluntary Trust Fund for Facilitating Participation of Developing Country Parties in the Cartagena Protocol on Biosafety, (**BI Trust Fund**). Full details of the pledges and contributions to the BI Trust Fund are reflected in Annex IX.

### III Accounting and Reporting

#### Status of Expenditure

10. COP-9 approved a budget of US\$11,391,900 for the BY Trust Fund for 2009. As at 31 March 2009, a total of US\$2,764,318 was spent or committed. This represents 24.3% of the approved amount.

11. COP/MOP-4 approved a budget of US\$2,611,800 for the BG Trust Fund for 2009. As at 31 March 2009, a total of US\$614,796 has so far been spent or committed. This represents 23.5% of the approved amount.

#### Reimbursement for Services provided to the Secretariat

12. 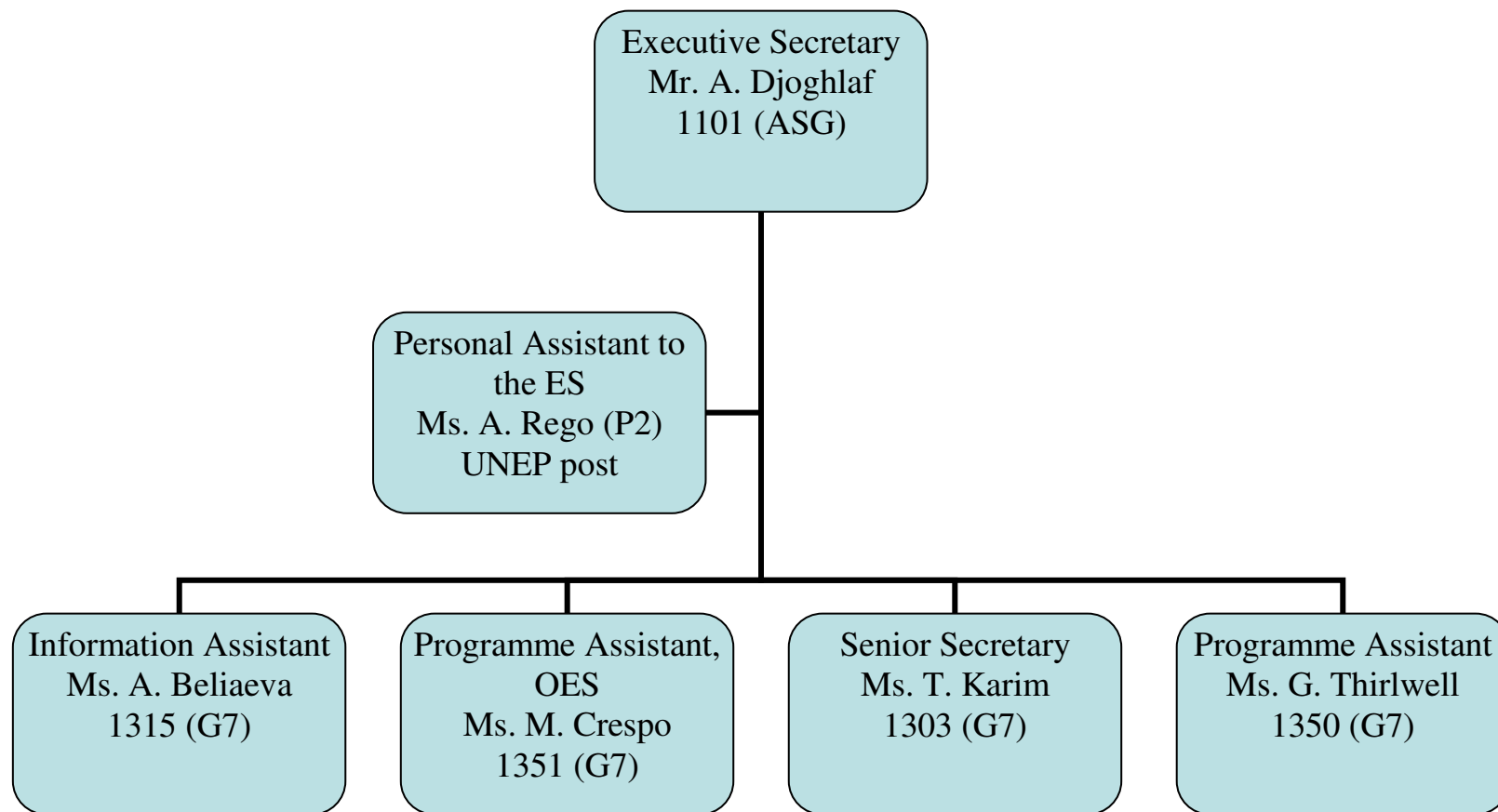

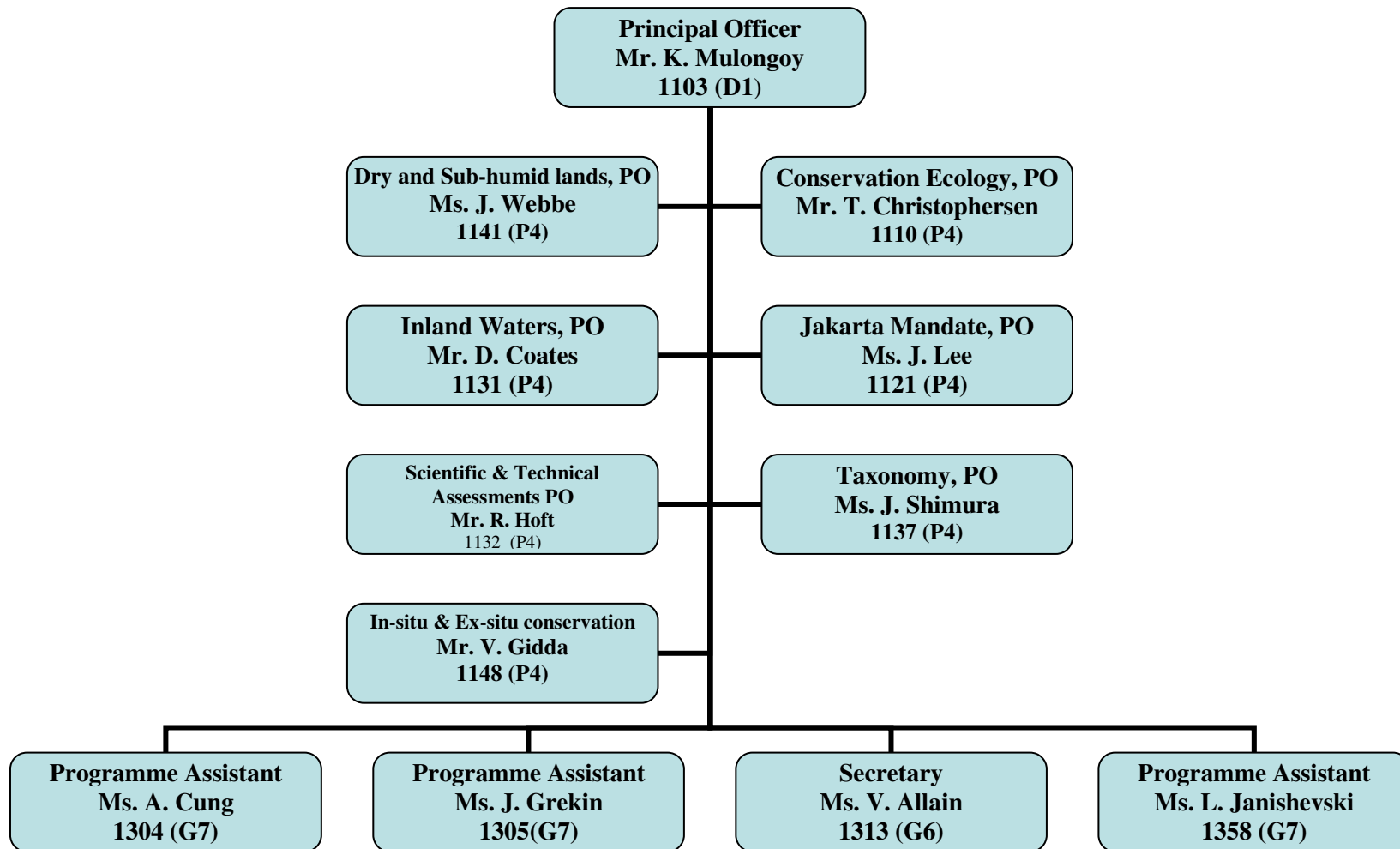

**Organizational Chart of the CBD Secretariat**

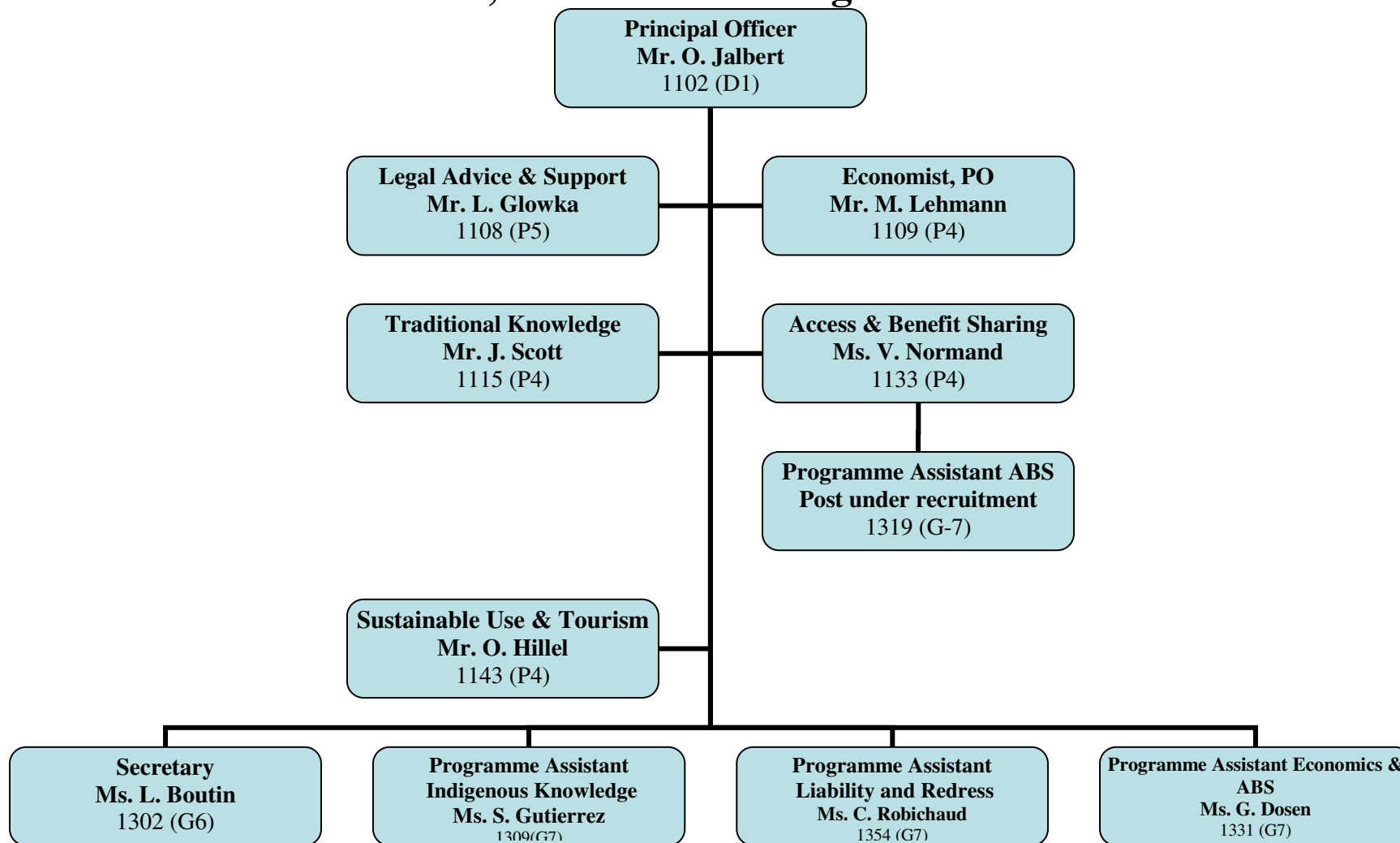
