INTRODUCTION

- 1. This report has been prepared pursuant to decision III/24 of the Conference of the Parties, which requested the Executive Secretary to prepare a quarterly report on the administration of the Convention including such matters as the staff list, status of contributions, progress on the implementation of the medium term work programme and financial expenditure report. The requirements to report on a regular basis to the Parties were further elaborated under the Administrative Arrangements between the Secretariat and UNEP, which were endorsed by the Conference of the Parties in decision IV/17.
- 2. Therefore, the Executive Secretary has prepared this Quarterly Report which contains a summary of key activities in implementing the decisions of the Conference of the Parties and other relevant matters during the period 1 July to 31 December 2010.

I. OFFICE OF THE EXECUTIVE SECRETARY

MEETINGS

- 3. Regional Workshop for Europe on the Fourth National Report, 30 June 2 July 2010, Budapest, Hungary.
- 4. Second Expert Workshop on the Development of the City Biodiversity Index, 1-3 July 2010, Singapore City, Singapore.
- 5. Pacific Sub-regional Workshop on Capacity-building and Exchange of Experiences on Risk Assessment and Risk Management of Living Modified Organisms, 5-7 July 2010, Nadi, Fiji.
- 6. The resumed session of the ninth meeting of the *Ad hoc* Open-ended Working Group on Access and Benefit-Sharing was held in Montreal, Canada, from 10-16 July 2010, and gathered the participation of more than 400 delegates. Informal, regional and interregional consultations were held on 8-9 July. Significant progress was made in the negotiations of the draft Protocol, but the Working Group was unable to finalize the text at this session. The Working Group therefore decided to continue the negotiations in September using an Interregional Negotiating Group (ING) setting. Prior to the resumed WGABS9, a COP Bureau meeting was held on 9 July.

- 12. A meeting of the Interregional Negotiating Group (ING), established to negotiate a draft international protocol on access and benefit-sharing (ABS) convened on 18-21 September 2010 in Montreal, Canada. While key issues remained outstanding, the meeting saw some progress towards an improved common understanding on key elements of the international ABS regime, most notably on the concept of utilization of genetic resources and its relation to derivatives, and on provisions on benefit-sharing and access. The results of the meeting were then transmitted to the ABS Working Group, which reconvened prior to the COP10 meeting in Nagoya.

- The fifth meeting of the Conference of the Parties to the Convention on Biological Diversity 18. serving as the Meeting of the Parties to the Cartagena Protocol on Biosafety (COP-MOP 5) was held on 11-15 October 2010 in Nagoya, Japan. More than 10,000 participants, including ministers and representatives from Governments, civil society and business, attended the meeting. The meeting was opened by Mr. Wolfgang Koehler of Germany, on behalf of Ms. Julia Klöckner, Parliamentary State Secretary in the Federal Ministry of Food, Agriculture and Consumer Protection of Germany and outgoing President of the Conference of the Parties serving as the meeting of the Parties to the Protocol. This was followed by Mr. Michihiko Kano, Minister of Agriculture, Forestry and Fisheries of the Government of Japan and incoming President of the Conference of the Parties serving as the meeting of the Parties to the Protocol. Opening remarks were also made by: Mr. Balakrishna Pisupati, on behalf of Mr. Achim Steiner, UNEP Executive Director, Mr. Ahmed Djoghlaf, CBD Executive Secretary, Mr. Masaaki Kanda, Governor of the Prefecture of Aichi; and Mr. Takashi Kawamura, Mayor of the City of Nagoya. The biggest highlight of the meeting was the adoption of the Nagoya-Kuala Lumpur Supplementary Protocol on Liability and Redress to the Cartagena Protocol on Biosafety after more than six years of negotiations. The new treaty shall be open for signature at the United Nations Headquarters in New York from 7 March 2011 to 6 March 2012 and will enter into force 90 days after being ratified by at least 40 Parties to the Cartagena Protocol on Biosafety. The meeting also adopted 16 other decisions, including a Strategic Plan for the Cartagena Protocol on Biosafety for the period 2011-2020 and a programme of work on public awareness, education and participation concerning the safe transfer, handling and use of living modified organisms for the period 2011-2015. Decision were also taken with respect to the following issues: compliance with the Protocol obligations; the Biosafety Clearing-House; capacity-building; the financial mechanism; cooperation with other organizations, conventions and initiatives; handling, transport, packaging and identification of living modified organisms; risk assessment and risk management; monitoring and reporting and assessment and review. The meeting was closed by Ms. Masayo Tanabu, Parliamentary Secretary of Ministry of Agriculture, Forestry and Fisheries, speaking on behalf of the Government of Japan and the incoming President of the Conference of the Parties serving as the meeting of the Parties to the Protocol.

Interregional Negotiating Group (ING) of the *Ad Hoc* Open-ended Working Group on Access and Benefit-sharing (WG-ABS), followed immediately by the second resumed session of the Ninth meeting of the *Ad Hoc* Open-ended Working Group on Access and Benefit-sharing, 13-15 October and 16 October 2010 (respectively), Nagoya, Japan
- 20. South-South Cooperation Forum on Biodiversity for Development, 17 October 2010, Nagoya, Japan
- 21. Meeting of the Clearing-House Mechanism Informal Advisory Committee, 17 October 2010, Nagoya, Japan
- 22. The tenth meeting of the Conference of the Parties to the Convention on Biological diversity was held in Nagoya, Aichi Prefecture of Japan, from 18 to 29 October 2010, with the theme "Life in harmony, into the future". Surpassing its record of attendance to date, the meeting gathered the participation of more than 18,000 participants. The opening ceremony started with a traditional arts performance, with Yoko Deva playing the Shinobue and a shadow play by the Kakashi-za group. The meeting was then officially opened by Mr. Jochen Flasbarth, who addressed the plenary on behalf of the COP 9 President, after which he handed over the COP Presidency to Mr. Ryu Matsumoto, Environment Minister of Japan. The new COP10 President delivered opening remarks, followed by statements from: Mr. Masaaki Kanda, Governor of the Aichi Prefecture; Takashi Kawamura, mayor of Nagoya City; Mr. Achim Steiner, UNEP Executive Director; and Mr. Ahmed Djoghlaf, CBD Executive Secretary. A video prepared by the Government of Japan was shown, which was followed by a performance by MISIA, COP10 Honorary Ambassador, with the song "Life in Harmony". The meeting adopted historic decisions aimed to meet the unprecedented challenges of the continued loss of biodiversity compounded by climate change. It achieved its three interlinked goals: adoption of a new ten year Strategic Plan or the "Aichi Target" to guide international and national efforts to save biodiversity through enhanced action to meet the objectives of the Convention on Biological Diversity, a resource mobilization strategy that provides the way forward to a substantial increase to current levels of official development assistance in support of biodiversity; and a new international protocol on access to and sharing of the benefits from the use of the genetic resources of the planet. 47 decisions were adopted in total, including a plan of action on cities and biodiversity; a multi-year programme of action on south-south cooperation; on affirming the role of CBD in reducing emissions from deforestation and forest degradation in developing countries, and forest conservation, sustainable forest management and enhancement of forest carbon stocks; the adoption of the Tkarihwaié:ri code of ethical conduct; and established clear steps to increase cooperation among the Rio Conventions leading up to the Rio+20 Summit, to name a few. A meeting of the COP 9 Bureau was convened prior to the COP 10 meeting.
- 23. Media Workshop during the tenth meeting of the Conference of the Parties to the Convention on Biological Diversity, 23-24 October 2010, Nagoya, Japan

- 28. The High Level Segment of COP 10 was held on 27-29 October 2010 at the Century Hall, Nagoya Congress Center, organized by the Government of Japan, in consultation with the Secretariat and the Bureau of the Conference of the Parties. Statements were made by heads of state and relevant international organizations; a stakeholder panel; and statements by ministers and other high-level representatives. The summary of the high-level segment is included as Appendix 2 in the final report of the COP 10 meeting.
- 29. Regional Workshop on Biodiversity and Finance in Support of the Nagoya Outcome, 29-30 November 2010, Cairo, Egypt
- 30. The COP 10 Bureau held its first meeting on 19 December in Kanazawa, Ishikawa Prefecture in Japan. Items discussed included: Work programme for the implementation of COP10 decisions; early entry into force of the Nagoya Protocol on ABS, celebration of the United Nations Decade on Biodiversity, preparations for COP11 and COP-MOP 6, among other matters. The next Bureau meeting is scheduled to take in June 2011, in the margins of the first meeting of the Intergovernmental Committee for the Protocol on Access to Genetic Resources and Equitable Benefit-sharing Arising from their Utilization.
- 31. Immediately after the Bureau meeting, the first meeting of the COP-MOP 5 Bureau was held to discuss the draft Biosafety Programme of Work including proposed Calendar of Biosafety meetings 2011-2012, and the ceremony for the opening for signature of the Nagoya-Kuala Lumpur Supplementary Protocol on Liability and Redress, among other issues. It was agreed that the next meeting of the COP-MOP Bureau will be held back-to-back with the second meeting of the COP 10 Bureau in June 2011.

MUSEUM OF NATURE AND CULTURE

- 32. In July 2010, in the margins of the meeting of the Intergovernmental Negotiating Committee on ABS held in Montreal, the delegate from Malaysia presented a replica of the Malaysian Giant Kite (*Wau*) from the Malaysian Environment Minister Dato Sri Douglas Uggah to the CBD Executive Secretary for inclusion to the CBD Museum. The *Wau*, a traditional folk game which is a living heritage of Malaysia, is a biodiversity in action as it is made from natural products and is decorated with flora and fauna motifs.
- 33. The COP 10 meeting in Nagoya provided an opportunity for the Environment Minister of Mauritania to present a woven carpet to the CBD Executive Secretary as a contribution to the CBD Museum.

REPRESENTATION

34. During the reporting period, the Secretariat took part and contributed to a number of important meetings and activities that are of relevance to the objectives of the Convention on Biological Diversity and its Cartagena Protocol on Biosafety. Details can be seen in Annex I to this report.

MEMORANDA OF COOPERATION/UNDERSTANDING

Rome University (Sapienza Università di Roma)

35. The overall objective of the agreement is to promote a strong educational, scientific and technical partnership between the Convention processes and Sapienza University, in support of the enhanced phase of implementation of the objectives, policy agenda and programmes of work of the Convention and its Cartagena Protocol, bridging the gap of information and dialogue between academia and international

conventions, in particular in developing countries where Sapienza University will play a crucial role in disseminating the issues and programmes of the Convention.

Wildlife Conservation Society (WCS)

36. The purpose of the agreement is to establish a framework for further strengthening and promoting coordination and collaboration between WCS and the Secretariat in areas of common interest relating to the threefold objective of the Convention. Areas for collaboration and joint activity are not limited to but may include the Programmes of Work on Protected Areas (including LifeWeb) and Marine and Coastal Biological Diversity, and also Article 10 of the Convention, climate change and biodiversity, biofuels and innovative financial mechanisms.

International Barcode of Life Project (iBOL)

37. The agreement aims to establish a framework of collaboration between iBOL and the CBD Secretariat with a view to furthering common goals, to include: promoting and facilitating capacity-building in species identification and discovery; scientific cooperation and technology development to provide the relevant processes of the Convention with biodiversity information; and supporting the Convention's processes with regard to biodiversity targets, NBSAPs, monitoring, indicators and assessments, and invasive alien species.

State of Paraná

38. An agreement between the Brazilian State of Paraná and the CBD Secretariat was signed in the margins of the Nagoya Biodiversity Summit with the aim of offsetting the environmental impact of the operations of the Secretariat. Building on the success of previous memoranda of understanding between the two Parties signed in March 2006 and May 2008, the new agreement will, through the Riparian Forest Programme of Paraná State, offset SCBD emissions from 2010-2012, a total of 12,625 tonnes of CO2, through native species reforestation in Paraná State.

Organization for Industrial, Spiritual and Cultural Advancement-International (OISCA)

39. The objective of the Memorandum of Understanding is to promote and enable collaboration between OISCA-International and the CBD Secretariat for the implementation of the Strategic Plan of the Convention for 2011-2020 and in particular on issues related to public awareness, education, participation and communication, with a focus on youth and children.

Secretariat of the International Treaty on Plant Genetic Resources for Food and Agriculture

40. The agreement aims to enhance cooperation between the International Treaty and the CBD Secretariat in areas of mutual interest and within the respective mandates, to include: capacity-building dealing with access and benefit-sharing as related to plant genetic resources for food and agriculture; undertaking and promoting workshops, seminars and other events including on access and benefit-sharing, as related to plant genetic resources for food and agriculture, and coordination of technical assistance; ensure the respective participation at meetings organized by them or providing expertise/input, as appropriate; and undertake studies and provide technical inputs in writing to the governing or other competent bodies of the requesting Party, as necessary for the advancement of their respective programmes of work, including on access and benefit-sharing, as related to plant genetic resources for food and agriculture.

National Institute of Biological Resources (NIBR)

41. The objective of the agreement is to promote NIBR as a collaborative center of the CBD for the implementation of the Strategic Plan of the Convention for the period of 2011-2020 and in particular the Multi-Year Plan of Action for South-South Cooperation on Biodiversity for development.

Earth Rangers

42. The purpose of the Memorandum of Understanding is to contribute to raising public awareness on the importance of biological diversity and in particular the understanding of children, youth and families and to engage children and youth in action to support the implementation of the CBD.

AEON Environmental Foundation

43. The agreement aims to promote collaboration with AEON Environmental Foundation and in partner countries of the Foundation on issues related to education and public awareness programmes on biodiversity and in particular youth and children.

Institute for Global Environmental Strategies (IGES)

44. The objective of the Memorandum of Understanding is to extend collaboration between IGES and the CBD secretariat, to broadly promote the three objectives of the Convention on Biological Diversity, drawing upon complimentarity existing between the two organizations.

RARE

45. The objective of the agreement is to establish and enable collaboration between the RARE and the CBD Secretariat towards the implementation of the Strategic Plan of the Convention for 2011-2020 and in particular on issues related to public awareness, education, participation and communication.

SEDNA Foundation

46. The agreement aims to contribute to raising awareness on the importance of biodiversity and engaging the public, in particular children and youth, in the global biodiversity agenda. Both Parties will collaborate for the success of: The Green Wave, the International Decade of Biodiversity 2011-2020 and the Sedna IV Expedition on Biodiversity.

United Nations Economic Commission for Europe (UNECE)

47. The agreement aims to further strengthen collaboration between the UNECE and the CBD Secretariat by keeping each other informed of their respective regional and subregional activities related to the provisions of the CBD and programmes of the UNECE, and will strive to use their respective expertise in support of each other's mandates in areas of mutual interest.

United Nations Development Programme (UNDP)

48. Following the Memorandum of Understanding signed by both Parties in May 2008, and in the follow up to COP 10, the CBD Secretariat and UNDP signed an agreement in the margins of the Nagoya

Biodiversity Summit, strengthening cooperation in assisting Parties to implement the New Biodiversity Strategy and 2020 Targets, and national development goals.

International Union for Conservation of Nature (IUCN)

49. An agreement to collaborate on the Implementation of the Strategic Plan was signed between the CBD Secretariat and IUCN during the COP10 in Nagoya. Issues agreed upon include: capacity-building and technical support for effective implementation of the Strategic Plan at the national level; Business and biodiversity; Programme of Work on Protected Areas; Cities and Biodiversity; and promoting South-South Cooperation.

Consortium of Scientific Partners on Biodiversity

50. During the period between July and December 2010, the Consortium of Scientific Partners on Biodiversity welcomed new members to the group, namely: National Institute of Biological Resources, the Joint Nature Conservation Committee, the Missouri Botanical Gardens, the Royal Botanic Garden Edinburgh, and the Natural History Museum of London.

United Nations Environment Programme

51. In the margins of the COP-10 meeting in Nagoya, the revised Administrative Arrangements between the United Nations Environment Programme and the Secretariat of the Convention on Biological Diversity was signed, and was endorsed by Conference of the Parties to the Convention on Biological Diversity at its tenth meeting (Annex 1 to COP X/45).

MEETINGS OF THE EXECUTIVE SECRETARY

- 52. During the reporting period, the Executive Secretary met with a number of senior staff and representatives from Parties, other Governments, organizations and institutions, with a view to further enhancing and strengthening cooperation, and raise public awareness of the work and objectives of the Convention on Biological Diversity and its Cartagena Protocol on Biosafety.
- 53. In July, the CBD Executive Secretary welcomed the visit of the following: representatives of MISIA, the Honorary Ambassador of COP10; the President-elect of the 65th session of the United Nations General Assembly; and *The Green Wave* Ambassador. In the margins of the resumed session of WGABS9, visitors to the Secretariat included: the representative of the COP 9 President/UBA-Germany President; the COP-10 Ambassador of Japan; a delegation from India and Norway, and CBD Focal Points for Syria and Iraq, to name a few.
- 54. In preparation for the COP 10, the Chairs of the Working Groups I and II and of the Budget Committee visited the Secretariat in late September and met with the CBD Executive Secretary as well as with relevant staff. The Governor of the Ishikawa Prefecture and the Director of the United Nations Forum on Forests also visited the Secretariat, and had an opportunity to address the staff on the upcoming Biodiversity meetings in Japan as well as the closing ceremony of the International Year of Biodiversity and the launch of the International Year of Forests. Students from the Research Institute on Vegetable Biology of the Botanical Gardens of Montreal also visited the CBD offices. A Korean delegation as well as students from Concordia University visited the offices in December.

- 55. On 2 July, the Executive Secretary was in New York to participate in the high-level lunch time panel discussion on "harnessing the gender dimensions of biodiversity, sustainable land management and climate change to achieve environment protection and sustainable development". The event was held to commemorate and contribute to the International Year of Biodiversity, pursuant to the United Nations General Assembly Resolution 63/219, and in support to Resolution 64/289 on the creation of the UN Entity for Gender Equality and the Empowerment of Women UN Women, the Secretariat in partnership with the Secretariat of the Economic and Social Council of the United Nations. The Executive Secretary also attended the designation ceremony of actor Edward Norton as the United Nations Goodwill Ambassador for Biodiversity by the United Nations Secretary General. Mr. Norton's appointment came as the United Nations designated 2010 as the International Year of Biodiversity, with heads of State set to discuss the issue at a high-level meeting at UN Headquarters in New York at the start of the General Assembly's 65th annual General Debate in September.
- 56. Senior staff from the United Nations Development Programme (UNDP) and the Secretariat of the Convention on Biological Diversity held a one-day brainstorming session on 19 July at the Secretariat premises. Discussions focused on the enhanced partnership between the two organizations for supporting Parties in 2011-2012 to implement the expected compact to be adopted at COP 10. The participants agreed on a two-year action plan for the implementation of COP 10 decisions to be signed in the margins of the Nagoya Biodiversity Summit.
- 57. At the Farnborough International Airshow 2010, more than 3,000 young people were given a lesson on the crucial importance of biodiversity to human well-being and to our future at the Airshow's Futures Day event which took place on 23 July, with the support of AlDIS, Airbus and the South West RDA among other partners. The Futures Day, an initiative designed to encourage young people to consider careers within the aerospace, defence and security industries, also aims to get the youth be part of the solution to global challenges such as climate change and biodiversity loss. Taking part in the event, the CBD Executive Secretary had an opportunity to meet with young people and inform them of the work of the Convention on Biological Diversity and The Green Wave initiative.
- 58. In his capacity as member of its Advisory Board, the CBD Executive Secretary participated in the seventh meeting of the TEEB Advisory Board, held on 12 August in Leipzig. The meeting provided an update on all reports, as well as launch and outreach events, including CBD COP 10 in Nagoya. In the margins of the TEEB meeting, discussions were also held with the President of COP 9 and the President of WWF International, as well as with officials from the Helmholtz Centre for Environmental Research (UFZ). A meeting was also held with the UNEP Executive Director on administrative arrangements with UNEP.
- 59. The CBD Executive Secretary attended the opening plenary of the XXIII IUFRO World Congress, and also took part in the panel on "Biodiversity, climate change and forestry perspectives of the Collaborative Partnership on Forests", one of three concurrent sub-plenaries in the afternoon. Participants were briefed on the work of the Convention, in particular, the International Year of Biodiversity, The Green Wave and the upcoming CBD COP 10 meeting. While in Korea, meetings were held with senior officials from the Republic of Korea, including the Environment Minister. The CBD Executive Secretary also paid a courtesy visit to the President of the Republic of Korea, which provided an opportunity for the President to be presented with the CBD Award in recognition of his unique contribution to the preservation of life on Earth. The CBD Executive Secretary then travelled to China to take part and deliver an opening statement at the High-level International Forum on the Strategy for Biodiversity Conservation, in Chengdu, Sichuan. Meetings were held with Chinese officials including the Vice Minister of the Environment and the Vice Governor of Sichuan. During the visit, the possibility of having a South-South agreement was discussed.

- 60. From 27-30 August, the CBD Executive Secretary was in Japan to take part in a number of events. Meetings were held the Governor of Aichi, as well as the Mayor of Nagoya. A working dinner was also organized with the new Director of the UNEP Division for the Regional Offices and the UNEP Director for Asia and the Pacific. The CBD Executive Secretary also participated in the International Youth Conference on Biodiversity in Aichi 2010, held at the Nagoya University, organized by the Ministry of the Environment, the Ministry of Foreign Affairs and Aichi Prefecture, with the generous support from the AEON Environmental Foundation. Participants learned more about biodiversity, discussed inputs for the upcoming Biodiversity meetings in Nagoya and established a network for future actions. He also attended the TEEB workshop and had bilateral meeting with the TEEB Study Leader and the representatives from IGES.
- 61. While in Japan, the Executive Secretary also travelled to Tokyo to take part in a number of meetings, including taking part in the meeting of the selection committee for the Midori Prize, a meeting with MISIA, COP 10 Ambassador, who has produced a special song for COP10 and will organize an exhibit at Tokyo Tower with the expected visit of 300,000 people. The Executive Secretary also met with the CEO and other officials of Japan Airlines. They organized a visit to see the JAL eco jet with the logo of COP 10. Meetings were held with senior officials at the Ministry of the Environment to discuss COP 10 and Japan fund, as well as with major Japanese NGOs, including WWF Japan, Wild Bird Society of Japan, and Japan Nature Conservation Society. A briefing to the EU Diplomatic corps on COP 10 was also organized. A meeting was also held with the Secretary General of OISCA on partnership and the signing of an agreement in Nagoya.
- 62. Thanks to the generous support from the Government of Switzerland, a ministerial forum of CBD COP Presidents was convened by the Secretariat on 3 September 2010 at the Château de Bossey, Switzerland. Eleven ministers responsible for the environment, representing the former and upcoming Presidencies of the Conference of the Parties to the Convention on Biological Diversity (CBD), called upon world leaders to provide leadership in shaping and implementing a new biodiversity vision for the twenty-first century. The ministers adopted the Geneva Ministerial Biodiversity Call for Immediate Action, in which they affirmed the key role that biodiversity plays in assuring human well-being and guaranteeing the provision of ecosystem services and noted with extreme concern that the 2010 biodiversity target, established at the Johannesburg World Summit on Sustainable Development, would not be met. The declaration called upon leaders that will attend the high-level event on biodiversity during the sixty-fifth session of the United Nations General Assembly to be held in New York on 22 September to lead the way in making the required national commitments to implementing the Convention and its new Strategic Plan.
- 63. Prior to the Ministerial Forum of the CBD COP Presidents, a high-level retreat among the secretariats of the Biodiversity- related Conventions was held. The retreat was an initiative of the Secretariat of the Convention on Biological Diversity in response to requests by other convention secretariats for a joint meeting before the High Level Event on Biodiversity and the tenth meeting of the CBD Conference of the Parties. The participants agreed on a common approach to address the biodiversity crisis, based on the Strategic Plan of the CBD. The group further agreed that the Strategic Plan should serve as a common framework for action over the next 10 years for all of the Biodiversity-related Conventions. While in Switzerland, similar retreats were also organized with staff of IUCN and WWF International. A briefing on the Nagoya Biodiversity Summit was given, on 7 September, to the Permanent Missions to the U.N. in Geneva and relevant press corps.
- 64. During the month of September, the CBD Executive Secretary travelled to Cordoba, Spain to attend and deliver a statement at a meeting on the role of agricultural biodiversity in addressing hunger and climate change, held in the framework of the International Year of Biodiversity and in commemoration of World Food Day. The meeting promoted raising awareness and dialogue among public institutions, universities,

scientists, civil society and the private sector; catalyzed action and projects; and contributed to defining priorities and developing policies at all levels. The CBD Executive Secretary also took part in an event hosted by ITPGRFA on Delivering Global Food Security in Cordoba which facilitated discussion on the Treaty's role in addressing food security and adaptation to climate change.

- Also in September, the CBD Executive Secretary attended the Pan-African High-Level Conference on Biodiversity was held in Libreville, Gabon, under the theme "Biodiversity and the fight against poverty: Opportunities for Africa?". The meeting, attended by Environment Ministers from across Africa and other stakeholders, identified approaches and integrated biodiversity issues into policies, strategies and programmes of economic and poverty alleviation in Africa, formulating a common African position ahead of the United Nations high level event on biodiversity in New York and the tenth meeting of the Conference of Parties to the Convention of Biological Diversity in Nagoya, Japan.
- 66. A one-day high level meeting with the participation of Heads of State and Government was convened on 22 September, pursuant to United Nations General Assembly resolution 64/203, and held as a contribution to the International Year of Biodiversity. Delegates at the meeting had before them a note by the Secretary-General (document A/64/865), which included topics on framing the post-2010 biodiversity strategy and ensuring the means for implementing it; deriving benefits from biodiversity for development and poverty alleviation; and ensuring that measures to meet the objectives of the Convention on Biological Diversity and the United Nations Framework Convention on Climate Change are mutually supportive and reinforcing. The meeting was chaired by the President of the 65th session of the UNGA, and statements were made by: UN Secretary General, Chairman of the G-77, Environment Ministers from Brazil and Germany, Japanese Foreign Affairs Minister; and the President of the European Commission. The plenary was followed by two thematic panels (in the morning and afternoon), with the first panel co-chaired by the Presidents of Slovenia and Tajikistan; and the second by the Heritage Minister of Ecuador and Environment Minister of Norway. The panels addressed, in a balanced manner, the three objectives of the Convention on Biological Diversity. The outcomes of the one-day high level event will be transmitted to the tenth meeting of the Conference of the Parties to the Convention on Biological Diversity to be in October 2010 in Nagoya, Japan. The CBD Executive Secretary also took part in a number of high-level events during the third week of September, including: High-Level Dinner hosted by Environment Minister of Norway, 21 September; High Level Reception hosted by Wildlife Conservation Society and CBD, 21 September; High Level Luncheon hosted by CBD and IUCN to discuss gender inequality: Linkages between MDG 1, 3 and 7, 21 September; and a Ministerial Breakfast meeting on access and benefit-sharing, 23 September.
- 67. The tenth meeting of the Joint Liaison Group of the Rio Conventions was convened in New York on 23 September under the chairmanship of the CBD Executive Secretary, in the margins of the high-level meeting on biodiversity of the United Nations General Assembly. The meeting provided an opportunity for the heads of the Convention on Biological Diversity, the United Nations Framework Convention on Climate Change (UNFCCC) and the United Nations Convention to Combat Desertification (UNCCD) to discuss emerging issues related to cooperation and enhanced collaboration in the context of the preparation of their respective Conferences of the Parties.
- 68. Immediately after the Nagoya Biodiversity Summit, the CBD Executive Secretary travelled to New York and presented to the Second Committee of the United Nations General Assembly the successful outcomes of the COP-MOP 5 and the COP10 meetings. A briefing was also made on the Nagoya outcomes to representatives of the Permanent Missions to the United Nations in New York. Also on the same day, a press conference on the ABS Protocol to Convention on Biological Diversity was also held. A breakfast briefing hosted by the U.K. Permanent Representative was organized at the U.K. Mission, with the participation of more than 25 Permanent Representatives to the U.N. in New York Meetings were also held

with senior U.N. officials, including the Under Secretary General of the Legal Department on the signing ceremonies of the Kuala Lumpur and Nagoya Protocols.

- 69. The CBD Executive Secretary attended the thirty-ninth meeting of the Council of the Global Environment Facility (GEF), held on 16-18 November 2010 in Washington, D.C., U.S.A. The GEF Council noted the success of the tenth meeting of the Conference of the Parties, and discussed the proposal of a Japanese ABS Trust Fund to support a multilateral benefit sharing mechanism and technology transfer as well as the request for establishing a South-South Biodiversity Fund. The Council agreed that the GEF shall launch a pilot on accrediting new agencies under Paragraph 28 of the Instrument, and priority shall be given to the accreditation of national institutions. The CBD Executive Secretary also met with senior staff from The World Bank, as well as from the Global Environment Facility, among others.
- 70. A delegation from the Secretariat of the Convention on Biological Diversity participated in the sixteenth meeting of the Conference of the Parties to the United Nations Framework Convention on Climate Change (UNFCCC COP 16) in Cancun, Mexico. The meeting provided an opportunity for the Secretariat to participate in various events relevant to the work of the CBD, as well as meet and engage with relevant partner organizations and bodies, highlighting the work of the CBD, in particular the results of the recent Biodiversity Summit held in Nagoya, Japan. A number of bilateral meetings were also held with Parties on how the CBD COP 10 decision on biodiversity and climate change could be considered by meetings of the UNFCCC and regarding collaboration for Rio +20. The Rio Conventions' Ecosystems and Climate Change Pavilion, a collaborative outreach activity involving the Rio Convention secretariats, with the Global Environment Facility and other important partners, launched during COP 10 in Nagoya, was also convened during COP 16 in Cancun. In Cancun, the Ecosystems Pavilion had an exhibit, a meeting space, and a series of associated events on topics highlighting the linkages between biodiversity, climate change and sustainable land management. The CBD Secretariat co-hosted three side events, on cooperation among the Rio Conventions, REDD and biodiversity, and ecosystem-based approaches for adaptation. The Secretariat was one of the co-hosts of the Forest Day 4, which brought together more than 1,500 of the world's leaders and experts, practitioners and policy makers, advocates and investors, indigenous people, community representatives, and the media to discuss the integration of forests into climate mitigation and adaptation from local to global levels. The CBD Executive Secretary participated in the launch of the 2011 Rio Conventions Calendar. Bilateral meetings were also held with Ministers of Environment from Costa Rica, South Africa, and Japan among others, as well as with the UNCCD Executive Secretary and senior staff from organizations such as UNDP. CBD staff also took part in meetings for the development of a gender action plan for UNCCD and a meeting between the Rio Conventions, the GEF, WEDO and IUCN to discuss how to harmonise gender mainstreaming in the three Rio Conventions and its financial mechanism.
- 71. An international conference "Getting Post-2010 Biodiversity Targets Right" was held on 11-15 December 2010, in Sao Paulo, Brazil, organized by the Biota-FAPESP Program. The CBD Executive Secretary was invited to deliver opening remarks on Post 2010 Biodiversity Targets. Gathering some key players from the Nagoya Biodiversity Summit, the meeting established important new science-based targets for the conservation of biodiversity, as well as mechanisms to monitor the implementation of targets. The meeting focused on four main topics: Post 2010 Biodiversity Targets; National and International Interoperability Among Biodiversity Information Systems; Metagenomics as a Tool to Assess Micro-Biodiversity; and Impacts of Local & Global Changes on the Atlantic Rainforest.
- 72. In December, the closing ceremony of the International Year of Biodiversity was held in Kanazawa, Ishikawa Prefecture, Japan. Opening remarks were made by Japan's Environment Minister Ryu Matsumoto, followed by welcoming remarks from Ishikawa Governor Masanori Tanimoto. Statements were also made by: the United Nations Secretary General (read by the CBD Executive Secretary); the representative from the United Nations Environment Programme and from IUCN-Regional Office in Asia;

and by MISIA, COP10 Honorary Ambassador. The results of the Nagoya Biodiversity Summit were presented, as well as a report on the International Year of Biodiversity. A ceremony bridging the International Year of Biodiversity to the International Year of Forests 2011 was also organized. A commemorative symposium and other events were held to promote a future rich in biodiversity.

- 73. A Canadian reception to mark the closing of the International Year of Biodiversity was held in Montreal, Canada on 6 December. The event gathered the participation of representatives of the Diplomatic Corps in Ottawa and Montreal, relevant partners, as well as senior staff from the City of Montreal attended the event. Statements were also made by: the Consul General of Japan in Montreal (representative of the tenth meeting of the Conference of the Parties); the Director General of the Quebec Region at Environment Canada; Director of International Organization, Ministry of International Relations, Province of Quebec; Senior Vice President for The Americas region, Japan Airlines; senior staff from AIRBUS; Director of the Environment, General Council of Moselle; Mayor of the City of Montreal and the CBD Executive Secretary. A special video on the closure of the International Year of Biodiversity was shown, highlighting the efforts made by the global community to celebrate the important Year. A fresco to celebrate the Biodiversity Year, created at the initiative of four artists from the Quebec region, was also presented.
- 74. In December, prior to the IYB closing ceremony in Kanazawa, the CBD Executive Secretary was invited to make a presentation at the 8th International Conference on Sustainability, organized by the Science Council of Japan. A meeting with the UNESCO Director General, the head of the IOC-UNESCO and the Assistant Director General for Natural Sciences was held during the third week of December.
- 75. A number of media-related events took place during the reporting period. In July, the CBD Executive Secretary was interviewed by the *BBC Arabic Network* at the Farnborough Airshow. A student from Stanford University conducted an interview on ABS. There was wide media coverage on the announcement of the designation of Edward Norton as the U.N. Goodwill Ambassador for Biodiversity.
- 76. In August, while in Nagoya, the CBD Executive Secretary was interviewed by a local TV as well as by *Yomiuri* newspaper, and by Ms. Takigawa, a famous TV anchor. While in Tokyo, an interview was made by *Japan TV*. At the initiative of the representative of the Province of Quebec in Tokyo, a briefing on the Biodiversity Summit was made at the residence of the Ambassador of Argentina, with the participation of more than 60 journalists. A video on biodiversity and an article in the JAL in-flight magazine were prepared and made available throughout October 2010 in all JAL flights
- 77. Also in August, the CBD Executive was one of the invited panelists on *CNN International's Earth's Frontiers* special edition on biodiversity. Broadcasted from the Royal Botanical Gardens, Kew, other panelists were the Director of Kew's Millennium Seed Bank and the Head of Biodiversity for PriceWaterhouseCoopers, and with the participation of environmentalist Philippe Cousteau. The debate on Earth's Frontiers focuses on the critical importance of maintaining our ecosystems and why individuals, big businesses and governments can no longer ignore the loss of biodiversity that threatens the future of our planet and our very existence, and takes place in advance of a special high-level meeting of the United Nations General Assembly on biodiversity that will take place on 22 September 2010 in New York. Other media interviews were made by *The Guardian* (UK) and *Landscape Mosaics*.
- 78. During the month of September, a briefing was made to the Geneva International Press on the biodiversity meetings in Nagoya. While on mission in Brussels, the CBD Executive Secretary was interviewed by a Brazilian journalist. In New York, the Secretariat held a press conference on 21 September with the Environment Minister of Japan, MISIA and Chairman of AEON. The CBD Executive Secretary also attended the press conference by U.N. Goodwill Ambassador for Biodiversity, together with Dr. Eric Chivian (Harvard Medical School) and Dr. Thomas Lovejoy (Heinz Center Biodiversity Chair) on

- 22 September. Interviews were also made by: *The New York Times, Agence française de presse, Nature magazine, Algerian Radio in Arabic* and *Algerian TV*, and also by UNEP's *Our Planet* magazine. The CBD Executive Secretary also contributed an article to the 2010 *OzonAction* Special Issue, "*Out of the Maze, Montreal Protocol, Climate Benefits and the Green Economy*", which was printed on 16 September.
- 79. During the Biodiversity meetings in Nagoya, daily press briefings were held. Press conferences were also held in the margins of the meetings, with some co-organized with WWF, MISIA and Conservation International with Harrison Ford. Daily media coverage by Japan local TV news and radio was also made, as well as global coverage by major international news agencies. An interview was also conducted by *The Diplomat*. The CBD Executive Secretary and Tommy Koh, Ambassador-At-Large at the Ministry of Foreign Affairs of Singapore, were interviewed by *Strait Times* on the "*Battle for Biodiversity reaches new heights*".
- 80. In the margins of the IYB closing ceremony in Kanazawa, a number of press interviews were held. The Nagoya Summit outcome was also featured in Montreal's *Le Devoir* and also *Xinhua News*.

IMPLEMENTATION OF THE ADMINISTRATIVE ARRANGEMENTS

A. Personnel Arrangements

- 81. During the period July December 2010, there were 26 Professional staff members regularized on posts approved under the Convention. There were 4 vacant posts. Additionally, 5 professional staff members are regularized on posts funded from other sources.
- 82. Under the Convention there were 23 General Service staff members regularized on posts funded by the core budget. There was one (1) vacant post. Additionally, 11 staff members are regularized on posts funded from other sources, 3 of which were formerly funded from the core budget.
- 83. During the period under review, with the generous funding from the Government of Japan the Secretariat was able to recruit four additional professional staff members to assist with the delivery of the Strategic Plan of the Convention and particular the Programme of Work on National Biodivesity Stategies and Action Plans (NBSAP).
- 84. During the period under review for the Biosafety Protocol there were 7 Professional staff members regularized on posts approved by the COP/MOP. There were 4 General Service staff members regularized on posts funded by the core budget.
- 85. For more information, please refer to the attached staff list and organigram (Annex II Appendix 1, and Annex III respectively).

B. Financial Arrangements

86. With regard to budgetary matters, as at 31 December 2010, of the total pledged contributions of US\$11,453,478 for 2010 to the General Trust Fund for the Convention on Biological Diversity (**BY Trust Fund**), the total contributions received amounted to US\$11,653,008 of which US\$2,258,387 were 2010 and future years pledges paid in 2009, and US\$9,394,621 were pledges paid in 2010 for 2010 and future years. Details of the BY Trust Fund are contained in Annex VI.

- 87. Several Parties have contributed additional voluntary funds in support of approved activities under the Convention (**BE Trust Fund**). As of 31 December 2010, the total pledged for 2010 amounts to US\$6,942,622 of which US\$6,511,364 has been received. Total unpaid pledges for 2010 and prior years to the BE Trust Fund is US\$948,115. Details of the BE Trust Fund are contained in Annex IV.
- 88. As at 31 December 2010, US\$2,023,756 has been pledged and received in 2010 as additional voluntary contributions to facilitate the participation of Parties to the Convention Process (**BZ Trust Fund**). Total unpaid pledges for prior years, to the BZ Trust Fund, amount to US\$162,138. Details of the BZ Trust Fund are contained in Annex V.
- 89. As at 31 December 2010, of the total pledged contributions of US\$2,389,071 for 2010 to the General Trust Fund for the Core Programme Budget for the Biosafety Protocol (**BG Trust Fund**), total contributions received is US\$2,774,235, of which US\$611,974 were 2010 and future years pledges paid in 2009 and US\$2,162,261 has been received in 2010 for 2010 and future years. Details of the BG Trust Fund are contained in Annex VII.
- 90. As at 31 December 2010, four Parties have pledged and/or contributed to the Special Voluntary Trust Fund for Additional Voluntary Contributions in support of Approved Activities of the Cartagena Protocol on Biosafety, (**BH Trust Fund**). To date, US\$682,401 has been received in 2010 for 2010 and future years. Details of the BH Trust Fund are contained in Annex VIII.
- 91. As at 31 December 2010, three Parties have pledged and/or contributed to the Special Voluntary Trust Fund for Facilitating Participation of Developing Country Parties in the Cartagena Protocol on Biosafety, (**BI Trust Fund**). Pledges totalling US\$117,102 have been received and collected in 2010. Total unpaid pledges for prior years, to the BI Trust Fund, amounts to US\$31,620. Details of the BI Trust Fund are contained in Annex IX.
- 92. As at 31 December 2010 two pledges have been received for the General Trust Fund for Voluntary Contributions to Facilitate the Participation of Indigenous and Local Communities in the Work of the Convention on Biological Diversity (**VB Trust Fund**) in 2010. Norway pledged NOK200,000 and Japan pledged US\$50,000. Details of the VB Trust Fund are contained in Annex X.

II. IMPLEMENTATION OF THE DECISIONS OF THE CONFERENCE OF THE PARTIES

SCIENTIFIC, TECHNICAL AND TECHNOLOGICAL MATTERS

Decision VII/27: Mountain Biological Diversity

- 93. In response to this decision, the Secretariat:
 - (a) Prepared and serviced the agenda item on the in-depth review of the mountain biological diversity programme of work at the tenth meeting of the Conference of the Parties to the Convention on Biological Diversity held in Nagoya from 18-29 October 2010. The Conference of the Parties adopted decision X/30;
 - (b) In collaboration with the Alpine and Carpathian Conventions and with ICIMOD, a side event was organized in the margins of COP 10, showcasing the implementation of the mountain biological diversity program of work at regional level. Ministers of Environment from the Governments of Austria, Switzerland, Bhutan, Peru, and Slovenia delivered keynote addresses emphasizing the

- regional cooperation and mountain to mountain cooperation for effective implementation of the mountain biological diversity programme of work; and
- (c) Attended the International Conference on "Biodiversity, Livelihood and Climate Change in the Himalayas Save the Himalayan Biodiversity for future generations" organized in Kathmandu, Nepal from 12 to 14 December 2010, as part of the International Year of Biodiversity, jointly by the Central Department of Botany, Tribhuvan University, the Ministry of Forests and Soil Conservation, and the Ministry of Environment, Government of Nepal. A statement by the Executive Secretary was distributed and a member of the Secretariat gave lectures and a statement in the opening session.

Decisions IX/1, IX/2 and X/34: Agricultural Biodiversity

- 94. In response to these decisions, the Secretariat:
 - (a) Liaised with the Food and Agriculture Organisation and Bioversity International on the preparation of a document on sustainable agriculture for dissemination (re. decision X/34, para. 17);

Decisions VIII/1 and IX/21: Island Biodiversity

 - (a) Collaborated with the Global Island Partnership (GLISPA) to organize an "Island Briefing" meeting on the theme "Islands and COP 10" before the opening of COP 10 on 17 October, in Nagoya, Japan. Kate Brown, GLISPA Coordinator, Bernard O'Callaghan, IUCN's Oceania office, along with several other partners, provided a guide to island delegates and interested stakeholders on COP topics of relevance to SIDS and island Parties, such as the COP agenda, side events, and the Strategic Plan. An "island guide" to COP 10 ("Island Journey") was distributed;
 - (b) Together with partners, launched the in-depth review of the island biodiversity programme of work, to take place at COP 11 in 2012, during an island fiesta on 26 October, organized by GLISPA, the Caribbean and Micronesia challenges, The Nature Conservancy, Micronesia Conservation Trust, IUCN, the Government of Italy and the CBD's LifeWeb. The fiesta followed a side event providing updates on progress on the Caribbean and Micronesian commitments in protected areas in terms of financing, partnerships and implementation;
 - (c) Participated in an event titled "Advancing the Biodiversity and Climate Adaptation Agenda in the Western Indian Ocean" on 20 October, organized and hosted by GLISPA, with participation from countries and institutions in the Western Indian Ocean region. The discussions and presentations included environmental and climate change needs and threats and how to address these through implementation of CBD commitments in the region, examples of cutting-edge conservation work that can help address the region's climate threats and discussion of the Western Indian Ocean Partnership, an initiative/platform to mobilize high-level leadership and support;
 - (d) Participated in an informal planning meeting for the Western Indian Ocean Partnership, organized by GLISPA on 23 October;
 - (e) Participated in a strategy meeting to discuss the in-depth review of the island biodiversity programme of work on 27 October, during which a tentative roadmap was discussed, as were potential contributions from islanders at national, regional and global levels;

 - (f) Liaised with GEO-BON on the preparation of an assessment of observation needs regarding the 20 targets of the Strategic Plan for Biodiversity 2011-2020;

The objective of the meeting was to assess and develop a strategy for restoration of a network of wilderness and large wild areas of natural habitat, process and wildlife across Europe, bearing in mind that many wild areas are threatened, but that there are substantial opportunities for restoration, creation of new areas and linkage with ecological corridor. A member of the Secretariat made a presentation in the opening session on "The wilderness momentum for modern Europe". He reviewed COP-10 guidance on what areas to restore, how to do it, expected outcomes and enabling activities. He stressed in particular COP requests in Targets 14 and 15 of the Strategic Plan, taking

into account the references to restoration in the Nagoya-Kuala Lumpur Protocol on Liability and Redress, as well as references to restoration in the CBD and previous COP decisions in particular the programmes of work.

 - (a) Organized and held the inaugural Rio Conventions' Ecosystems and Climate Change Pavilion on the margins of the CBD COP10 in October 2010 in Nagoya, Japan. This new collaborative outreach activity of the Rio Convention secretariats, the Global Environment Facility and 15 other important partners aims to enhance the linkages between biodiversity, climate change and sustainable land management at the national level;
 - (b) Participated in the sixteenth meeting of the Conference of the Parties to the United Nations Framework Convention on Climate Change (UNFCCC), held in Cancun, Mexico, 29 November 10 December 2010, including:
 - i. Hosted the Rio Conventions' Ecosystems and Climate Change Pavilion;
 - ii. Organized two side events in collaboration with the United Nations Convention to Combat Desertification (UNCCD) and the European Commission; and
 - iii. Delivered a statement under the agenda item on the Nairobi Work Programme.
 - (c) Developed the Rio Conventions' Ecosystems and Climate Change Pavilion website reflecting key themes including: protected areas and climate change; indigenous people and local communities; the linked benefits of forests for mitigation and adaptation, including through REDD-plus; water, ecosystems and climate change; dryland biodiversity; marine, coasts and islands; the economics of biodiversity and ecosystems services; ecosystem-based approaches for adaptation; and enhancing synergies for sustainable development and poverty alleviation. Presentations, interviews and key messages from the Pavilion held at Nagoya can be found on the Pavilion website (www.ecosystemspavilion.org); and
 - (d) Liaised with current and potential partners regarding the Rio Conventions' Ecosystems and Climate Change Pavilions to be held in 2011 (at the UNCCD COP10 in Korea in October and at the UNFCCC COP17/CMP 7 in South Africa in December) and to be held in May 2012 in Brazil at the United Nations Conference on Sustainable Development.

Decision IX/17: Biodiversity of Dry and Sub-humid Lands

- 102. In response to this decision, the Secretariat:
 - (a) Serviced CBD COP 10 meeting on the agenda item on the biodiversity of dry and sub-humid lands;
 - (b) Contributed to the celebrations of Land Day 3 organized on the margins of CBD COP 10;
 - (c) Participated in the sixteenth meeting of the Conference of the Parties to the United Nations Framework Convention on Climate Change (UNFCCC), held in Cancun, Mexico, 29 November 10 December 2010, including:

- ii. Organized a side event in collaboration with the UNCCD on the topic synergies between the Rio Conventions;

The workshop concluded *inter alia* that synergies between the two Convention processes in this area should be strengthened; and
- (e) Participated in the "International Conference on Drylands, Deserts and Desertification The route to restoration" hosted at Ben Gurion University's Sde Boker campus, in cooperation with the United Nations Educational, Scientific and Cultural Organization from 8 to 11 November 2010.

 - (b) Organized side events showcasing the successful implementation of PoWPA and launched the e-learning modules at the margins of COP 10;
 - (c) Raised funding from the Governments of Luxembourg, Germany, and Finland for undertaking the task of developing learning modules, and discussions for completing the Arabic translation are currently underway with the Government of Saudi Arabia;
 - (d) In collaboration with UNDP and GEF, published "Protected Areas for the 21st Century: Lessons from the UNDP/GEF Portfolio", a book showcasing best practices gained from projects supported by the UNDP/GEF for implementing the CBD Programme of Work on Protected Areas, how protected areas as critical components of a life support system can do more ecologically, socially and economically than they ever have before and management strategies that enhance the role of protected areas by facing current challenges;
 - (e) Convened the third informal meeting of the PoWPA Friends Consortium at the margins of COP 10 to discuss the strategy and *modus operandi* for facilitating implementation of COP 10 decision;
 - (f) Participated in the 20th anniversary of establishing the German Nature Conservation Academy at the Island of Vilm and presented a keynote address on the "Contribution of Vilm in shaping global biodiversity policy and capacity building" in the plenary session;
 - (g) Prepared the final project document 1 million Euros for a focussed capacity building activities for implementing the PoWPA in developing countries for consideration of EU under the ENTRP grant. The EU approved the project and signed the contract;

 - Interregional Negotiating Group (ING) of the Ad Hoc Open-ended Working Group on Access and Benefit-sharing, 18-21 September 2010, Montreal, Canada
 - Resumed Ninth meeting of the Ad Hoc Open-ended Working Group on Access and Benefitsharing, 10-16 July 2010, Montreal, Canada.
- 110. The Secretariat carried out all logistical arrangements and prepared the necessary documents for these meetings. The Secretariat also organized regional consultations and bilateral consultations for delegations prior to the meetings.
- 111. The Secretariat also participated in the following meetings:
 - (a) Regional Preparatory Meeting for the 10th Conference of the Parties to the CBD for Governmental Representatives of the Member Countries of the Amazon Cooperation Treaty Organisation (ACTO), held on 8-9 September 2010, in La Paz, Bolivia, and briefed participants in preparations for COP-10 by presenting an overview of the agenda and issues to be addressed.
 - (b) The seventeenth session of the Intergovernmental Committee on Intellectual Property and Genetic Resources, Traditional Knowledge and Folklore, held on 6-10 December 2010, in Geneva, Switzerland and presented a side-event on the adoption of the Nagoya Protocol on ABS at COP-10.
 - (c) A briefing session organised by the World Health Organisation for missions based in Geneva, held on 10 December 2010, in order to brief participants on the Nagoya Protocol on Access and Benefitsharing.
 - (d) An International Technical Expert Workshop "Exploring the need for specific measures for access and benefit-sharing of animal genetic resources for food and agriculture" organised by the Centre for Genetic Resources, the Netherlands, held from 8 to 10 December 2010, in the Netherlands.
- 112. Following the adoption of the *Nagoya Protocol on Access to Genetic Resources and the Fair and Equitable Sharing of Benefits Arising from their Utilization* at COP-10, the Secretariat, in collaboration with the Office of Legal Affairs in New York, initiated the arrangements for the opening of signature of the Nagoya Protocol to be held on 2 February 2011.
- 113. As per Decision X/1, the Secretariat invited Parties to nominate a Focal Point for the *Ad Hoc* Open-ended Intergovernmental Committee for the Nagoya Protocol and to submit information and views in preparation for its first meeting to be held from 6-10 June 2011.

Decision IX/13: Article 8(j) and Related Provisions

- 114. During this quarter, participation of indigenous and local communities (ILCs), through the voluntary fund, was finalised to ensure twenty-four indigenous and local community representatives received funding to participate in the resumed ninth meeting of the Working Group on Access and Benefit Sharing, which was held in Montreal, Canada from 10-16 July 2010. Further to this, the Secretariat facilitated an indigenous and local community representatives' negotiators meeting for twelve ILCs, which was held in Montreal from 17-21 September and also facilitated their participation in the Interregional Negotiating Group (ING) of the Ad Hoc Open-ended Working Group on Access and Benefit-sharing from 18-21 September, Montreal, to assist indigenous and local community representatives to prepare for the final ABS negotiations.
- 115. Also during this period, the Secretariat facilitated, through the VF for ILCs, the participation of thirty-one ILCs at the tenth meeting of the Conference of the Parties 18-29 October and the resumed ninth session of the WG ABS (Nagoya), as well as funded two of the ILCs chief negotiators to the ICG on ABS held from 13-15 October.

A. Capacity Building

116. The Secretariat facilitated two capacity building workshops in the Latin American and Caribbean region in Panama, from 11-13 August, and Bogota, Colombia, from 23-25 September 2010, as well as prepared for a third capacity building workshop to be held in Guyana, on 14-18 March 2011. Capacity building workshops were also held on the margins of COP 10 on 14 October for ILC women and again on 21 October for ILCs participating in the Ecosystems and Climate Change pavilion.

 - Facilitated seven side events with major partners and mounted and exhibition on ILCs and bio and cultural diversity.
 - Co-facilitated with Conservation International and the Equator Initiative (UNDP) ILCs thematic day at Ecosystems and Climate Change Pavilion
- 118. A number of side events were also organized including:
 - (a) Side event: "Article 10(c) customary sustainable use: Examples, Challenges, Community Initiatives and Recommendations" Organized by the Secretariat of the Convention on Biological Diversity and Forest Peoples Programme on 18 October. During this side-event, indigenous and local community organizations from various countries discussed future directions for article 10(c) of the Convention through the draft decisions considered at COP10. The speakers talked about '10(c) case studies' with a focus on what is customary sustainable use; what challenges these practices face; how implementation of 10(c) at national and local levels can be improved; and what communities are themselves doing to support and accelerate this process. Finally, the organizers

invited participants to continue to support further implementation of Article 10(c); they particularly invited them to join the network on customary sustainable use. - (b) Side event: Local communities within the context of the CBD. Organized by Secretariat of the Convention Biological Diversity and local communities organizations on 19 October. During this side-event government representatives and local community organizations from various countries have discussed the draft decisions on article 8(j) to be considered at COP10. In particular the draft decisions which seek to strengthen the engagement of local Communities in the work of the Convention were discussed at length. The speakers talked about regional situations and experience of local communities with a focus on CBD and traditional knowledge. Finally, the organizers invited participants to continue supporting further participation of local communities under Convention and welcomes the proposal for an expert meeting on local communities.
- (c) Side event: Indigenous and Local Communities capacity building initiatives with a focus on LAC ILCs: Three year capacity building strategy with the SCBD and the IWBN LAC region and the Indigenous Leadership Programme of Conservation International. Organized by Secretariat of the Convention Biological Diversity and Conservation International on 21 October. During this side-event, the panellists and participants discussed capacity building initiatives in particular in Latin-American and Caribbean- with a special focus on indigenous women. The speakers talked about two initiatives: a) A three-year capacity building strategy with the SCBD and the Indigenous Women Biodiversity Network IWBN LAC, and b) Indigenous Leadership Programme of Conservation International (more information http://www.conservationleadershipprogramme.org/). All speakers affirmed the importance of these initiatives and their important outcomes and expressed their desire to see them continue to grow and expand to other regions. Finally, the organizers invited participants to continue supporting these capacity building initiatives for the indigenous peoples with a focus on women and the CBD for the promotion of their full and effective participation in the meetings both in the LAC and other regions.
- (d) Side event: Indigenous and Local Communities and the Private Sector "Open for Business". Organized by Secretariat of the Convention Biological Diversity and Natural Resource Stewardship Circle (Cosmetics Industry) on 21 October. During this side-event Natural Resources Stewardship Circle of the aromatic, perfume and cosmetics industry (NRSC)- which now includes over 20 international companies- presented its final guidelines for ethical and sustainable sourcing of natural extracts from indigenous and local community producers around the world. The speakers talked about the importance of the guidelines as a significant step towards self-regulation for the industry. Lessons learned, field experience and future program of work. Finally, the organizers invited participants to continue working together for the implementation of the guidelines with indigenous peoples and to consider future capacity building needs arising from both these new guidelines, also taking into account the adoption of the ABS Protocol.
- (e) Side event: Indigenous Peoples' Knowledge and Climate Change. Organized by Secretariat of the Convention on Biological Diversity and UNESCO Links Programme. on 22 October. During this side-event, the panelists discussed climate change issues including international efforts that highlight the promotion of traditional knowledge, local experience and coping strategies as foundations for community-level response to climate change. The speakers talked about their experience and initiatives on vulnerabilities of indigenous and local communities and the impacts of climate change and the accelerated threats to traditional knowledge, innovations and practices, as well as different climate change networks. Finally, the organizers invited participants to promote, at regional and national levels, the adaptation and mitigation strategies, policies and programmes, and the full and effective participation of indigenous and local communities and to fully value and take into account traditional knowledge.

(f) Side event: Towards a joint programme of work on biological and cultural diversity. Organized by Secretariat and UNESCO on 25 October. During this side-event, the panellists discussed the links that exist between cultures and the conservation of nature throughout the world and the mutually enforcing roles of diversities, and how lessons learned can be applied to the global problems currently facing humanity and in particular how to promote sustainable development. The speakers talked about the proposed joint programme between UNESCO and the SCBD, as developed at the International Conference on Biological and Cultural Diversity for Development (June 2010, Montreal). The Work Programme's vision is to work with the global community to sustain biological and cultural diversity for present and future generations. Amongst its initial steps are plans to support and foster learning networks on bio-cultural approaches to sustainable development, linking grassroots and community initiatives with national, regional and global policy-making processes. The speakers were: Ms. Ana Persic, Man and the Biosphere Programme, UNESCO, as moderator; Mr. John Scott, Secretariat of the Convention on Biological Diversity as moderator; Mr. Luis Delgado Hurtado, Associación Yachay Wasi, Peru; Ms. Barbara Lassen, ABS Initiative for Africa, German Development Agency GTZ; and Mr. Gonzalo Oviedo, Social Policy, Finally, the organizers invited participants to continue working together for the implementation of the joint programme between UNESCO and the SCBD.

C. Fund Raising Activities

119. Finalized Secretariat's project proposals for the 2010-11 Spanish Grant.

D. Beyond 2010

120. Established a Task Force to commence planning for COP 11 and Rio+20, and to prepare for a staff retreat on 27-28 January 2011, with the objective of producing a two-year work plan up to COP 11 with a focus on coordination, harmonization and economizing of the Secretariat's activities particularly concerning capacity building.

Decisions IX/6 and X/44: Incentive measures

- 121. In the period under review, the Secretariat finalized relevant documentation on the topic for the tenth meeting of the Conference of the Parties, which convened from 18 to 29 October in Nagoya, Japan, serviced the meeting in its deliberations on the topic, and initiated implementation of the pertinent decision of the tenth meeting of the Conference of the Parties.
- 122. The Secretariat finalized the draft of the lessons learnt and good practice cases on the removal or mitigation of perverse incentives and the provision of positive incentive measures, as reviewed by the tenth meeting of the Conference of the Parties, for publication, with the financial support of the European Union and SIDA, through the clearing house mechanism of the Convention and as a Technical Series document.
- 123. The Secretariat participated in the sub-regional workshop for Central Africa (COMIFAC) on integrated assessments of trade-related policies and biological diversity in the cacao sector. This meeting took place in the context of UNEP's 5-year initiative to support, in close cooperation with the Secretariat, assessing the impacts of trade liberalization on biodiversity in six ACP countries, thereby responding to earlier requests of the Conference of the Parties (see decision VII/3, paragraph 6). The last phase of the initiative supported the dissemination of the assessment outcomes at national and (sub) regional levels.

124. The Secretariat co-organized, together with the German Agency for Nature Conservation, a workshop on payments for ecosystem services, in Germany, Island of Vilm, from 14 to 16 December 2010. The workshop responded to the invitation and request of the Conference of the Parties expressed in decision IX/6, paragraph 15, to further study and analyse payment schemes and their advantages as well as their potential limitations and risks, their cost-effectiveness, equity issues, and potential their implications for biodiversity and indigenous and local communities.

Decision IX/14: Technology Transfer and Cooperation

125. The Secretariat finalized relevant documentation on the topic for the tenth meeting of the Conference of the Parties, which convened from 18 to 29 October in Nagoya, Japan, serviced the meeting in its deliberations on the topic, and initiated implementation of the pertinent decision of COP 10, including the preparation and sending of Notification 2010-207.

Decisions IX/28 and X/22: Promoting engagement of cities and local authorities

- 126. The second expert workshop on the development of CBI took place on 1-3 July 2010, at the Singapore Botanic Gardens, and was co-organized by the Secretariat of the Convention on Biological Diversity and National Parks Board of Singapore. The workshop was organized in close consultation with the members of the Global Partnership on Cities and Biodiversity. The objectives of the workshop were to review comments by cities which have test-bedded the index; refine and improve the indicators of CBI; and finalize the User's Manual for CBI. - Partnership on Cities and Biodiversity to which over 15 participants contributed each time, notably in view of preparing their participation at the COP and to submitting the Plan of Action on Sub-national Governments, Cities, and other Local Authorities for Biodiversity (2011-2020) to the Parties for adoption. On 29 October, the Plan of Action was endorsed, and decision X/22 including the Plan was adopted by 193 CBD Parties at the COP 10 meeting. The Plan calls for capacity building and dissemination of best practices and for an "assessment of the links and opportunities between urbanization and biodiversity" to be produced by 2012, and aims at providing national governments with opportunities to work together with sub-national governments, cities, and other local authorities on the development of biodiversity strategies and action plans. - 128. On 22 October, over 75 people took part in a side-event on Local Biodiversity Strategies and Action Plans which aimed at recognizing the role of sub-national governments in the implementation of the Convention. The Governor of Uppsala and representatives from Aichi, Ishikawa, Hyogo, Parana, UNU, took the opportunity to exchange on best practices related to biodiversity management at sub-national level and success stories of collaboration between levels of governments. Also on 22 October, a side-event on Cities and Biodiversity aimed at improving cooperation for local implementation of the CBD was held. The Mayor of Nagoya and city government representatives from Curitiba, Montreal and Bonn presented their actions for urban biodiversity and their involvement in regional and international activities.
- 129. On 24-26 October 2010, the CBD Secretariat attended the City Biodiversity Summit 2010 as a coorganizer of this event. During the three-day event, more than 600 top executives including 240 mayors, governors, local government officials and heads of international organizations, shared best practices and lesson learned from their actions for local biodiversity. The Secretariat organized a plenary session where

the participants discussed the CBD Plan of Action with representatives of supportive CBD Parties and expressed their support towards the endorsement of the Plan by the COP. The City Summit results, adopted as the Aichi/Nagoya Declaration on Local Authorities and Biodiversity, were announced by Mayor Kawamura of Nagoya and Governor Kanda of Aichi Prefecture at the high-level segment of COP 10 on October 28, to the Heads of States and Governments. The City Summit Declaration is available in six U.N. languages plus Japanese, please see: http://www.cbd.int/authorities/importantevents/.

130. In order to promote the biodiversity-related activities of cities and local authorities around the world and raise awareness on the important role local authorities can play in biodiversity conservation, the Secretariat published the second issue of the Cities and Biodiversity Newsletter in time for the City Biodiversity Summit 2010 and COP 10. Decisions VIII/14: Biological Diversity and Tourism - IX/13: Article 8(j) and Related Provisions

- 131. The second ITBW Award Official Ceremony was held during the Ecotourism and Sustainable Tourism Conference (ESTC), in September, in Portland, Oregon, USA. During the ESTC 2010, indigenous and local communities tourism was discussed in different opportunities, such as the press conference, an expert panel, and the closing ceremony, which was held during the 2010 ESTC Closing reception. The two winners and two finalists present at the Conference also had the opportunity to meet with several companies. The Secretariat also organized a one-day workshop Web2.0 Training: New information and Web-based Technologies, which offered practical training on tools for developing genuine conversation, business networking and guerrilla marketing, facilitated by Planeta.com founder Ron Mader.
- 132. As a side-event to COP10, the Secretariat organized a panel on "Sustainable Tourism as a Development Strategy for Indigenous Peoples". The panel introduced Indigenous Tourism experiences and also the winners of the Award for Best Indigenous Tourism and Biodiversity Website 2010. With a considerable number of participants, the event was moderated by Oliver Hillel from the CBD and the panellists were Mr. Peter Cochrane, CBD Focal Point for Protected area and Director of National Parks, Department of the Environment, Water, Heritage and the Arts of Australia; Mrs. Sarah Goodwin, ITBW finalist from Squamish *Lil'wat* Cultural Centre Canada; Mr. Nils Torbjörn, ITBW award winner from Nutti Sámi Siida Sweden; Mr. Michael Meyer, Expert Consultation Unit on Biodiversity and Tourism of UNWTO; Mr. Cecilio Solis Librado from RITA (Red Indígena de Turismo de Mexico A.C.); and Mr. Alancay Morales from the NGO Kus Kura S. C. Indigenous.

OUTREACH AND MAJOR GROUPS

Decision IX/26: Promoting Business Engagement

- 133. The *Business.2010* Newsletter (Volume 5, issue 3) with special focus on the Strategic Plan was issued and distributed at COP10.
- 134. The Conference of the Parties at its tenth meeting adopted Decision X/21 on Business Engagement which requests the CBD to undertake a number of actions, for example to compile, analyze and make available tools and mechanisms for the business sector and to encourage the establishment of national and regional business and biodiversity initiatives.
- 135. At COP10, the Keidanren Committee on Nature Conservation, Global Environment Facility (GEF), Aichi Nagoya COP10 Promotion Committee and CBD co-organized a high-level dialogue with

Governmental and Business leaders. Besides this COP10 saw several relevant events for the business sector for example the full day event International Business and Ecosystems Dialogue which gathered several global leaders on Biodiversity and ecosystems.

136. During the second half of 2010, CBD participated at several events in Montreal on integration of biodiversity in businesses' strategies. These events were organized by Quebec Centre for Biodiversity Science (QCBS) (McGill University) and saw participation from Hydro Quebec, HEC Business School, WRI, Quebec and Canadian Government, Canadian Business and Biodiversity Council etc.

Decisions IX/32 and IX/33: Programme of Work for Communication, Education and Public Awareness and the International Year of Biodiversity

- 137. The CBD and the International Year of Biodiversity contributed to the work of ECOSOC through a high-level panel on gender and biodiversity on 2 July in New York. The SCBD, in partnership with the Secretariat of ECOSOC, facilitated a panel discussion on "harnessing the gender dimensions of biodiversity, sustainable land management and climate change to achieve environment protection and sustainable development". This event fell under the mandate as outlined in UNGA resolution 63/219 to commemorate and contribute to the International Year of Biodiversity.
- 138. On 8 July, marking the 2010 International Year for Biodiversity, United Nations Secretary-General Ban Ki-moon designated two-time Academy Award-nominated actor Edward Norton as the United Nations Goodwill Ambassador for Biodiversity.
- 139. A one day high-level discussion of Biodiversity and its contributions to the Millennium Development Goals, featuring heads of state was held on 22 September, in the margins of the 65th session of the United Nations General Assembly. A series of interactive panels explored key strategic issues relating to biodiversity, the Millennium Development Goals, and the CBD. On the same day, staff of the CBD Secretariat rang the bell for biodiversity. This was part of a symbolic ringing of church bells in different parts of the world, mainly in the UK. For instance, the Peterborough Cathedral rang its tolling bell 492 times on 22 September in tune with the high level event on biodiversity in New York one toll for each animal and plant species that England has lost.
- 140. The Governor of Ishikawa Prefecture paid official visit to the Secretariat of the Convention on Biological Diversity on 29 September. In preparation for the Nagoya Biodiversity Summit, the Secretariat of the Convention on Biological Diversity and the Governor of Ishikawa prefecture, Masanori Tanimoto, accompanied by an important delegation, paid a visit to the Secretariat to prepare the closing ceremony of the International Year of Biodiversity, to be held in Kanazawa City on 18-19 December 2010. The preparation of the New Biodiversity Vision of Ishikawa, to be presented at the tenth meeting of the Conference of the Parties to the Convention on Biological Diversity, was also discussed. The New Biodiversity Vision of the prefecture revolves around the traditional land management strategy, Satoyama, and the reintroduction of the Crested Ibis, which became extinct in the wild in Japan in 1981.
- 141. The International Year of Biodiversity wins the Green Award as best global environmental campaign. With the slogan "Biodiversity is Life. Biodiversity is our Life", the International Year of Biodiversity won the coveted 2010 Green Award for best Global Campaign in recognition of the strength of a campaign that inspired activities throughout the world that showcase the value and beauty of biodiversity. The award ceremony took place at London's Natural History Museum on 2 December with more than 400 guests. The ceremony was attended by Sir David Attenborough, Britain's best loved naturalist with more than 50 years of broadcast experience including the BBC Life series. The Rt. Hon. Chris Huhne, Secretary

of State for Energy and Climate Change, delivered a key note address. Mr Eric Falt, the Assistant Director-General of UNESCO, also addressed the participants.

- 142. The Secretariat of the Convention on Biological Diversity organized a local closing ceremony for the International Year of Biodiversity in Montreal attended by representatives of the diplomatic corps in Ottawa and Montreal, senior officials from the Governments of Canada, Quebec and the City of Montreal, and relevant partners.
- 143. The closing ceremony of the International Year of Biodiversity: Contribution to the International Year of Forests 2011 was held on 18-19 December, organised by the Executive Committee for the Closing Event for the International Year of Biodiversity and Secretariat of the Convention on Biological Diversity in collaboration with the Government of Japan, Ishikawa Prefecture, City of Kanazawa, local economic organizations and the United Nations Forum on Forests.

E. CEPA Fair

- 144. The tenth meeting of the Conference of the Parties (COP 10) and the celebrations of the International Year of Biodiversity provided the perfect backdrop to host the second Communication, Education and Public Awareness (CEPA) fair. This year's CEPA Fair provided the opportunity for partners and Parties to highlight the contribution of CEPA activities to implementation of the Convention and to mainstreaming the work of the Convention. A total of 36 events were held. A range of themes were showcased including:
 - CEPA and the strategic plan of the CBD;
 - Biodiversity monitoring and citizen science;
 - Media relations and biodiversity;
 - Building capacity for CEPA at national and regional levels;
 - Mainstreaming biodiversity into education for sustainable development;
 - Natural history museums, zoos, botanical gardens and CEPA;
 - Information technology and CEPA (including social networking);
 - Indigenous and local communities (ILCs) and communicating traditional knowledge;
 - Communicating the economic value of biodiversity
- 145. In addition to the above mentioned presentations, the CEPA Fair area was abuzz with activity as organizations used the occasion to set up booths to highlight their activities and communication products.

F. Media Training

146. Journalists from Brazil, India, the Philippines, Kenya, Mexico, Mozambique, Nigeria, Uganda, Samoa, South Africa and Sri Lanka attended the Media Training Workshop which was held on 23-24 October in Nagoya, Japan. Their attendance to the workshop was made possible thanks to the generous financial assistance from the Government of Spain. The participation of two journalists from the African region was also made possible through the kind support of the Global Environment Facility. The journalists were provided with a series of presentations covering different relevant topic areas pertinent to the work of the Convention. The aim of the workshop was to demystify biodiversity by explaining the different Programmes of Work covered by the Secretariat and to highlight the key issues to be covered at the COP. The funded journalists were also able to attend the High Level segment held during the COP and report back their findings to their respective Media Outlets. A total of 64 articles were published by the sponsored participants.

G. Press Conferences

- 147. A total of 94 Press Briefings were held during the tenth Meeting of the Conference of the Parties COP 10. A total of 1,772 media representatives were officially given media accreditation.
- H. Expert Meeting on a Communications kit for biodiversity and climate change
- 148. During the UNFCCC 16 meeting held in Cancun, Mexico, the Secretariat organized a meeting of experts on "Biodiversity, Climate Change and Education for Sustainable Development for Small Island Developing States" held on 6 December 2010. Thanks to the financial assistance of the government of the Netherlands, this workshop was structured within the framework of the Programme of Work (POW) for Communication, Education and Public Awareness (CEPA). The aim of the workshop was to develop a work plan and pave a way forward for the creation of an educational toolkit that integrates biodiversity and climate change messages in an Education for Sustainable Development Framework for stakeholders in Small Island Developing States.

IMPLEMENTATION AND TECHNICAL SUPPORT

Decisions VIII/8 and IX/8: National Biodiversity Strategies and Actions Plans

- 149. By the end of November 2010, 171 (89% of the total) have finalized their national biodiversity strategies and action plans or equivalent instruments. In addition, 13 Parties have informed the Secretariat that they are preparing their national biodiversity strategy and action plan. Two Parties that have acceded to the Convention in the last two years, and seven others, have not prepared a national biodiversity strategy and action plan or initiated the process to do so, or have not informed the Secretariat that they have done so. At least 49 Parties have revised national biodiversity strategies and action plans, or are in the process of doing so.
- 150. The Secretariat is continuing work on the compilation of case studies, tools and guidance arising from the fourth national reports and the sub-regional capacity-development workshops held in 2008 and 2009 on NBSAP implementation and biodiversity mainstreaming (www.cbd.int/case-studies/). The Secretariat has drawn upon this material to enhance and update the capacity development modules on national biodiversity strategies and action plans (www.cbd.int/nbsap/training/) in line with Decision IX/8. At present, preliminary drafts of three revised modules in this series of seven are available on the CBD website for consultation.
- 151. In early September 2010, at a retreat in Château de Bossey, Switzerland, the heads and representatives of five international conventions on biodiversity and major conservation organizations agreed to a common approach to address the biodiversity crisis, based on the Strategic Plan of the Convention on Biological Diversity (CBD) for the period 2011-2020.
- 152. A high-level meeting of the United Nations General Assembly was held on 22 September 2010, as a contribution to the International Year of Biodiversity. A summary of discussions prepared by the President of the 65th session was subsequently presented to the tenth meeting of the Conference of the Parties in Nagoya in October 2010. Further details on the high-level meeting are available at: http://www.cbd.int/sp/sp2010p/unga.shtml.

Decisions VIII/14 and X/10: National reporting

- 153. As of end of November 2010, a total of 157 final fourth national reports had been received. In addition, 11 countries had sent their advanced draft reports.
- 154. The Executive Secretary circulated a reminder during COP 10 to all heads of the delegations of those countries that have not submitted their fourth national reports, urging them to submit the report before the end of 2010. Follow-up messages were sent to these countries by the Secretariat after COP 10.
- 155. An updated analysis of the fourth national reports received as of 22 September 2010 was prepared for the tenth meeting of the Conference of the Parties (see UNEP/CBD/COP/10/INF.2).
- 156. Two lists providing updates on the status of the fourth national reports were issued before COP 10 was opened and closed (see UNEP/CBD/COP/10/INF.2/Add.1 and UNEP/CBD/COP/10/INF.2/Add.2).
- 157. Draft guidelines for the fifth national report were revised and presented for consideration and adoption at the tenth meeting of the Conference of the Parties. The guidelines as contained in the document UNEP/CBD/COP/10/11 have been adopted by the tenth meeting of the Conference of the Parties in its decision X/10. The finalized guidelines in the six UN languages will be made available to Parties before the end of 2010 or early 2011.
- 158. A preliminary draft resource manual for the fifth national report was prepared for the tenth meeting of the Conference of the Parties, as contained in UNEP/CBD/COP/10/INF.19. Currently the draft manual is being further developed.
- 159. Development of a webpage or portal on the Convention website is being considered to provide assistance to Parties for preparing the fifth national report.

Decision IX/30: Scientific and Technical Cooperation and the Clearing-House Mechanism

- 160. During the third and fourth quarters of 2010, activities related to the Clearing-House Mechanism (CHM) can be summarized as follows:
 - (a) The CHM pre-session documents for COP 10 were prepared in consultation with the CHM Informal Advisory Committee (CHM-IAC). These documents consisted of a report on progress made with recommendations for further development (UNEP/CBD/COP/10/15), as well as a few additional information documents providing further details. The recommendations contained the CHM mission, goals, and objectives aligned to the new Strategic Plan for Biodiversity 2011-2020, together with a list of priority activities for the intersessional period. The COP adopted decision X/15 based on the draft decision.
 - (b) A meeting of the CHM Informal Advisory Committee was held on Sunday 17 October 2010 at the margins of COP 10. The meeting documentation included a detailed description of the information services for the central CHM (UNEP/CBD/CHM/IAC/2010/1/3). During the meeting, strategic and technical aspects of the CHM were discussed at the central, national and partner levels, and participants made constructive recommendations in line with the draft decision on the CHM. Details are available at www.cbd.int/doc/?meeting=chmiac-2010-01.
 - (c) Several activities were related to the CBD website:
 - The establishment of the COP 10 and COP-MOP 5 web portals;

- The development of an online registration system for meetings;
- The preparation of an online interactive version of COP 10 decisions;
- The ongoing translation of web content;
- The preparation of web-design templates for a new version of the CBD website to be launched in early 2011.
- (d) A few steps were taken to prepare the content for the future CHM knowledge base. First, part of the support for the CHM from the Government of Spain will be reserved for biodiversity expertise in identifying and compiling relevant information resources. Second, an information assistant will dedicate part of her time to catalog publications and other reference documents. Third, an intern in knowledge management will contribute to the organization of the knowledge base during the first quarter of 2011.
- (e) The European CHM is considering further enhancements to the European Portal Toolkit and a virtual meeting was held on 13 December to discuss the requirements for national CHM websites.
- (f) The CBD Secretariat was represented as the North American Regional Meeting of the Global Biodiversity Information Facility (GBIF) which took place on 11-12 August 2010 in Guelph, Ontario, Canada. Further collaboration followed with GBIF's CHM-IAC member to define biodiversity information services that GBIF can provide to the CHM network. A joint GBIF-CBD side event was organized during COP 10 to inform Parties of this project.
- (g) Collaboration continued with the MEA Information and Knowledge Management initiative. A video conference was held on 7 September 2010 to prepare for the COP 10 side event, and a second one was held on 12 November 2010 to discuss the next steps in the implementation of the InforMEA portal, the interoperability mechanism, and the possibility of online reporting.

Decision IX/24: Gender Plan of Action

- 161. In an effort to highlight the inter-linkages between the three Rio Conventions, from gender perspectives in particular, and how this contributes to sustainable development, the Secretariat organised a high-level lunch-time panel discussion on Harnessing the gender dimensions of biodiversity, sustainable land management and climate change to achieve environment protection and sustainable development in collaboration with the Secretariat of the Economic and Social Council (ECOSOC), on 2 July 2010. Participants included, U.N. Deputy Secretary-General Asha-Rose Mtengeti Migiro; H.E. Ms. Ritva Koukko-Ronde, Under-Secretary of State, Ministry of Foreign Affairs, Finland; H.E. Ms. Elza Pais, Secretary of State for Equality, Portugal; H.E. Ms. Melanne Verveer, Ambassador-at-Large for Global Women's Issues, U.S. Department of State via video message; Mr. Ahmed Djoghlaf, Executive Secretary, CBD; Mr. Narinder Kakar, UN Permanent Observer, IUCN; Mr. Nikhil Seth, Director, Office of ECOSOC Support and Coordination and Mr. Melchiade Bukuru, Chief, UNCCD Liaison Office.
- 162. The discussions demonstrated the inter-linkages between climate change, biodiversity and sustainable land management (SLM), as well as how gender-sensitive approaches to these issues contribute to sustainable livelihoods, environment protection and sustainable development. In highlighting the implications for biodiversity and the people who manage and rely upon it, in (inter)government, business and other decision-making bodies, the panel members brought the issue to the forefront, similarly to what is currently being done for climate change. Through the interventions, it was clear that the political, economic, and social empowerment of women is of vital importance and that investing in women and girls is key not only for achieving the Millennium Development Goals and sustainable development as a whole, but also for advancing global peace and security. It was also clear that governments need to provide

financial support to gender equality initiatives within the responsible (environment) ministries as well as within the Rio Conventions.

- 163. Building on these discussions and as support to the United Nations General Assembly resolution A//RES/64/289 which aims to help the U.N. system be accountable for its own commitments on gender equality, including regular monitoring of system-wide progress, the inter-linkages between biodiversity, climate change and sustainable land management from a gender perspective, the CBD Secretariat and the International Union for Conservation of Nature (IUCN), in partnership with the Government of Finland and the Millennium Challenge Corporation, facilitated a luncheon discussion on Gender inequality A constraint to economic growth, biodiversity protection, poverty reduction and sustainable development: Linkages between MDG 1, 3, and 7 on 21 September 2010 at the margins of the MDG Summit.
- 164. The keynote speakers, Mr. Ahmed Djoghlaf, Executive Secretary, CBD; Ms. Julia Marton-Lefèvre, Director General, IUCN; Ms. Cassandra Butts, Senior Advisor MCC; Mr. Luc Gnacadja, Executive Secretary UNCCD; H.E. Ms. Tarja Reponen, Ambassador for Sustainable Development, Ministry of Foreign Affairs Finland and H.E. Ms. Gunilla Carlsson, Minister for International Development Cooperation, Ministry of Foreign Affairs, Sweden, each presented a review of successes, best practices and lessons learned, obstacles and gaps, challenges and opportunities faced in the last ten years in achieving the MDGs in particular, with regard to the integration of MDG 3.
- 165. Through the roundtable discussions, there were several common actions that were called for towards the achievement of MDG 3. Amongst these are:
 - (a) Two-prong education for all stakeholders at all levels: from infancy through adulthood
 - (b) Finance:
 - i. Strengthening of micro-credit schemes for women to access loans
 - ii. More funding for community/grass roots gender activities
 - iii. More women needed in decision-making positions in the finance world
 - (c) Legislation for resource rights to be transferred to women
 - (d) Land and inheritance rights for women
 - (e) Integration of traditional and cultural rights into the gender debate
 - (f) Coordination among the Rio Conventions on gender.
- 166. The full report can be found at www.cbd.int/gender.
- 167. The tenth meeting of the Conference of the Parties, through its decision X/19: (i) emphasized the importance of gender mainstreaming in all programmes of work under the Convention in order to achieve the objectives of the Convention and its Strategic Plan for the period 2011-2020; (ii) Requested the Executive Secretary in cooperation with other intergovernmental and non-governmental organizations, to enhance efforts to fully implement the Plan of Action in order to mainstream gender considerations in all aspects of the work under the Convention and formulate clear indicators to monitor progress; (iii) invited Parties to consider gender as a core cross-cutting issue in the implementation of biodiversity-related activities; and (iv) urged Parties to promote the mainstreaming of gender considerations in developing, implementing and revising their national and, where appropriate, regional, biodiversity strategies and action plans, and equivalent instruments, in implementing the three objectives of the Convention, taking into account the guidance provided in the CBD Technical Series No. 49.

- 168. In addition, other decisions from COP 10 which call for gender mainstreaming and/or the full participation of women include:
 - Decision X/1 Access to Genetic Resources and the fair and Equitable Sharing of Benefits arising from their Utilization (ABS) Annex 1, Nagoya Protocol, paragraph 11; Article 22 Capacity; Article 25 Financial Mechanism and Resources, paragraph 3;
 - Decision X/2 Updating and Revision of the Strategic Plan for the Post-2010 Period paragraph 3(a), 9; Annex Strategic Plan for Biodiversity 2011-2020 and the Aichi Biodiversity Targets IV Strategic Goals and the Aichi Biodiversity Targets, 462 Strategic goal D: Enhance the benefits to all from biodiversity and ecosystem service, Target 14; V. Implementation, Monitoring, Review and Evaluation, 463 Means of Implementation, 464 Programmes of work, 465 Broadening political support, 466 Partnerships, 467 Reporting by Parties; VI Support Mechanisms, 469 470 Capacity-building for effective national action, 473 Partnerships and initiatives to enhance cooperation, 474 Support mechanisms for research, monitoring and assessment;

Decisions IX/11 and IX/31: Financial Resources and the Financial Mechanism, and guidance to the Financial Mechanism

- 169. The Executive GEFOP meeting was held via teleconference on Wednesday, 13 October 2010. The meeting reviewed the proposed work program for presentation to the 39th meeting of the GEF Council.
- 170. The GEF document "Enhancing the Relationship with the Conventions" for the GEF Council incorporated several ideas from the Secretariat.
- 171. The press information on financial resources and the financial mechanism was prepared in advance of the tenth meeting of the Conference of the Parties, and was included in the press package.
- 172. The first edition of Global Monitoring Report Innovative Financing for Biodiversity was released in time for the tenth meeting of the Conference of the Parties, and available on the website.
- 173. Two major documents on financial resources and the financial mechanism (UNEP/CBD/COP/10/13 and UNEP/CBD/COP/10/14) were prepared and circulated in time for the tenth meeting of the Conference of the Parties.
- 174. Notifications concerning Green Development Mechanism and Business-Biodiversity Offset Programme were circulated to Parties and relevant stakeholders in response to the request from the third meeting of the *Ad Hoc* Open-ended Working Group on Review of Implementation.
- 175. The tenth meeting of the Conference of the Parties succeeded in adopting several decisions related to financial resources and the financial mechanism, including Decisions X/3 on resource mobilization, X/24 on review of guidance to the financial mechanism, X/25 on additional guidance to GEF, X/26 on assessment of funding needs for GEF-6, X/27 on the fourth review of the effectiveness of the financial mechanism.
- 176. The project proposal on enabling early into force of the Nagoya Protocol on Access and Benefit Sharing has been prepared and presented to the GEF CEO through the UNEP/GEF.
- 177. The GEF report to the tenth meeting of the Conference of the Parties was made available in time for the Nagoya Conference. The Programme attended the side-event organized by the GEF to provide updated information on the GEF-5 biodiversity strategy.
- 178. The GEF report to the GEF Council on Relations with Conventions and other International Institutions drew substantial inputs from the Financial Services Programme of the Secretariat.
- 179. The 39th GEF Council Meeting was held from 16-18 November 2010. The Executive Secretary delivered a statement transmitting the guidance from the tenth meeting of the Conference of the Parties, as well as other related decisions. The meeting had initial consideration of the requests for the Japan ABS Fund and the South-South Biodiversity Cooperation Fund.

- 180. The outcome of the 39th GEF Council Meeting was transmitted to Parties and relevant stakeholders immediately after the meeting.
- 181. The terms of reference for a Junior Programme Officer on the strategy for resource mobilization were prepared and funding has been sought.
- 182. A regional workshop on biodiversity and finance was convened by the League of Arab States, CBD Secretariat and UNEP/ROWA from 29-30 November 2010. The meeting was attended by 51 participants, from 17 Arab countries and 14 regional and international organizations. The workshop agreed to 16 response measures that need to be taken up by the region with support from regional and international organizations in response to the Aichi Target. The workshop report and the Arab regional statement for action on the 2020 biodiversity targets, funding strategies and innovative financial mechanisms are available on the website. A web-based publication "Arab Digest on Biodiversity and Finance" will be available shortly.
- 183. The eighth Plenary Meeting of the Leading Group on Innovative Financing for Development was held in Tokyo from 16-17 December 2010. The meeting explored a wide range of innovative funding instruments for many sectors. A web-based publication "Mission Note on Innovative Financing for Development" is being prepared in response to the strategic objective 4.5 of the strategy for resource mobilization.
- 184. The meeting with Conservation International discussed potential opportunities for advancing the funding needs assessment that was requested by the tenth meeting of the Conference of the Parties.
- 185. The planning for next year regional/subregional workshops on Aichi targets, funding strategies and innovative financial mechanisms are under advance stage.
- 186. The website for financial resources and the financial mechanism is being revamped in light of the strategy for resource mobilization for biodiversity and will be made available shortly. Substantial new information has been compiled and added.

Biodiversity for Development Initiative

187. During the third and fourth quarters of 2010, the activities related to the Biodiversity for Development Initiative were, as follows:

A. Production of documents

- 188. A final version of the best practice guide for mainstreaming biodiversity and ecosystem services into planning and financing has been finalized in form of a booklet and a power point presentation.
- 189. The report "Linking the Thematic Programmes of Work of the Convention on Biological Diversity to Poverty Reduction and Development (136 p)" was finalized and printed.
- 190. Two new Technical Series documents were finalized and printed, and presented during side events at COP 10:
 - CBD TS N° 54 Interdependence of Biodiversity and Development Under Global Change (224 p)

- CBD TS N° 55 Linking the Thematic Programmes of Work of the Convention on Biological Diversity to Poverty Reduction and Development (136 p)
- 191. The four "Good Practices Guides" on tourism, drinking water, forestry and pastoralism were translated in some of the UN languages (English, French, Spanish, and Arabic) and printed.
- 192. To facilitate the diffusion and dissemination of those documents the Secretariat produced a toolbox and a CD, called "Biodiversity for Development: new approaches for national biodiversity strategies", bringing together all the documents of the "Biodiversity for Development Initiative" and the first three training modules for new NBSAPs. This toolbox was launched and disseminated during COP-10.

B. Meetings

- 193. The Secretariat organized, with the Japanese International Cooperation Agency (JICA), the High Level Forum on Biodiversity in Development Cooperation in Nagoya, Japan during COP-10. The main outcome of this forum was the Nagoya declaration on Biodiversity in Development Cooperation.
- 194. The Secretariat organized, with the Government of Gabon and UNEP, the first Pan-African Conference on Biodiversity and Poverty Alleviation: What Opportunities for Africa?, held in Libreville, Gabon (12-17 September 2010) with a two-day Ministerial meeting. The main outcomes of this high level meeting were the Libreville Declaration on Biodiversity and Poverty Alleviation in Africa; a common position for COP-10, a road map for a Pan-African committee for the ipBes, a road map for a green economy in Africa.
- 195. The Secretariat facilitated the day on Biodiversity and Development at the Ecosystem Pavilion during COP-10 organized with UNDP.
- 196. The Secretariat attended the regional meeting on the follow-up of the Action Plan of the regional strategy of SADC on Biodiversity, which took place in Johannesburg, on 8-9 September 2010.
- 197. The CBD Secretariat was represented at the conference "La nature a-t-elle sa place en éducation? Pour une pédagogie de la biodiversité!" in Montreal on 4 November 2010, and at the first annual symposium of the Québec Center for Biodiversity Science from 30 November to 2 December 2010.

C. Follow up activities

- 198. Collaboration continued with the GEF-Small Grant Programme and UNEP-Equator Initiative on the development of the website "Biodiversity and Local Livelihoods".
- 199. The Secretariat contributed to the Guide for Negotiators for the COP-10 co-produced by OIF, Institut EDS, Université Laval, IEPF.

Other activities

200. During this last quarter of 2010, the joint ICT Unit of the CBD Secretariat has been developing a new meeting registration tool in order to cope with the ever growing participants to its meetings. The main project's aims were to allow participants from governments and organizations to register online on the CBD website prior to the meeting and to ensure a smooth on site badge emission thanks to the "priority pass" system.

- 201. The new registration system reduces tremendously the burden on the SCBD staff that did not have to enter participants manually as it used to be in past meetings. Furthermore, the "priority passes" that were sent individually to pre-registered participants allowed them to receive their personal badges in less than a couple of minutes. A secure barcode system was also implemented to ensure validity of badges at each security points.
- 202. The joint ICT unit will continue improving this already successful project in the coming months, sharing its experiences with partner organizations like UNFCCC and other large meetings organizers.
- 203. The Secretariat of the CBD has started using a web meeting software to organize online conferences and courses to partners and public. A first well attended online course (webinar) on REDD biodiversity benefits was organized by the CBD Secretariat on 15 November 2010, to provide an update on recent developments in the negotiations under the UNFCCC, as well as on ways and means to enhance biodiversity benefits of REDD. Α recording of the webinar is available http://www.cbd.int/forest/redd/webinar/2010-11-15/.
- 204. Apart from the immediate benefit of being able to reach more stakeholders and allow a better information sharing, online conference tools is also a more economical and environmental friendly way of meeting the growing community of members and actors of the biodiversity conservation community. Based on the strong interest, the Secretariat will offer further webinars and conferences on different biodiversity related topics in the near future.

BIOSAFETY

THE CARTAGENA PROTOCOL ON BIOSAFETY

III. IMPLEMENTATION OF THE DECISIONS OF THE CONFERENCE OF THE PARTIES SERVING AS THE MEETING OF THE PARTIES TO THE PROTOCOL

Decisions BS-II/2 and BS-IV/2: Operation and Activities of the Biosafety Clearing House (BCH)

- 205. During the reporting period, the Secretariat, in collaboration with and support of the UNEP-GEF Biosafety Project, convened a training workshop for National Focal Points for the Biosafety Clearing-House (BCH-NFPs) from 8 to 9 October 2010, in Nagoya, Japan. More than 30 participants received comprehensive training in the general navigation of the BCH and management of national records.
- 206. The Secretariat also launched the offline version of the common formats in the six official languages of the United Nations. The offline common formats aim to assist BCH users to gather and organize information prior to its submission online. They are available in the "Registering Information" and the "Resources" sections of the BCH. The launch of the offline version concluded the translation of the entire Management Centre of the BCH.
- 207. In September 2010, the Secretariat also launched the LMO Quick-links on the BCH. The LMO Quick-links are small image files, which can be easily copied and pasted, that identify an LMO through its unique identifier, trade name and a link to the BCH where information on the LMO is available (e.g. LMO characteristics, countries' decisions, risk assessments, etc.). The LMO Quick-links can be easily accessed by either scanning the barcode or by typing the URL in a web browser.

Decision BS-IV/1: Compliance Committee

208. The seventh meeting of the Compliance Committee under the Cartagena Protocol on Biosafety took place in Montreal from 8 to 10 September 2010. The Committee continued discussions of items that it examined at its previous meeting relating to national reporting rates and status of compliance in fulfilling obligations to make information available to the BCH. It also considered the views submitted by Parties on how to improve the supportive role of the Committee. The Committee finalized its recommendations and report for submission to the fifth meeting of the COP-MOP.

Decisions BS-II/9 and BS-IV/11: Risk Assessment and Risk Management

209. Pursuant to paragraph 12 of COP-MOP decision BS-IV/11, the Pacific Subregional Workshop on Capacity-building and Exchange of Experiences on Risk Assessment and Risk Management of Living Modified Organisms was held in Nadi, Fiji, from 5 to 7 July 2010. It was made possible following an offer from the Government of Fiji to host the workshop and the generous financial contributions from the Governments of the Netherlands, Norway and Spain. Twelve participants, including 11 Governments and 1 organization attended the workshop. The workshop focussed on how to conduct a risk assessment in the context of the Cartagena Protocol on Biosafety; the general framework in which the risk assessment has to be conducted and how to establish an interdisciplinary teamwork for risk assessment. With the help of a case study on risk assessment, participants took part in a hands-on group exercise to put into practice some of the concepts learnt and discussed how risk assessors may communicate the outcomes of a risk assessment in a structured report so as to provide relevant information and recommendations to decision makers. Decision BS-IV/12: Liability and Redress

210. The Secretariat organised and serviced the fourth meeting of the Group of the Friends of the Co-Chairs on Liability and Redress in the Context of the Cartagena Protocol on Biosafety, which took place from 6 to 11 October 2010, in Nagoya, Japan. It was initially planned to be a three day meeting (6 8 October 2010). However, more time was needed to resolve the outstanding issues prior to the opening of COP-MOP 5, and thus the meeting was extended. The Group concluded its work at 2 a.m. on 11 October 2011, just eight hours before the opening of COP-MOP 5. The Group agreed to name the Protocol after the cities of Nagoya where it is adopted, and Kuala Lumpur, the city where the first mandate to negotiate international rules and procedures on liability and redress was adopted by the decision of the first meeting of COP-MOP and two of the meetings of the Group of Friends of the Co-Chairs were held. Accordingly, the Group submitted to COP-MOP 5 the Nagoya – Kuala Lumpur Supplementary Protocol on Liability and Redress to the Cartagena Protocol on Biosafety, together with a draft decision for its consideration and adoption. The report of the Group is available as document UNEP/CBD/BS/GF-L&R/4/3.

Decision BS-IV/17: Public Awareness, Education and Participation

- 211. During the reporting period, the Secretariat advanced the implementation of the outreach strategy (2008-2012) to promote public awareness, education and participation and celebrations of the International Year on Biodiversity (IYB). In particular, the Secretariat:
- (a) Co-organized a joint Aarhus Convention/Cartagena Protocol on Biosafety workshop on public awareness, access to information and participation regarding living modified organisms/genetically modified organisms (LMOs/GMOs), which was held in Nagoya, Japan, from 8 to 9 October 2010,

- immediately before COP-MOP 5. More than 50 participants attended the workshop. The participants shared knowledge, experiences and lessons learned regarding public awareness, access to information and public participation and developed recommendations on the programme of work on public awareness, education and participation concerning LMOs.
- (b) Organized a fair on national experiences with the implementation of the Cartagena Protocol on Biosafety during COP-MOP 5 in Nagoya, Japan from 11 to 15 October 2010. Several delegates attended the fair and a number of countries showcased their national experiences, good practices and lessons learned with regard to different issues.
- (c) Made presentation to students at the Graduate School of International Cooperation Studies, the Kobe University in Japan in October. The theme of the event was: "Outcomes from the fifth meeting of the Conference of the Parties serving as the meeting of the Parties to the Cartagena Protocol on Biosafety: Achievements and Outstanding Issues".

Status of Ratification or Accession to the Protocol

212. As of 1 December 2010, 160 countries have ratified or acceded to the Protocol. The list of these Parties is available on the website at: http://bch.cbd.int/protocol/parties/.

ANNEX II

Status of Implementation of the Agreed Administrative Arrangements

I <u>Personnel Arrangements</u>

1. During the reporting period, the Secretariat had 33 regularized Professional staff members and 27 regularized General Service staff members funded from the core budget. There were 4 Professional posts and 1 General Services vacant post for which recruitment/selection is in progress. Additionally, 5 professional posts and 11 General Service posts were funded from other sources. For more information, please refer to the attached staff list and organigram (Appendix 1 and Annex II respectively).

II <u>Contributions and Funds</u>

- 2. During the third and fourth quarters of 2010, twenty-five new pledges of additional voluntary funds in support of approved activities under the Convention (BE Trust Fund) were recorded. Belgium pledged: EUR30,000 for the development of a TEMATEA module on forests, EUR27,120 towards the Ecosystems and Climate Change Pavilion and EUR30,000 towards the Programme of Work on Protected Areas; EU pledged EUR100,500 towards the Ecosystems and Climate Change Pavilion at COP 10; France pledged: EUR9,307.50 for the translation of CBD Technical Series # 46, in French and EUR35,000 towards the Publication of the Libreville Conference, the support on Biodiversity and Poverty Alleviation and the participation of 3 persons to the Biodiversity and Local Authorities Meeting; Germany pledged: EUR60,000 towards the Forest Biodiversity Workshops, EUR30,000 towards the Marine Protected Areas and Climate Change E-Learning modules and EUR96,538 for the EBSA Activities; IBRD pledged US\$3,000 for the reception costs during the International Biodiversity Day; ICEI pledged US\$5,000, IUCN pledged US\$35,000 and UNDP pledged US\$50,000, towards the Ecosystems and Climate Change Pavilion at COP 10; Japan pledged: US\$621,285 towards the 'Japan Fund for CBD', US\$1,083,212 as Additional Costs for COP 10 and US\$350,000 to assist participation of parties in Meetings related to COP 10; Korea, Republic of, pledged US\$274,588 for a Programme Officer - South South Cooperation; Luxembourg pledged EUR10,000 and Switzerland pledged US\$10,000, for the PoWPA E-Learning modules; Norway pledged: NOK320,000 to support the Information Activities by the Convention and NOK290,000 towards the development of a TEMATEA module on forests; Canada pledged CAD275,000 and Spain pledged EUR1,000,000, as Approved Activities of the Convention; UK pledged GBP60,000 towards the Asia-Pacific Regional Workshop on Reducing Emissions from Deforestation and Forest Degradation and World Future Council pledged EUR6,000 to support the Future Policy Award Ceremony.
- 3. For 2010 a total of US\$6,942,622 has been pledged to the BE Trust Fund, of which US\$6,511,364 or 94% has been collected as at 31 December 2010. Full details of the pledges and contributions to the BE Trust Fund are reflected in Annex IV.
- 4. The total amount pledged for the **BY Trust Fund** in 2010 is US\$11,453,478. Of this amount, US\$11,083,768 or 97% has been received as at 31 December 2010. A total of US\$569,240 has also been collected in 2010 as advance payments for 2011 and future years. Additionally, US\$903,800 has been pledged and has been collected, as additional contributions to the BY Trust Fund for 2010. US\$1,168,842 has also been collected in 2010 for prior years. Full details of the pledges and contributions to the BY Trust Fund are reflected in Annex VI.

- 5. As at 31 December 2010, US\$2,023,756 has been pledged for 2010 as additional voluntary contributions to facilitate the Participation of Parties in the Convention process (**BZ Trust Fund**). Full details of the pledges and contributions to the BZ Trust Fund are reflected in Annex V.
- 6. As at 31 December 2010, contributions to the BZ Trust Fund in 2010 amounted to US\$2,023,756 or 100% of the total pledged for 2010. A total of US\$162,138 remains outstanding for the BZ Trust Fund for prior years. Full details of the pledges and contributions to the BZ Trust Fund are reflected in Annex V.
- 7. As at 31 December 2010, a total of ninety eight (98) countries have paid US\$2,300,426 to the **BG Trust Fund**, representing 96% of pledges for 2010. A total of US\$473,809 has also been collected in 2010 as advance payments for 2011 and future years. US\$86,603 has also been collected in 2010 for prior years. Full details of the pledges and contributions to the BG Trust Fund are reflected in Annex VII.
- 8. As at 31 December 2010, four Parties have pledged and/or contributed to the Special Voluntary Trust Fund for Additional voluntary Contributions in Support of Approved Activities of the Cartagena Protocol on Biosafety, (**BH Trust Fund**). To date US\$682,401 has been received in 2010 for 2010 and future years. Full details of the pledges and contributions to the BH Trust Fund are reflected in Annex VIII.
- 9. As at 31 December 2010, the Governments of Finland, Norway and Sweden have pledged a total of US\$117,102 to the Special Voluntary Trust Fund for Facilitating Participation of Developing Country Parties in the Cartagena Protocol on Biosafety, (**BI Trust Fund**). The total amount pledged or 100% has been collected. Full details of the pledges and contributions to the BI Trust Fund are reflected in Annex IX.
- 10. As at 31 December 2010 pledges have been received, from the following donors, to the General Trust Fund for Voluntary Contributions to facilitate the Participation of Indigenous and Local Communities in the Work of the Convention on Biological Diversity (**VB Trust Fund**): Japan (US\$50,000) and Norway (NOK200,000). The total amount pledged or 100% has been collected. Full details of the pledges and contributions to the VB Trust Fund are reflected in Annex X.

III Accounting and Reporting

Status of Expenditure

- 11. COP-9 approved a budget of US\$12,355,100 for the BY Trust Fund for 2010. As at 31 December 2010, a total of US\$12,361,231 was spent or committed. This represents 100% of the approved amount.
- 12. COP/MOP-4 approved a budget of US\$2,880,900 for the BG Trust Fund for 2010. As at 31 December 2010, a total of US\$3,001,162 has so far been spent or committed. This represents 104% of the approved amount.

13. 



Organizational Chart of the CBD Secretariat


