MINUTES OF THE XIIth MONTHLY REVIEW MEETING CHAIRED BY SHRI RAM MUIVAH, IAS, PRINCIPAL SECRETARY (WORKS), GOVT. OF MANIPUR HELD ON 5th DECEMBER, 2011 AT 12.30 P.M. AT CONFERENCE HALL, OLD SECRETARIAT.

2.0. Principal Secretary (Works), Govt. of Manipur welcomed all members present and initiated the discussion. At the outset, he expressed happiness regarding the smooth and successful inauguration of the following mega projects of PWD by the Hon'ble Prime Minister of India, Dr. Manmohan Singh and Smt. Sonia Gandhi, Chairperson UPA on 3rd December, 2011:

- a). New Assembly Hall.
- b). New High Court.
- c). City Convention Centre and
- d). ISBT (Inter State Bus Terminus).

2.1. He expressed deep appreciation to all the PWD Engineers who were responsible for the construction of the above mega projects sometime beyond the call of duty namely : (a) Shri M. Lokendro Singh, Chief Engineer (PWD), (b) Shri M. Theimon Singh, CE (M & E), PWD, (c) Shri Pradeep Kumar Mukherjee, ACE (d) Shri Subhash Singh, SE (e) Shri Kumar Singh, SE (Elect) (f) Shri Robindro Singh, SE, (g) Shri Randhir Singh, EE (BD- I) (h) Shri Rajen Singh, EE (Elect) (i) Shri Brojen Singh, EE, PWD, Manipur.

2.2. Principal Secretary also expressed appreciation to Messrs. **Ng. Manglemjao, SE, N. Joychandra, EE (I/E)** and **Prem Kumar, EE/NH-I** for successfully arranging of over 30,000 (thirty thousand) chairs at Kangla and barricades along the VVIP routes in Imphal City within short notice in connection with the visit of Hon'ble Prime Minister on 3rd December, 2011.

2.3. It was decided to place on record the deep appreciation of the State Government and extend financial benefit to the above Engineers as a mark of recognition as per rule under FR.

- **3.3. CDA** : It was reported that many CDA proposals are Pended in FD. All such matters pending with FD for over 2(two) weeks should be reported to Chief Secretary. It was further reported that FD has deducted 11.5% while releasing CDA for PWD as agency charges though agency charges were not provided in the case of ISBT by NEC and construction of roads under BADP i.e, Kamjong to Konkan Thana in Ukhrul District etc. For deposit works, agency charges were deducted as source and FD again had deducted the same when CDA was released. Such excess deductions will eat into funds for works and PWD would be unable to submit full VCS. The matter is to be taken up suitably with FD.
