## New Year's Message, 2012

## Dear APPA Members,

2011 was an excellent year for APPA. First and foremost, our critical mass of renewing members and journal subscribers, along with many new members and subscribers, enabled our Association to continue thriving.

Philosophical practice received renewed media attention this year as well, with a feature in the *Washington Post*, and public radio broadcasts in the US, Canada, and abroad. APPA members and practitioners remain in the forefront of the global movement.

APPA enjoyed a wonderful Annual Meeting and dinner in June, and conducted a fully-subscribed Certification program in August.

Our Journal, *Philosophical Practice*, also had a banner year. We once again published three excellent issues on schedule (volume 6.1 in March, 6.2 in July, 6.3 in November), bringing our cumulative output to 18 issues -- a significant contribution to the literature in the field.

And during 2011, APPA successfully negotiated an important distribution contract with EBSCO, a leading distributor of serial scholarly publications. *Philosophical Practice* will be carried on EBSCO's flagship citation database, into more than 17,500 university libraries and research institutions world-wide.

This means that every article and book review published in our Journal will be searchable in EBSCO's database -- by author, title, subject, and keywords. Our Journal and its contributors therefore stand to gain considerable exposure, and citations, in the coming years. By the same token, APPA also stands to gain more members, subscribers, and contributors as well. It's a win-win-win scenario.

None of this would be possible without the fine work of our editorial team, including Nancy Matchett (Reviews Editor), Kate Mehuron (Managing Editor), Greg Goode (Technical Consultant), and Thomas Griffith (Legal Consultant). And of course we also rely on our editorial boards, referees, and contributors. I urge you all to redouble your commitments in the coming years, so that *Philosophical Practice: Journal of the APPA* will continue to flourish.

That said, Kate Mehuron now faces other pressing duties, and must relinquish her position as Managing Editor. She has done a great job for two years and six issues; we will miss her, and we wish her well.

## Looking Ahead, 2012

Anticipating growing demand in Hispanic countries, APPA is planning to publish a Spanish-language edition of our Journal -- *Filosofia Practica: Revista de la APPA*. To that end, we have a preliminary editorial team in place. The Editor-in-Chief will be Jose Barrientos Rastrojo (Spain); the Managing Editor, Francisco Iracheta (Mexico); the Reviews Editor, Giselle Monges (Argentina). We will keep you informed as this project moves forward.

The 11th International Conference on Philosophical Practice is being organized by Prof. Young E. Rhee and other South Korean practitioners, in conjunction with Taiwanese and Japanese colleagues, and will be held at Kangwon National University, Chuncheon, Korea, from July 16-19, 2012. Upcoming New York events in 2012: APPA will hold its annual meeting in June (date to be announced), and a Certification Program for philosophical counselors from August 10-12, 2012.
