- 2. If the official nomination letter has been received by the Secretariat, each delegate will receive a 'Priority Pass';
- 3. If the Secretariat has not yet received the official nomination letter, the status of each entered participant will be reflected as 'Pending Accreditation'. An individual 'Priority Pass' will be sent upon receipt of the official nomination letter;
- 4. Delegates should print and bring their "Priority Pass" to the meetings. The "Priority Pass" contains a bar-code which will facilitate on-site registration.
