# Donations to Political Parties Analysis 4th Quarter, 2011




# **Donation Trends**

We see a repeating trend of a dip in funding after each election year (2001, 2005, 2010), followed by increasing levels of donations. This effect was also echoed in 2007 when it was widely speculated an election would be called, with a dip following in 2008.

We also see that, over the last 11 years, Labour have been reliant on trade unions for 63% of their funding, the Conservatives have depended on individuals for 62% of theirs and the Lib Dems receive more of their funding from company donations than the other two major parties. Trade union funding is also less volatile from year to year, compared to individual and company donations.

Specifically in 2011, we saw:

- A substantial drop off in donations to major parties, after years of generally increasing donation levels, driven by Conservative donations
- A major decrease in levels of funding from individuals and companies, a minor decrease in trade union funding, and a major increase in funding from trust funds
- A far more significant dip after an election year than in 2005
- Trade unions' share of Labour donations rise to 84%, the highest level since records began in 2001



- **Peter Cruddas** is the founder and owner of internet securities dealer CMC Markets and is also the Co-Treasurer of the Conservative Party

**Long Term Donor Alert: Stanley Fink** (Donated £70,751.26 this quarter) Mr Fink is a hedge fund manager, Treasurer of the Conservative Party since 2010 and a member of the House of Lords since 2011. This donation brought his total donated to the Conservatives and its MPs to £2,652,392.26, spread over 29 donations, the first occurring in 2004.

#### **Conservative Donation Trends**

- Over the last 11 years, the Conservatives have been dependent on donations from individuals for a majority of their funding, with companies and unincorporated associations also playing a significant role
- The last quarter of 2011 confirms a massive decline in Conservative donations, less than half of what they received in 2010
- Prior to this, there was an increasing overall trend for total donations after the 2001 election year until the election year of 2010, which saw the Conservatives form a government with the Liberal Democrats



- **UNISON** is Britain's biggest public sector union with more than 1.3 million members and Labour's second largest donor since 2001
- **David Sainsbury** is the former Chairman of his family's supermarket business Sainsbury's, and former Science and Innovation Minister. He has been a member of the House of Lords since 1997, is the Chancellor of Cambridge University and is Labour's largest individual donor.

#### Long Term Donor Alert: William Haughey (Donated £17,700 this quarter)

Mr Haughey is a Scottish businessman, with an estimated worth of  $\pounds$ 50m. He is the owner and chairman of City Refrigeration Holdings Ltd, a facilities management company. This donation brought his total donated to Labour to  $\pounds$ 1,160,500, spread over 12 donations, the first occurring in 2001.

#### Labour Donation Trends

- Labour have been reliant on Trade Union funding each year, but in 2011 the Unions' share of Labour donations rose to 84%, the highest trade union share yet, as their donations have remained largely consistent but individual donations have dipped to less than a seventh of 2010 levels
- 2011 represented a large decline in Labour donations, but not to the same extent as the Conservatives




# Lib Dem Donors Q4, 2011 – Total Donations £1,090,186.93

- **Ministry of Sound Ltd** is a entertainment business specialising on recorded music, night clubs and consumer electronics
- There is very little information publically available on the internet on the **Methuen Liberal Trust Fund**, though it appears that Liberal Democrat peers Lord John Alderdice and Lord Paul Tyler are trustees

#### **Liberal Democrats Donation Trends**

- The Lib Dems have relied more on company donations than either of the other main parties for all but 2 of the last 11 years
- With the exception of 2005, which included £2.4m of donations from convicted fraudster Michael Brown, donations largely tended to increase until 2010, when the party formed part of the government
- The Lib Dems experienced the smallest decrease from 2010 of any of the major parties, but this was mainly due to nearly £1,000,000 from the Methuen Liberal Trust Fund, which also drove an increase in the share of trust fund donations





### **Scottish National Party Donation Trends**

- Donation levels to the SNP prove to be somewhat volatile, with the party heavily dependent on inconsistent donations from individuals, though their peak levels of donations do correspond with the Scottish Parliament elections in 2003, 2007 and 2011
- They received only £80,662.98 in this quarter, over half of which was from their only donation over £10,000
- This is compared to a total of £2,027,168.80 from the previous quarter, mainly thanks to £1,000,000 from lottery winners Colin and Christine Weir, and over £900,000 left to them in the will of the late Scottish poet Edwin Morgan
- These donations also created a total for 2011 that dwarfs figures from other years, nearly 4 times the donations they received in the three years before

- 2. Analysis of individual donors refers to donations of £10,000 and over only and includes donations to regulated donees such as party MPs and associated organisations.
- 3. Analysis of total donations to parties refers to donations of all value, though not to regulated donees. This includes total party donations per quarter.
- 4. Trade Union totals include donations from predecessor organisations.
- 5. Annual donation totals are adjusted according to CPI inflation.
