



## Call for contributions to [square brackets]

## Submissions due 2 April 2012

[square brackets] is a newsletter produced jointly by the Secretariat of the Convention on Biological Diversity (SCBD) (<u>www.cbd.int</u>) and the CBD Alliance (<u>www.cbdalliance.org</u>).

The newsletter aims to facilitate timely dialogue among civil society stakeholders on cutting edge biodiversity issues, from both policy (advocacy and decision-making) and practical (implementation) perspectives. The 5<sup>th</sup> edition was published in June 2011 (<u>www.cbd.int/ngo/square-brackets/square-brackets/square-brackets/square-brackets-2011-06-en.pdf</u>).

We invite short articles from members of civil society all over the world (including NGOs, social movements, indigenous organizations and representatives, local communities).

The new edition of [square brackets] will be published to coincide with the sixteenth meeting of the Subsidiary Body on Scientific, Technical and Technological Advice (30 April - 5 May, in Montreal) and the fourth meeting of the Ad Hoc Open-ended Working Group on Review of Implementation of the Convention (7 - 11 May, also in Montreal).

Specifically, we are interested in receiving articles on issues being addressed by SBSTTA 16 and WGRI 4, including:

- REDD+
- How to improve the effectiveness of SBSTTA; and collaboration with IPBES
- Strategic Plan for Biodiversity 2011-2020/Aichi Biodiversity Targets
- Integration of biodiversity into poverty eradication and development.

In addition, other issues of interest include implementing the CBD and The Economics of Ecosystems and Biodiversity (TEEB) study.

Articles will be selected and edited by an editorial board consisting of representatives of indigenous and non-governmental groups, and staff from the SCBD.

## Length: 700-800 words

**Topics**: We seek submissions that focus on targets that civil society will aim to implement nationally and the challenges or barriers they face in doing so.

**Photos**: Photos that are of publishable quality are most welcome. Please note that photos should be sent as image files and not placed in Word documents. They can be sent as jpeg, tiff, or psd. Photos should be sent in the largest size available; please do not reduce the size of images before sending.

**Tone**: Articles must be written in a constructive and analytical manner and contribute to a deeper understanding of the issue. Contributions must not identify or target particular Parties on issues under negotiation. Opinions are more than welcome, but total coverage of topics in the newsletter will aim to present diverse and balanced viewpoints and arguments that enable the readers to formulate their own informed opinions.
