
Significant inroads are being achieved each day though hard work remains before us every single moment. Our ground game with grassroots support is paramount to total victory in November.

April 2008 - Obama speaks disrespectfully of Christians, saying they "cling to guns or religion" and have an "antipathy to people who aren't like them."

February 2009 - Obama announces plans to revoke conscience protection for health workers who refuse to participate in medical activities that go against their beliefs, and fully implements the plan in February 2011.<sup>2</sup>

April 2009 – When speaking at Georgetown University, Obama orders that a monogram symbolizing Jesus' name be covered when he is making his speech. 3

May 2009 – Obama declines to host services for the National Prayer Day (a day established by federal law) at the White House. 4

April 2009 – In a deliberate act of disrespect, Obama nominated three pro-abortion ambassadors to the Vatican; of course, the pro-life Vatican rejected all three. 5

October 19, 2010 – Obama begins deliberately omitting the phrase about "the Creator" when quoting the Declaration of Independence an omission he has made on no less than seven occasions. 6

November 2010 - Obama misquotes the National Motto, saying it is "E pluribus unum" rather than "In God We Trust" as established by federal law.

January 2011 – After a federal law was passed to transfer a WWI Memorial in the Mojave Desert to private ownership, the U.S. Supreme Court ruled that the cross in the memorial could continue to stand, but the Obama administration refused to allow the land to

be transferred as required by law, and refused to allow the cross to be re-erected as ordered by the Court. 8

February 2011 - Although he filled posts in the State Department, for more than two years Obama did not fill the post of religious freedom ambassador, an official that works against religious persecution across the world; he filled it only after heavy pressure from the public and from Congress. 9

April 2011 – For the first time in American history, Obama urges passage of a non-discrimination law that does not contain hiring protections for religious groups, forcing religious organizations to hire according to federal mandates without regard to the dictates of their own faith, thus eliminating conscience protection in hiring. 10

August 2011 - The Obama administration releases its new health care rules that override religious conscience protections for medical workers in the areas of abortion

11 November 2011 -Obama opposes inclusion of President Franklin Roosevelt's famous D-Dav Praver in the WWII Memorial.

12 November 2011 -Unlike previous presidents, Obama studiously avoids any religious refer-

February 2012 - The Army orders Catholic chaplains not to read a letter to parishioners that their archbishop asked them to read. 25

# Rallying Against the Living Wage: UVa Conservatives Thwart Leftist Initiative by Peter A. Finocchio

ast month, Living Wage protestors at the University of Virginia went on a "hunger strike" in an attempt to garner attention and support for their demand of a "living wage" for all University employees. The "Wagers" used a lot of emotional rhetoric, painting University employees as hungry underpaid vic-



tims and anyone opposing their demands as immoral and heartless. Relentless ad homonyms were levied not just against conservative critics.

but also against our entire student government, University administration, and even our very own University President, Theresa Sullivan, who was accused of being deliberately dishonest about the living wage. In reality, it was the Living Wage Movement that was being dishonest about the living wage, whether or not it was deliberate.

The problem with implementing a "living wage" is twofold. First, despite economically soundless claims to the contrary, forcing salaries up also forces unemployment up. Seventy-nine percent of economists agree on this. Not a single professor in UVa's Commerce School or Economics Department signed on to the Living Wage's faculty petition. A "living wage" would result not in the firing of prominent professors, but in the letting go of a significant number of the University's unskilled workers- the very people Living Wage advocates set out to help. Moreover, greater costs to the University are inevitably transferred to students. Northwestern University testified that "the additional annual cost in room and board rates for those living in residence halls" as a result of a living wage mandate "would be at least \$1,000" per student, plus

higher tuition. Living Wage protestors at UVa touted our University's large endowment as proof that UVa could afford to implement the policy without additional costs to anyone, but they failed to understand that most of the University endowment is earmarked for specific long-term purposes and cannot be spent on employee salaries or benefits. Like other liberal idealists, the Living Wage enthusiasts refuse to acknowledge that their policies come at a price.

A few weeks ago the Living Wage Movement attempted to have our Student Council pass a resolution stating that the Council was in full support of the protestors and their goals. They thought the resolution would pass without question, but by combating vitriol with facts, a small handful of conservative students managed to block its passage. The debate lasted two meetings. At the conclusion of the first meeting, the resolution was tabled by the Council, to be picked up again the following week. At the end of the second meeting, when the resolution's defeat was imminent, its sponsor withdrew it, rather than take the greater defeat of total failure.

Standard procedure for our Student Council's representative body is to table a resolution the week it is introduced for the first time, so that it is not rushed through and so that student representatives have ample time to do their own research on the issue and gauge the opinion of the student body. However, the Living Wage supporters thought that their special cause deserved exemption from the rules, and were, to use a word one of them was fond of saying at the meeting, "appalled" when they didn't get their way. During the week between tabling and defeat, Living Wage supporters did their cause no help by lambasting the very body whose support they would need if they hoped for their resolution to pass. A shameful opinion piece by one Living Wage activist in our University's main student publication, the Cavalier Daily, accused our Student Council of corruption and immorality

(http://www.cavalierdaily.com/20 12/02/22/broken-leadership/). My rebuttal, warmly received by the Student Council and published conveniently one day before the final vote on the resolution, can be found at this address (http://www.cavalierdaily.com/20 12/02/27/if-it-ain%E2%80%99tbroke/). I recently wrote a blog for UVa's rising new right-leaning student publication, the Virginia Advocate, summarizing and explaining the resolution's defeat (http://virginiaadvocate.wordpress .com/2012/03/06/conservativevictory-studco-style/). There have been several other blogs in the Virginia Advocate addressing the Living Wage from a rightward angle, and first-year student Wendy Morrison wrote an excellent "Smithian Appraisal" of the Living Wage in the March issue of our magazine (http://virginiaadvocate.files.word press.com/2011/09/vaadvocateissue-two.pdf). The Virginia Advo-

issue-two.pdf). The Virginia Advocate is nonpartisan and does not aim to influence public policy; it exists as a forum for those ideas and issues directly pertaining to the University which are not always addressed in the more dominant student newspaper.

The Living Wage wanted their resolution rushed through at the first meeting so that when the Board of Visitors met the next day, the Living Wage protestors could claim that the voice of the students was on their side. Undoubtedly they were surprised to encounter any opposition at all. A few years earlier, a previous Student Council unanimously passed a resolution in support of the Dream Act. Why didn't this liberal initiative follow the same trajectory as its predecessors? The reason is quite simple. Conservatives spoke out this time. We may not be the majority at our University, but when we engage in the conversation, when we talk to our fellow students, when we have even just a handful of conservatives on our student government, we are able to win the day. And that is exactly how the Student Council Living Wage Resolution was defeated here at Mr. Jefferson's University. 🖈


Therefore Winning from the right will unravel the left and we shall retain our sovereignty, as it should be, as it will be for We the people.







#### The result of the weak recovery is a huge gap between where the economy should be, in terms of growth, and where it is. (via <u>The Wall Street Journal</u>)
