I advised him that staff would present the proposed budget today and that UR would not be the recommended source of SYEP funding. I also said the City recognized that more funds are required to fully implement the Bristol plan. Martel thanked me for the information and I thanked him for calling me.

It was a cordial conversation; I'm sharing this only because others may have received incorrect information as well. We might want to point out in our presentations later today that no UR funding is proposed for SYEP.

Here is the information that answers the question Terry asked of Richard regarding CDBG funded infrastructure in Bristol Place:

Staff reviewed the Consolidated Annual Performance Evaluation Reports (CAPERS), prepared for the U.S. Department of Housing and Urban Development regarding CDBG funding (FY 2000/01 through FY 2010/11). These detailed annual reports also included some historical information reflecting CDBG-funded activities going back to FY 1995. During this period, the only CDBG-funded infrastructure in Bristol Park identified was for \$15,000 for the purpose of Bristol Park (located along Market Street) in FY 2000/01.







Staff reviewed the Consolidated Annual Performance Evaluation Reports (CAPERS), prepared for the U.S. Department of Housing and Urban Development regarding CDBG funding (FY 2000/01 through FY 2010/11). These detailed annual reports also included some historical information reflecting CDBG-funded activities going back to FY 1995. During this period, the only CDBG-funded infrastructure in Bristol Park identified was for \$15,000 for the purpose of Bristol Park (located along Market Street) in FY 2000/01.
