Esther,

Sorry, I did not see the updated survey results until after I responded to you yesterday (I was away from my office all day in meetings). I am attaching those now.

Stacey Tutt announced that you did send her some questions, so she shared those with the committee last night and these were discussed. The group agreed to move fixed-income tenants that are paying low rent to a higher priority status for receiving Section 8, along with those that will be seeking Section 8 homeownership vouchers.

We share the same goal of not harming the families that we are relocating. We will continue to work towards this goal and I believe we can make a positive impact in their lives through not just relocation financial assistance, but the entire process that we are developing, such as the family resource center. We are working to provide assistance to families that may not be accessible to them currently.

> FAMILY SERVICES CENTER

> The City of Champaign, in partnership with the Bristol Park Neighborhood
> Steering Committee, is committed to ensuring all households are
> adequately supported throughout the relocation process and are provided
> economic opportunities and case management in areas that may include:

- > • Relocation services
- > • Budget, credit and debt management counseling
- > • Job training and skills assessment
- > • Adult education programs
- > • Family, senior and youth services
- > • Social Services
- > • Computer lab with broadband access

> The success of the relocation plan and new neighborhood development will
> depend on the successful partnerships between the City, Bristol Park
> Neighborhood Steering Committee members, and other local service
> providers. This will require formalizing multiple partnerships through
> memorandums of understanding with an anchor institution within the
> Bristol Place neighborhood.

> Relocation Assistance to Eligible Homeowners in Bristol Place
> Neighborhood:

>

> 1. Increase in Property Taxes for Homes Purchased within the City
> of Champaign.

>

> a. Seniors or Persons with Disabilities. Homeowners currently
> receiving either social security or social security insurance (SS or
> SSI) will be considered eligible as a "senior or persons with
> disabilities" household. This will policy will address the burden of a
> potential increase in property taxes.

>

> Calculating the burden of increased property taxes will be based on two
> of three unit scenarios. First, the current real estate taxes on the
> "leave unit" (which is the existing unit the homeowner owns in

> Bristol Place) will be deducted from the lessor of the "comparable" (see
> Glossary) or "actual" unit (the unit that the homeowner actually
> purchases). If there is an increase in the property tax, this increase
> amount will be offered annually as a tax rebate to homeowners, for as
> long as they own and occupy the new unit. The payment will be based on
> a difference of the two properties at the time of application.

> Example 1 "Comparable Unit" is the "lessor of"

> Leave Unit \$50,000 \$646 (exemptions:
> senior, owner-occupied)

> Actual Unit \$85,000 n/a (use the
> lessor of comparable unit/actual unit)

> In this example (#1), the City would pay the \$745 annual property tax
> increase as long as the senior or person with a disability owned and
> lived in the home as their primary residence.

> Example 2 "Actual Unit" is the "lessor of"
> Type of Unit Current Assessed Value Current Property Tax Bill
> Leave Unit \$50,000 \$646
> (exemptions: senior, owner-occupied)
> Comparable Unit \$80,000 n/a (use the
> lessor of comparable unit/actual unit)
> Actual Unit \$70,000 \$1,142
> (exemptions: senior, owner-occupied)

>
> In this example (#2), the City would pay the \$496 annual property tax
> increase as long as the senior or person with a disability owned and
> lived in the home as their primary residence.

>
> The owner would receive the initial rebate amount (\$745 in Example 1 or
> \$496 in Example 2) during the relocation process to pay for the first
> year of new taxes and then would begin receiving a rebate the following
> year of the same amount and every subsequent year that the owner owns
> and occupies the property.

>
> b. Non-Seniors/Persons without Disabilities. Homeowners not
> currently receiving either social security or social security insurance
> (SS or SSI) will be considered for this property tax payment for a
> period of three (3) years and will be calculated in the same manner as
> listed above for "Seniors and Persons with Disabilities". This will
> policy will address the burden of a potential increase in property
> taxes.

>
> c. Projected Annual Budget for the Property Tax Rebate Program.
> This program will be capped at \$25,000 per year. This figure is based
> on the following assumptions: all owner-occupied households in the
> Bristol Place neighborhood are wanting to remain as homeowners and the
> average assessed valuation difference is \$30,000. If the cost of the
> program should exceed this amount, the seniors and persons with
> disabilities will be prioritized. If any funding remains after the
> seniors and persons with disabilities receive their payment, then the

> remaining portion shall be equally divided amongst the remaining
> eligible homeowners.
>
> 2. Homeowners wanting to return to the new development. Efforts
> will be made to keep all homeowners desiring to remain in the new
> development in their home as long as possible.
>
> Relocation Assistance to Eligible Renters in Bristol Place Neighborhood:
>
> • Relocated tenants interested in returning to the newly developed
> neighborhood will be offered first right of refusal. The new renters
> will need to meet the development's tenant selection criteria for lease
> approval.
>

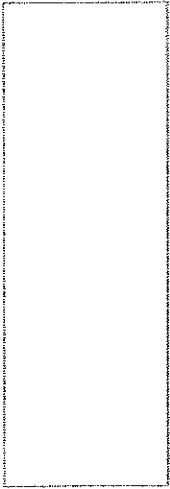

HUD officials are scrambling to stop the financial bleeding of the Section 8 housing voucher program after 18 public housing authorities (PHAs) reject administration of the program following a series of budget cuts. The predicament comes as the administration expands voucher assistance to accommodate families left homeless through foreclosures.

PHAs say cuts up to 25% of the amount needed to allocate vouchers and ensure their proper use force ceding the program to other agencies rather than further jeopardize their primary mission of providing quality public housing opportunities.

Cuts to capital funding alone amount to 33% over the past two years, and sources tell HAL that a probable 22% cut in all non-defense spending in January 2013 to help ease pressure on the national debt will further decimate public housing operations.

Continual cuts to Section 8 administrative fees worry PHAs the most now, considering the Obama administration is adding housing vouchers and Veterans Administration Supportive Housing (VASH) vouchers to its portfolio on a regular basis without increasing fees to administer them.

HUD officials remain largely mum on the depth of the problem, only acknowledging minimal details. A request from HAL for a list of the 18 PHAs rejecting further implementation of Section 8 was refused. HUD's Public Affairs Office will only say "the secretary's statements stand on their own," hinting that a Freedom of Information request may be necessary to obtain more complete information. Federal agencies under pressure from the media sometimes use this ploy to delay disclosure until a predicament subsides.

"Cutting administrative fees to the extent that PHAs are unable to sustain the leasing and utilization supported by the renewal funding ultimately defeats the purpose for which that renewal funding was appropriated," HUD's official statement says. "The department believes that the Housing Choice Voucher program is at substantial risk in 2012 of numerous PHAs 'turning in the keys' and giving up administration of the HCV program due to the severity of the 2012 cuts."

Noting that the process of transferring administration of programs that essentially are going out of business to other administering groups can be extremely disruptive to families and landlords in affected communities, HUD says: "For example, two PHAs (Akron and Milwaukee) turned down allocations of HUD-VASH vouchers, citing their inability to administer additional vouchers in light of the reductions in administrative fees.

"In the month of January alone, 13 PHAs have either had their programs transferred by HUD or have indicated they wish to have their programs transferred to other agencies, as these agencies have determined they are unable to sustain operations in the coming year with such a deep proration," the statement concludes.

HUD Secretary Shaun Donovan says in testimony before the House Appropriations Committee that five additional PHAs have joined the Section 8 exodus since January. But Donovan was unable to name the affected PHAs, and he tells the ranking Democrat on the HUD subcommittee, Rep. Jon Olver (D-MA), that a Section 8 administrative fee study will not be completed until 2014.

Timothy Kaiser, executive director of the Public Housing Authorities Directors Association, tells HAL that additional PHAs likely will refuse to administer the program rather than risk jeopardizing their core public housing mission. "There is a sense of urgency," Kaiser says. "The feds are not living up to their commitment."

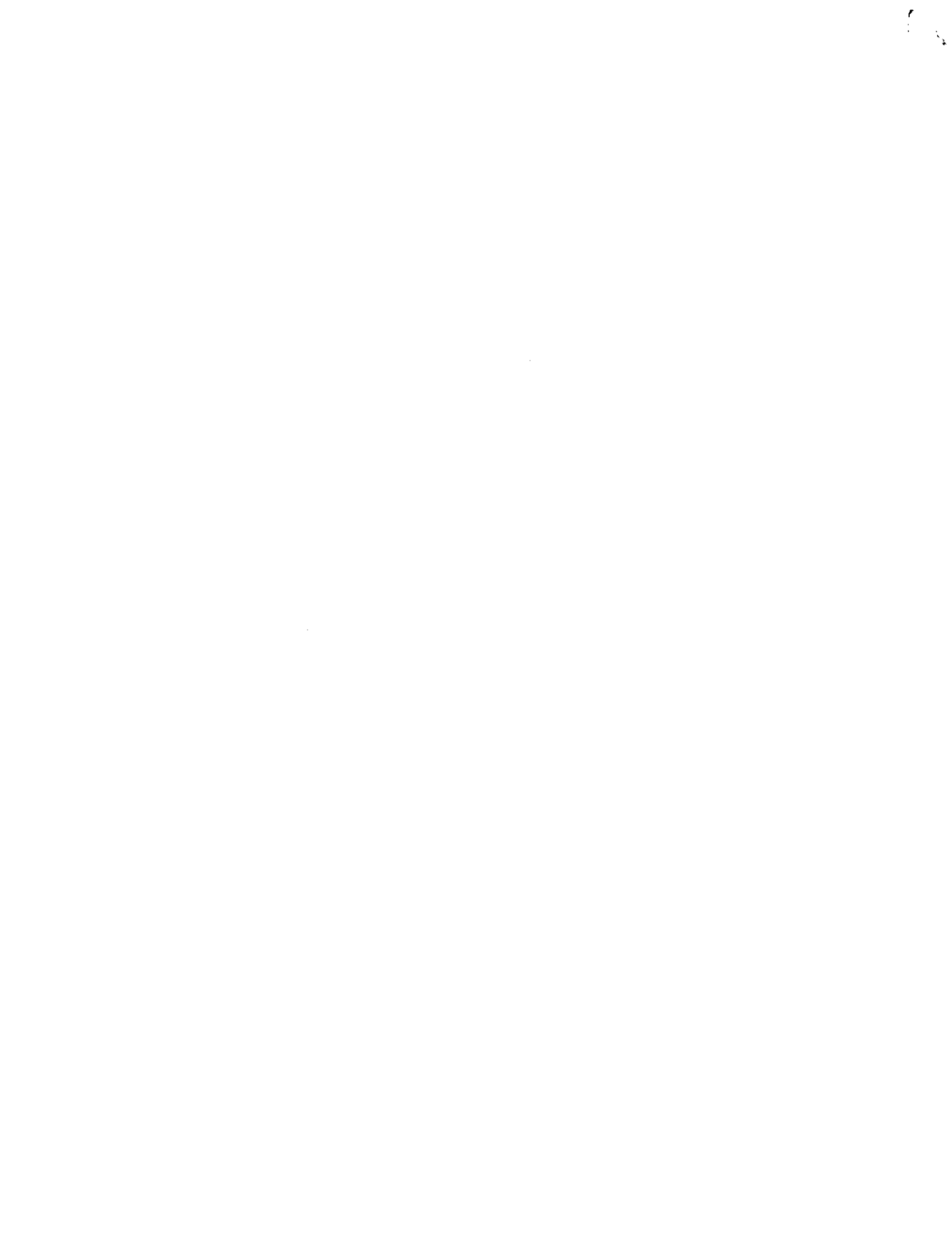

Hi Greg,

In response to your voicemail this morning, the email forwarded below is the email we received from the HUD Field Office. In it Cynthia Harvey quoted partially from the CFR. She did not address giving preference to the Bristol Park neighborhood. The HACC did not receive whatever document Terry Townsend might have been quoting from at the City Council Meeting last night.

At any rate the CFR is very specific about local preference: Below is the section from the CFR that Cynthia Harvey partially quoted from in her email:

I highlighted one of the portions that she left out. While it is true that we could not establish a preference for the Bristol Park neighborhood, we can establish a preference for a county or municipality. I have attached the change we are proposing to make in our HCV Admin Plan if approved by the HACC Board of Commissioners. As you can see, we made the residency preference area Champaign County. This would allow us to help all local government agencies in Champaign County if a resident is required to move because of any local government action. Instances in the past where we could have helped if we had had this preference include residents who

lived at Gateway in the City of Champaign, the Ramos property in rural Champaign County or the Hanford Inn in the City of Urbana.

I hope this helps you understand the situation. Please feel free to share this email,

Waiting list: Local preferences in admission to program.

(a) Establishment of PHA local preferences. (1) The PHA may establish a system of local preferences for selection of families admitted to the program. PHA selection preferences must be described in the PHA administrative plan.

(2) The PHA system of local preferences must be based on local housing needs and priorities, as determined by the PHA. In determining such needs and priorities, the PHA shall use generally accepted data sources. The PHA shall consider public comment on the proposed public housing agency plan (as received pursuant to § 903.17 of this chapter) and on the consolidated plan for the relevant jurisdiction (as received pursuant to part 91 of this title).

(3) The PHA may limit the number of applicants that may qualify for any local preference.

(4) The PHA shall not deny a local preference, nor otherwise exclude or penalize a family in admission to the program, solely because the family resides in a public housing project. The PHA may establish a preference for families residing in public housing who are victims of a crime of violence (as defined in 18 U.S.C. 16).

(b) Particular local preferences— (1) Residency requirements or preferences. Residency requirements are prohibited. Although a PHA is not prohibited from adopting a residency preference, the PHA may only adopt or implement residency preferences in accordance with non-discrimination and equal opportunity requirements listed at § 5.105(a) of this title.

(ii) A residency preference is a preference for admission of persons who reside in a specified geographic area ("residency preference area"). A county or municipality may be used as a residency preference area. An area smaller than a county or municipality may not be used as a residency preference area.

(iii) Any PHA residency preferences must be included in the statement of PHA policies that govern eligibility, selection and admission to the program, which is included in the PHA annual plan (or supporting documents) pursuant to part 903 of this title. Such policies must specify that use of a residency preference will not have the purpose or effect of delaying or otherwise denying admission to the program based on the race, color, ethnic origin, gender, religion, disability, or age of any member of an applicant family.

(iv) A residency preference must not be based on how long an applicant has resided or worked in a residency preference area.

(v) Applicants who are working or who have been notified that they are hired to work in a residency preference area must be treated as residents of the residency preference area. The PHA may treat graduates of, or active participants in, education and training programs in a residency preference area as residents of the residency preference area if the education or training program is designed to prepare individuals for the job market.

(2) Preference for working families. The PHA may adopt a preference for admission of working families (families where the head, spouse or sole member is employed). However, an applicant shall be given the benefit of the working family preference if the head and spouse, or sole member is age 62 or older, or is a person with disabilities.

(3) Preference for person with disabilities. The PHA may adopt a preference for admission of families that include a person with disabilities. However, the PHA may not adopt a preference for admission of persons with a specific disability.

(4) Preference for victims of domestic violence. The PHA should consider whether to adopt a local preference for admission of families that include victims of domestic violence.

(5) Preference for single persons who are elderly, displaced, homeless, or persons with disabilities. The PHA may adopt a preference for admission of single persons who are age 62 or older, displaced, homeless, or persons with disabilities over other single persons.

(c) Selection among families with preference. The PHA system of preferences may use either of the following to select among applicants on the waiting list with the same preference status:

(1) Date and time of application; or

(2) A drawing or other random choice technique.

(d) Preference for higher-income families. The PHA must not select families for admission to the program in an order different from the order on the waiting list for the purpose of selecting higher income families for admission to the program.

(e) Verification of selection method. The method for selecting applicants from a preference category must leave a clear audit trail that can be used to verify that each applicant has been selected in accordance with the method specified in the administrative plan.

Good morning Mr. Bland

As stated in our conversation in accordance with the rules and regulations set by the Department of Housing and Urban Development (HUD) a housing authority can establish local preferences. When local preferences are established it must be described in your agency Administrative Plan. Any system of local preferences must be consistent with your agency PHA Plan and the Consolidated Plan. In addition, the preference system must be based on local housing needs and priorities, as determined by the Board of Commissioners and Housing Authority staff. Your agency may elect to adopt a preference for displaced families, working families (where the head, spouse or sole member is employed) or a residency preference. A residency preference applies to applicants who are working or have been notified that they are hired to work in the locality as well as applicants already living in the jurisdiction. A residency preference may not be based on the length of time the applicant has lived or worked in the area. Your agency may however treat graduates or participants of a training program designed to prepare individuals for the job market as "residents".

When speaking with you I was informed that your current tenant selection plan for the Section 8 Program is determined by date and time. If your agency wishes to change the tenant selection to a preference point system, you must give 30 day notice and an opportunity for public comment. An opportunity for public comment can be a public meeting or an opportunity to submit written comment. The new selection system must be included in the Section 8 Administrative Plan and approved by the Board of Commissioners before implementation. If preferences are adopted your agency must have procedures in place in order to verify preferences. HACC does not have to verify a preference at the time of initial application. At the time of initial application, the applicant only needs to certify as to whether or not they are eligible for a preference, and your agency need only to place the applicant on the waiting list. Before the family receives assistance however, your agency must verify the family's eligibility for the preference based on current circumstances. Please keep in mind the preferences you have outlined your email is open to all residents of Champaign County, you cannot target specific developments.

We are currently researching how HACC's MTW flexibility may be applied to the establishment of local preferences. The MTW Office in Washington D.C. has offered to help HACC with this research.

It is clear from the PIH Notice that HACC's proposed local preferences (attached) are not only legal, but also are exactly the types of preferences that HUD encourages housing authorities to establish.

Good morning Mr. Bland

As stated in our conversation in accordance with the rules and regulations set by the Department of Housing and Urban Development (HUD) a housing authority can establish local preferences. When local preferences are established it must be described in your agency Administrative Plan. Any system of local preferences must be

consistent with your agency PHA Plan and the Consolidated Plan. In addition, the preference system must be based on local housing needs and priorities, as determined by the Board of Commissioners and Housing Authority staff. Your agency may elect to adopt a preference for displaced families, working families (where the head, spouse or sole member is employed) or a residency preference. A residency preference applies to applicants who are working or have been notified that they are hired to work in the locality as well as applicants already living in the jurisdiction. A residency preference may not be based on the length of time the applicant has lived or worked in the area. Your agency may however treat graduates or participants of a training program designed to prepare individuals for the job market as "residents".

When speaking with you I was informed that your current tenant selection plan for the Section 8 Program is determined by date and time. If your agency wishes to change the tenant selection to a preference point system, you must give 30 day notice and an opportunity for public comment. An opportunity for public comment can be a public meeting or an opportunity to submit written comment. The new selection system must be included in the Section 8 Administrative Plan and approved by the Board of Commissioners before implementation. If preferences are adopted your agency must have procedures in place in order to verify preferences. HACC does not have to verify a preference at the time of initial application. At the time of initial application, the applicant only needs to certify as to whether or not they are eligible for a preference, and your agency need only to place the applicant on the waiting list. Before the family receives assistance however, your agency must verify the family's eligibility for the preference based on current circumstances. Please keep in mind the preferences you have outlined your email is open to all residents of Champaign County, you cannot target specific developments.
