Etsy Gift Card 2012 Sweepstakes OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING. The sponsor of the 2012 Etsy Gift Card Sweepstakes (the "Promotion") is Etsy, Inc. (owner and operator of Etsy.com) at 55 Washington Street, Suite 512, Brooklyn, NY 11201 (the "Sponsor").

- 1. **ELIGIBILITY:** Open to legal residents of the 50 United States and District of Columbia age 18 years or older at the time of entry. Method #1: When you purchase an Etsy Gift Card at www.etsy.com during the Promotion Period you will receive one automatic entry into the applicable Weekly Drawing when the purchase is made. Method #2: You may enter by sending an email to GiftCard2012@etsy.com with your name, physical address and Etsy ID (if applicable) ("Email") during the Promotion Period and you will receive one entry per Email into the applicable Weekly Drawing. Limit: five (5) entries per person, per Weekly Entry Period by any method of entry. All entries must be received by the end of the applicable Entry Period to be eligible for that applicable Weekly Drawing.
