*Financing of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the Former Yugoslavia since 1991* [item 143]

The Committee resumed its consideration of this agenda item and had before it draft resolution [A/C.5/67/L.16](#), which had been coordinated by the representative of Ecuador, on behalf of the Chair of the Committee.

Before the consideration of the draft resolution, the representative of the Russian Federation made a statement and proposed an oral amendment to the draft resolution.

The representative of Sweden requested a recorded vote on the oral amendment proposed by the representative of the Russian Federation.

The Committee then proceeded to vote on the oral amendment which was not adopted by a recorded vote of 59 votes against, 17 votes in favour, with 58 abstentions.

The representative of the Russian Federation requested a recorded vote on the draft resolution [A/C.5/67/L.16](#) as a whole.

The Committee then proceeded to vote on the draft resolution as whole which was adopted by a recorded vote of 135 votes in favour, to none and 12 abstentions.

The Committee thus concluded its consideration of this item at this stage.

*Programme budget for the biennium 2012-2013* [item 130]

The Committee resumed its consideration of this agenda item.

*Questions relating to the programme budget for the biennium 2012-2013*

A statement in explanation of vote after the vote was made by the representative of Nicaragua (also on behalf of Bolivia (Plurinational State of), Cuba, Iran (Islamic Republic of) and Venezuela (Bolivarian Republic of)).

The Committee then adopted draft resolution [A/C.5/67/L.18](#), as a whole, without a vote.

After the adoption of the draft resolution as a whole, the representative of Cuba made a statement.

The Committee thus concluded its consideration of this question.

*Programme budget implications*

The Chair of the Committee drew the attention of the Committee to document [A/C.5/67/L.12](#) (sections A to C), which contained three draft decisions on statements of

### **Protocol to Eliminate Illicit Trade in Tobacco Products (Seoul, 12 November 2012)**

#### **Opening for signature**

The Protocol to Eliminate Illicit Trade in Tobacco Products, which was adopted during the fifth session of the Conference of the Parties to the WHO Framework Convention on Tobacco Control, by decision FCTC/COP5 (1) of 12 November 2012, will be open

for signature at a signing ceremony to be held in Geneva, Switzerland, on Thursday, 10, and Friday, 11 January 2013, and, thereafter, at United Nations Headquarters in New York.

In accordance with its article 43, the Protocol shall be open for signature by all parties to the WHO Framework Convention on Tobacco Control at World Health Organization Headquarters in Geneva on Thursday, 10, and Friday, 11 January 2013, and thereafter at United Nations Headquarters in New York until Wednesday, 9 January 2014.

Certified true copies of the Protocol, of which the Arabic, Chinese, English, French, Russian and Spanish texts are equally authentic, are being printed and will be transmitted to all States as soon as possible. Electronic certified true copies of the Protocol are posted in the United Nations Treaty Collection Web site (please [click here](#)).

The Secretary-General takes this opportunity to recall that, under established international practice, only Heads of State, Heads of Government or Ministers for Foreign Affairs are empowered, by virtue of their functions, to sign treaties on behalf of States without having to produce full powers to that effect. Other representatives of States wishing to sign the Protocol must be in possession of appropriate full powers emanating from one of these authorities.

The Secretary-General would be obliged if parties to the WHO Framework Convention on Tobacco Control wishing to sign the Protocol could, as necessary, provide the required full powers in advance to the Treaty Section, Office of Legal Affairs, at United Nations Headquarters in New York (fax 1 (212) 963-3693).
