

I also request any information or records pertaining to the investigation of these incidents including a copy of the search warrant that was served to Colorado Indymedia, intelligence bulletins, and other information/communications between Denver FBI, ICE (Immigrations and Customs Enforcement), FPS (Federal Protective Services), Loveland Police Department, Colorado Springs Police Department, Larimer County Sheriff, El Paso County Sheriff Department, and the Department of Homeland Security. Please search both the automated and manual indexes at the agency headquarters in addition to any field offices in Colorado.

As many of these records already exist in electronic form, I request that they be mailed to me on a compact disc or DVD in the file format that they exist in. If any records that originally exist in electronic form are printed out and mailed to me, I will consider it a denial of my request.

I realize that some records which fall under this request may be exempt from release for a number of reasons. In such a situation, please redact any information which is exempt and provide me with all segregable portions of otherwise non-exempt material. Please cite any exemptions you make with the law or court ruling you base your exemptions on and provide a receipt indicating the charges for each record if there are any.

I would prefer that all communications, clarifications, etc. about this request be sent to me via my email address with "Public Records Request" in the subject line.

I am very interested in these records and will pursue any legal means available including litigation to gain access to them. It is worth noting that violations of the Freedom of Information Act can result in significant fines including attorneys fees for the prevailing party.

I am willing to pay up to \$10 for the reproduction of these records. Should you believe the costs will exceed \$10, please notify me. I look forward to your timely response within twenty days as the law requires.
