The Howard government introduced Workchoices.

The Rudd government abolished Workchoices.

The Liberal/National Party Coalition, led by Tony Abbott, wants to bring back parts of Workchoices.

Under Workchoices workers lost many key rights and entitlements.

Under Workchoices protection from unfair dismissal was removed for many workers.

Individual contracts which cut wages, penalty rates, loadings and allowances, were made legal.

It is not in the interests of workers for us to go back to a Workchoices system.

WorkChoices: Fact Sheet

WorkChoices hurt Australian workers and their families.

- \(\) Under WorkChoices protection from being sacked unfairly was stripped away from more than four million workers.
- Under WorkChoices it was easier for employers to cut penalty rates, overtime pay, holiday loadings, public holidays, redundancy pay and work allowances.
- Under WorkChoices more than a million low paid workers suffered real pay cuts of up to \$90 a week from WorkChoices' changes to minimum wages.
- \(\) Under WorkChoices AWA individual contracts only needed to contain 5 minimum conditions.
- ✗ Office of the Employment Advocate figures in 2006 confirmed AWAs were a rip-off for working people, taking away basic conditions without any compensation:
 - 64 per cent cut annual leave loading;
 - 63 per cent cut penalty rates;
 - 52 per cent cut shift work loadings;
 - 51 per cent cut overtime loadings;
 - 48 per cent cut monetary allowances;
 - 46 per cent cut public holiday pay;
 - 40 per cent cut rest breaks;
 - 36 per cent cut declared public holidays; and
 - 22 per cent provided workers with no pay rise, some for up to 5 years.
- \(\) Under WorkChoices, awards were set to disappear forever:
 - Award content got stripped out and awards couldn't be updated.
 - Once you made an AWA or an agreement, the award never applied to you again.
 - New businesses weren't even covered by awards their employees only got five minimum conditions.
- Under WorkChoices young workers, women and casuals were the most vulnerable, and ended up being its worst victims.

Despite Australian families rejecting WorkChoices at the last election Mr Abbott has consistently defended WorkChoices and has said that he would bring back some of the worst elements of WorkChoices.

JOURNALIST: "Just recently, when your book came out, you were flirting with, not flirting, but you weren't ruling out re-embracing WorkChoices. Is that still part of your manifesto now?"

ABBOTT: "Well, the phrase WorkChoices is dead. No-one will ever mention it again, but look, we have to have a free and flexible economy."

10. Abbott claims WorkChoices would have been good during the Global Financial Crisis.

"My instinct is that Australians who were dismayed by the seeming harshness of the original WorkChoices legislation could be much less sentimental about 'hard-won conditions' when businesses are struggling to survive and jobs are disappearing... After three decades of economic change, reform had almost become a dirty word, but tougher times will make the case for reform more, not less, persuasive."

11. Abbott was opposed to any changes to WorkChoices because he thought it couldn't be improved.

"The new government has its mandate and the new opposition has its mandate and I think we should vote for things that we think are good policy and against things that we think are bad policy. It's our judgement."

"I don't think there's anything that they are likely to propose to the existing Workplace Relations Act that would improve it. So I think whatever they put up we should vote against it."
