*Founded in 2008, the International Institutions and Global Governance (IIGG) program at the Council on Foreign Relations analyzes the institutional requirements for effective multilateral cooperation in today's rapidly changing world.*

### RESEARCH

The IIGG program analyzes frameworks needed to address specific global issues, including

- the rise of transnational threats, from terrorism to infectious disease
- a shift in power to the global “South”
- evolving norms of sovereignty and intervention
- the mounting influence of nonstate actors
- the spread of regional and subregional organizations

### DIALOGUE

The IIGG program gathers the foreign policy community to forge inventive solutions that strengthen the world's multilateral bodies. IIGG-sponsored meetings include

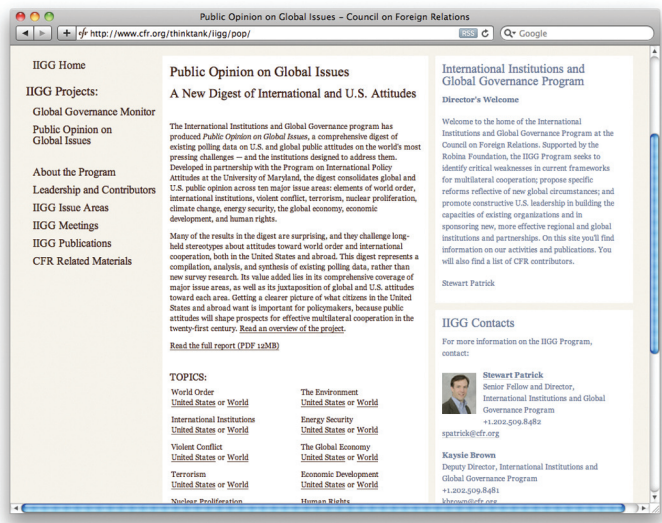

The IIGG program produces and sponsors books, articles, reports, and multimedia packages that combine cutting-edge technology with rigorous scholarship.



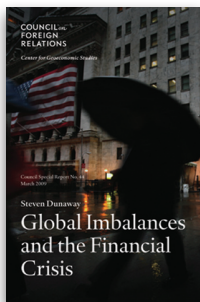

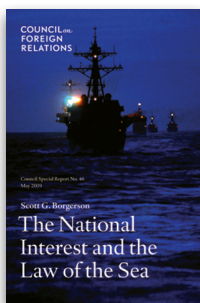
