We collect information from and about you.

Contact information. For example, we might collect your name and street address. We might also collect your phone number or email.

Payment information. For example, we collect your credit card number when you buy a subscription or pay to access parts of our site.

Information you submit or post. We collect the information you post in a public space on our website.

Demographic information. We may collect information about your interests or hobbies. We might collect this as part of a survey, for example.

Other information. If you use our website, we may collect information about the browser you're using. We might look at what site you came from, or what site you visit when you leave us. If you use our mobile app, we may collect your GPS location. We might look at how often you use the app and where you downloaded it. We collect this information using the tracking tools described [here](#). To control these tools, please read [here](#).

We collect information in different ways.

We collect information directly from you. For example, if you subscribe for home delivery or register for our newsletter. We also collect information if you post a comment or make a request. We may publish your name if you send a letter to the editor.

We collect information from you passively. We use tracking tools like browser cookies and web beacons. We also collect information from our mobile apps.

We get information about you from third parties. For example, our business partners may give us information about you.

We use information as disclosed and described here.

We use information to respond to your requests or questions. For example, we might use your information to confirm your subscription or register you for a contest. We may use your friend's email address if you send them information from our site.

We use information to improve our products and services. We might use your information to customize your experience with us.

We use information to look at site trends and customer interests. We may use your information to make our website and products better. We may combine information we get from you with information about you we get from third parties.

We use information for security purposes. We may use information to protect our company, our customers, or our websites.

We use information for marketing purposes. For example, we might send you information about special promotions or offers. We might tell you about new features or products. These might be our own offers or products, or third party offers or products we think you might find interesting. We may use push notifications on our mobile apps. To manage this, read the [choices](#) section below.

We use information to communicate with you about your account or our relationship. We may contact you about your account or subscription. We might also contact you about this Policy or our website Terms.

We use information to talk to parents or guardians to get permission. We may use contact information to get permission from parents for children who want to use our site.

We use information as otherwise permitted by law. For example, we may use your IP address for identification purposes in cooperation with internet service providers or law enforcement agencies.

We may share information with third parties.

We will share information within the Wrapports family of companies.

We will share information with third parties who perform services on our behalf. For example, we share information with vendors who send emails for us or fulfill your purchases.

We will share information with our business partners. For example, we might share information with a business partner who runs a sweepstakes for us. These partners may send

you information about events and products by mail or email. To control this, read the [choices](#) section below.

We will share information if we think we have to in order to comply with the law or to protect ourselves. For example, we will share information at the request of governmental authorities conducting an investigation, or to verify or enforce compliance with our internal policies and applicable laws. We will share information to respond to a court order or subpoena. Or, we might also share information when we are investigating potential fraud. This might include fraud we think has happened during a sweepstakes or promotion. We may share your information whenever we believe disclosure is necessary to limit our liability or to protect or enforce the rights, interests or safety of our products and services, our users or others.

We may share information with any successor to all or part of our business. For example, if part of our business was sold we may give our customer list as part of that transaction.

We may share information for other reasons we may describe to you.
