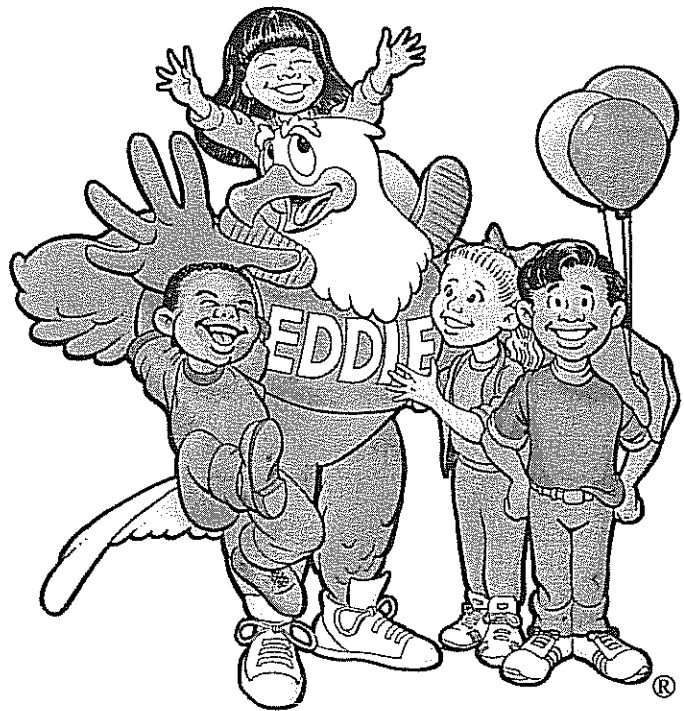

**Official Contest Rules:** Only law enforcement agencies in Upper New York can apply. To enter, you must complete the Eddie Eagle Mascot Costume Entry Form and return it to The Eddie Eagle GunSafe® Program. One entry per law enforcement agency. **Entries must be typewritten or neatly printed and mailed in.** Entries must be postmarked by **July 21<sup>st</sup>, 2014**. The costume will be awarded to the most deserving law enforcement agency. Only one law enforcement agency will win. Odds of winning depend on the number of entries received. The winner will be notified by mail within 30 days after contest deadline. Should the winning agency not accept the costume, the costume will then be awarded to an alternate winner. Costume winner must agree to follow the mascot costume rules and regulations as stated in the Eddie Eagle® Mascot Costume Handbook by completing and signing the costume application.
