EUobserver bridges the gap between citizens and EU institutions by reporting not only from Brussels bust also from EU member states. 80% of readers come from outside of Brussels.


#### Independent

- EUobserver is a primary source of EU news for international journalists and is regularly quoted in publications such as The New York Times, The Guardian, Le Monde, The Economist and many others.










