- Currently enrolled VU students transferring to another VU course.

#### Do I pay an application processing fee?

Applications made directly to Victoria University are exempt from an application fee. Fees are applicable for applications made through the Victorian Tertiary Admissions Centre (VTAC).

#### **Courses with Extra Selection Requirements**

Some courses have extra selection requirements that must be completed as part of their application. This includes courses which are available through VTAC, as well as courses that accept direct applications. Extra requirements may include attending an interview, sitting an aptitude test, presenting a folio etc.

It is your responsibility to ensure that you complete all extra selection requirements by the prescribed date, otherwise your application may not be considered.

### Courses that require Supplementary Information

Some courses require applicants to complete supplementary information. Forms, where applicable, can be downloaded from <u>www.vu.edu.au/supplementary-forms</u> and must be uploaded along with your online application or attached to your paper-based application, otherwise your application may not be considered.

#### IMPORTANT - ALL TAFE COURSE APPLICANTS - SKILLS REFORM

If you are applying for Vocational and Further Education (TAFE) qualifications, you will be subject to the *Victorian Training Guarantee* eligibility criteria for a government subsidised place. All applicants who meet the citizenship/residency requirements and are under 20 on 1 January in the year in which the course commences will be eligible for a government funded place. All other applicants will be subject to eligibility criteria and if the eligibility criteria are not met, applicants may be required to pay full fees to enrol into the course. Provided the student meets the citizenship/residence requirements, the student can defer the payment of their fees through VET FEE-HELP provided the course is at Diploma or higher qualification and the course is approved for VET FEE-HELP assistance. DOCUMENTATION SHOULD BE PROVIDED	You should provide (where applicable) <b>certified copies</b> of your qualifications, transcripts, study results or resume in support of your application. If your qualifications are from a country other than Australia, please provide an official 'Statement of Equivalence' form. If you don't have a 'Statement of Equivalence' you may submit your documentation for assessment by VU however it may take longer to confirm an admission decision. <b>Certified documents</b> A photocopy of an original document can be certified (signed and dated) as a true copy of the original document by an authorised person (e.g. Justice of the Peace, police officer, doctor, accountant, school principal, bank manager, pharmacist). This person must view both the original and the photocopy. You may be asked to show the original documents at a later stage (e.g. at an interview). You may also present your original and copy to a VU staff member at a Student Service Centre on campus for certification.

	Paper-based Direct entry applicants (available at <u>www.vu.edu.au/forms</u> ) must attach their certified documentation to their paper-based application form.		
	If you are applying for a special entry scheme, please ensure that you are able to supply all of the supporting documentary evidence requested.
