World Congress of Families – A Brief History

World Congress of Families was founded in 1995 by WCF International Secretary Allan C. Carlson, Ph.D., noted family historian, author and president of The Howard Center for Family, Religion & Society.

There have been six Congresses to date:

WCF I – Prague (1997)

WCF II – Geneva (1999)

WCF III – Mexico City (2004)

WCF IV – Warsaw (2007)

WCF V – Amsterdam (2009)

WCF VI – Madrid (2012)

More than 3,200 delegates from 72 nations attended World Congress of Families VI in Madrid (May 25-27, 2012). The Congress was addressed by 147 speakers from six continents, including eminent religious leaders, scholars, physicians, economists, demographers, scientists, officeholders and leaders of the pro-life and pro-family movements. WCF VI was covered by 190 accredited journalists from all over the world.

Among the speakers were the Chief Rabbi of Spain, the President of the Pontifical Council on the Family, the President of the Southwestern Baptist Theological Seminary (and former President of the Southern Baptist Convention), an Elder of the LDS Church and an Archpriest representing the Moscow Patriarchate of the Russian Orthodox Church.

Other Milestones

- In 2008, World Congress of Families circulated a “Petition In Support of Romania’s Defense of Marriage” which was signed by more than 100 pro-family leaders from 22 countries supporting a change in the nation’s family code defining marriage as the union of a man and a woman. The change was adopted.

- In February 2010, WCF initiated “The World Congress of Families Leadership Petition to Save Marriage

In Mexico City,” protesting the imposition of same-sex marriage in the nation’s capital. The Petition was endorsed by pro-family leaders from more than 40 countries.

- In 2010-2012, World Congress of Families held regional events in Vancouver (Canada) – Sydney – London – Edinburgh – Santa Cruz (Bolivia) – Riga (Latvia) – Lagos and Abuja (Nigeria) – Port of Spain (Trinidad), Moscow and Ulyanovsk (Russia).

- WCF’s Moscow Demographic Summit (June 29-30, 2011) at the Russian State Social University, was the first international gathering devoted exclusively to the challenge of rapidly falling birthrates worldwide. It attracted several hundred demographers, economists, authors, activists and religious and political figures to address what could be the greatest crisis confronting humanity in this century. In response, the Duma passed the first abortion restrictions since the fall of the Soviet Union.

- Our Partners have been in the forefront of efforts to save marriage around the world, including – Red Familia’s campaign to stop “same-sex marriage” in Mexico City, Christian Concern’s involvement in a coalition which delivered to 10 Downing Street half-a-million signatures on a petition to maintain marriage as the union of a man and a woman in Britain, the Australian Family Association, Endeavour Forum and Dads4Kids helping to defeat a “gay marriage” bill in the Australian Parliament in August 2012, and National Organization for Marriage’s involvement in most of the state marriage initiatives in the U.S.

- World Congress of Families VIII is tentatively scheduled for Moscow, The Kremlin, September 10-12, 2014.
