

Frequency Asked Questions about the 9/11 Attacks DC 9/11 Truth

Q: Don't 9/11 conspiracy theories offend the memories of the victims?

A: No, the 9/11 attacks have been used for political reasons that were unrelated to the crimes of 9/11. That is insulting to the victims. Finding the true perpetrators is the only way to respect the victims.

Q: Didn't Al Qaeda take responsibility for 9/11?

A: Al Qaeda claimed responsibility for Katrina floods, New York power outages, and earthquakes. According to British Secretary of State Robin Cook in 2005, Al Qaeda literally means computer "database", named by the CIA, was originally a list of Islamic fundamentalists recruited by the United States in the 1980s.

Q: Do conspiracies exist?

A: Conspiracy is a legal term. Government prosecutors often legally convict people for conspiracy. Our law enforcement officials are trained to investigate conspiracies, although political forces prevented a real investigation of 9/11 while preparations for war had already begun.

Q: Aren't conspiracy theories fictitious?

A: The phrase "conspiracy theory" is used to close down an uncomfortable discussion. There are plenty of conspiracy theories that turned out to be documented fact, like Iran-Contra, COINTELPRO, and the 1953 CIA coup in Iran. While COINTELPRO is as real as Obamacare, if you talk about COINTELPRO, people will assume it is just a "conspiracy theory" because it does not correspond with their ideal of the United States.

Q: What is a false flag event?

A: A false flag event is a staged event used to manage public opinion. The "father of public relations" Edward Bernays, for example, who worked for major U.S. corporations and the Pentagon, said "Now public opinion stood out as a force that must be managed [because]There are invisible rulers who control the destinies of millions."

Q: Isn't a conspiracy of this size impossible?

A: Conspiracies of this magnitude are performed using compartmentalization. Most people involved do not realize the larger picture, and believe they are performing a standalone mission. The World War II Manhattan Project, and Nevada air force base Area 51, were also secrets kept from the public, despite massive involvement by patriotic Americans.

Q: How could Americans plan to kill other Americans?

A: U.S. policymakers have often planned for the death of American citizens in order to manage public opinion. Patriotic Americans who plan for the death of fellow Americans believe they are doing so for the greater good, and that the ends justifies the means. For example, in the 1962 Northwoods document signed by Joint Chiefs of Staff, the plan stated: "Casualty lists in US newspapers would cause a helpful wave of national indignation." CIA Officer Michael Scheuer stated in 2011: "The only chance we have as a country right now is for Osama bin Laden to deploy and detonate a major weapon in the United States. Because it's going to take a grass-roots, bottom-up pressure.Only Osama can execute an attack which will force Americans to demand that their government protect them effectively, consistently, and with as much violence as necessary. " In 2000, the "Project for a New American Century", a think-tank with members who were prominent in the Bush administration, stated in their report that they needed to manage world affairs, but the public would not allow it "absent some catastrophic and catalyzing event – like a new Pearl Harbor."

Q: Didn't Muslims do this?

A: Muslims are often blamed for terror attacks that have been proven to be done by non-Muslims. For example, in 1954, Muslims were blamed for the Lavon Affair, yet the truth was that Muslims were only meant to be blamed. Letters that accompanied the Anthrax terror attacks of 2001 in the United States were meant to give the impression that they were written by Muslims. Generally it is accepted that Muslims were responsible for 9/11, and other terror attacks, because Westerners generally don't need evidence to blame Muslims.

Q: Weren't Arabs on the planes that were hijacked on 9/11?

A: The FBI admits that the hijackers used stolen identities, yet have not updated the list of perpetrators. Many of the alleged hijackers have been found alive after 9/11, but no new investigation is in progress. The suspected pilots were not skilled enough to perform the maneuvers they allegedly performed. Some Muslims may have been involved, although as patsies, and were unaware of the overall design on 9/11.

Q: What is a "false flag" government agent?

A: In intelligence circles, the term "false flag" is used to label operatives who have unknowingly been recruited to work against their own interests. Arabs used on 9/11 may have had no idea they would be used as patsies.

Q: Didn't Bin Laden admit guilt?

A: No, he said he did not plan 9/11, despite the media reports saying otherwise. After reviewing the evidence mainly obtained by torture, there is no hard evidence that would stand up in court linking Bin Laden or Muslims to the planning of the 9/11 terror attacks.

Q: Who could have done this?

A: Elites have always used propaganda and staged publicity stunts in order to help them manufacture public opinion, and manage democracy, because they have a paternalistic and condescending view towards the general populous. This is nothing new, but rather is the norm for thousands of years.

Q: Isn't government too incompetent to manage such an intricate stunt?

A: They seem incompetent because they cannot agree to promote the public good, yet they managed to conduct dozens of successful conspiracies, like Iran-Contra, 1953 Iran coup, 1973 Chile coup, etc.

Q: How is it possible for government to do this?

A: The US intelligence complex has billions of dollars and sophisticated technology. It would be easier for the US government to do this than fumbling Arabs.

Q: Wouldn't the media find out and tell us the truth?

A: Did the media question Iraq/WMDs, or toe the line before the war? There is a culture of conformity here. Reporters and politicians were complicit when they lied about WMDs in Iraq.

Q: Aren't conspiracy theories for uneducated people?

A: It is actually easy to just believe that Muslims are terrorists without any evidence, instead of investigating the truth.

Q: Wasn't there already was an investigation of 9/11?

A: The true American way of justice is to convict criminals in a fair trial, not avoiding due process for political gain. Foreigners were accused of committing crimes, without trials, to start wars.

Q: Don't some people just think that everything is a conspiracy?

A: Not everything that happens in the world is a conspiracy, but financial elites are involved in geopolitical activities that concern their interests, and they have resources to help manage their agenda. Elites have always used their resources for promoting their interests.

Q: Didn't planes bring down the World Trade Center buildings?

A: Three buildings fell in New York City, yet only two buildings were hit by planes. The buildings were built to withstand a plane impact. Fire from jet fuel is not hot enough to melt the steel frame of a skyscraper.

Q: The steel didn't melt, but fire was hot enough to weaken the steel, and weakened steel caused the buildings to suddenly collapse?

A: There have been many skyscraper fires, buildings burning like an inferno, in recent decades, and never before or after 9/11 has the steel weakened or the building collapsed due to fire. The 3rd building to collapse on 9/11, World Trade Center 7 (WTC7), which was not hit by a plane, is the smoking gun to conspiracy.

Q: Couldn't the terrorists have placed the explosives in World Trade Center 7 (WTC7)?

A: According to the National Institute of Standards and Technology (NIST), "For the building to have been prepared for intentional demolition, walls and/or column enclosures and fireproofing would have to be removed and replaced without being detected. Preparing a column includes steps such as cutting sections with torches, which produces noxious and odorous fumes....It is unlikely that 100 lbs. of thermite, or more, could have been carried into WTC 7 and placed around columns without being detected, either prior to Sept. 11, 2001, or during that day."

Q: Didn't the government explain why World Trade Center 7 (WTC7) collapsed, despite not being hit by a plane?

A: The 2008 NIST report on WTC7 claimed that office fires caused "steel floor beams and girders to thermally expand" for floor 13, causing steel column 79 to fail, and then the rest of the building caved in after one beam failed. Even NIST claims that this was an "extraordinary event", but it was the best they could do after 6 years of their investigation into the improbable collapse. This explanation in itself might be impossible, and the NIST calculations have been classified because disclosure of WTC7 data "might jeopardize public safety". However, even if it were true that office fires caused one beam to fail, it does not explain the collapse of WTC7, where the footage shows that all 84 steel columns failed simultaneously.

Q: Are conspiracy theories unAmerican?

A: If you care about this country, you would want to find out who committed this crime. We want the terrorists brought to justice. Any patriotic American should want to find out who did it.

Q: Are you saying that the United States is evil?

A: There are rogue elements in the U.S. government, and it takes a real patriot to admit that we have traitors in our government.
