COMMUNIST REVOLUION UNIVERSAL

Communist revolution is only solution of present crisis of the world. Its universal, thus, range of communist revolution is universal.

Because, national boundary was not enough to develop the capitalism, therefore, colonial policy was integral part of capitalism, thus it became a world wide system, therefore all nations became inter-dependent. So, there is no scope for national liberation.

Capital can not exist without reproduction & circulation thus due to existence, the capitalist is bound for reproduction. But result of reproduction is over production and effect of over production is recession.

Consequence of repeated recession is socialisation of means of production. Thus, capitalism is the foundation of communism. Therefore, cause of disappearance of capitalist class is capitalism it-self.

Thus, a communist revolution for replacement of capitalism by social/commune/ common ownership of means of production is not possible in one country alone.

Marx & Engels rightly formulated these theories, when the capitalism became as an old society, therefore, it was unable to develop the private

ownership of property that is it reached to the end of its development, though volume of capital has been increasing.

Principle of Communism, by Engels and Communist Manifesto by both are not totally wrong.

Consequence of contradiction of sellers & buyers of labour power is socialisation of means of production, therefore, socialist revolution is only job of working class, and no doubt working class is alone revolutionary in this epoch.

So, except working class, rest of all classes including peasants are reactionary, therefore, communist party for a communist revolution is a party of working class.

Therefore, communist party is not local or national but global.

United action of the leading civilized countries at least one of the first conditions for the emancipation of the proletariat, and unity of workers of the world is the first and primary condition.

But 2nd International, took the line of so-called "right of self-determination of nations", at their London Congress, 1896; And it was against unity of workers of the world, rather it divided the workers into the nations. Though, workers lost their nationality.

Capitalist, as a buyer of labour power is an exploiter of sellers of labour power, thus, relation of both the classes is antagonistic. Therefore, no capitalist is friend of working class, even if their language, religion, race and sex is same, in spite of that nothing is difference between the relation of buyer & seller of labour power.

But effect of this political line of national liberation is the local or national capitalist, has considered as friend of working class, which is totally against interest of working class, and it is so helpful to confuse the workers about their class & class interest.

Thus, the line taken by the leaders of the 2nd International for national liberation was betrayal to the working class of the world.

Working class have no nationality and country, but they have a world to win by losing their chain.

But Bolshevik party was formed for the right of self-determination and for peoples sovereignty, and for the interest of peasants, thus by born it was not a working class party for a communist revolution, and it acquired the state power by a pre-planed army coupe.

Army is not part of working class, but part & parcel of parasitic classes. By the agreement of both the countries , The RUSSIA of Lenin became the market of Germany as favoured nations. Thus,

Russia, a state of state capitalism, founded by Lenin, which was the shelter of decayed capitalism, who was engaged in a world war due to recession for its survival.

Lenin, him-self violated his and his party's commitment even on constitutional assembly and sovereignty of peoples after the defeat in the election of constitution assembly and failure to win in the post of the speaker of assembly .

Even Lenin hold the post of chief executive of state but it was not included in his constitution -1918, which is more abominable than the code of brutal Hamburabi, the first written law giver of the world.

Rate of exploitation at USSR was much more than USA. Therefore, the great Leninist Stalin was one of the three important founding member of the IMF-the mightiest finance syndicate.

Under the rule of the IMF, no state have right even to fix & determine the tax & tariff policies, thus state became defunct and they call it as globalization. Therefore, nation state is dead.

Exactly by the agreement to end the 2nd world war, the colonial policy has became unnecessary.

Under the governance of the WTO, capital and commodity will move freely all over the world.

Thus days of state capitalism is over. Therefore, days of Leninism is over, which is corruption of science of socialism, discovered, formulated and explained by Marx & Engels.

But still now capitalism is exist, but not working and the IMF is already failed.

On the other hand working class is not unified for emancipation.

In this case Leninism, which is for various types of democratic revolution, in fact for gabbing the state power, is a dangerous obstruction.

Therefore, it is must to reject the Leninism, to rebuild the communist movement, and reconstruct the communist party to unite the working class of the world, and to form it as a class.

Remarkable, science of socialism is not Marx but property of all. So, the very word "Marxism" is not only unscientific, and unjustified, but it also undermined Marx him-self. Because, he was not a prophet but a communist and as a communist he was for abolition of private property with all kinds of inheritances.
