- P. ROBERT SEYMORE aka "C-MO": Over the course of the conspiratorial time period ROBERT SEYMORE worked within the DTO as a street-level distributor of heroin he obtained from DERRICK BOND;
- q. TRAVIS DORMAYER aka "TRAVO": Over the course of the conspiratorial time period TRAVIS DORMAYER aka "TRAVO" worked within the DTO by maintaining a residence for storing and distributing heroin at the direction of DERRICK BOND and would distribute heroin for BOND;
- r. <u>RYAN STURM and SUNNY KIMBRELL</u>: Over the course of the conspiratorial time period both RYAN STURM and SUNNY KIMBRELL worked within the DTO as street level distributers and users of heroin;
