The Centre for Environmental Policy wishes to recruit a Head of TSU (Science) for the Technical Support Unit (TSU) for Working Group III of the Intergovernmental Panel on Climate Change (IPCC) hosted by Imperial College London. IPCC aims to provide the world with a clear scientific view on the current state of knowledge in climate change. Working Group III is concerned with reducing greenhouse gas emissions. "Science" is meant in the broadest sense to include all disciplines relevant to climate change mitigation.

The post holder will have Senior Research Fellow status and will lead the team of scientists which supports the IPCC Co-chairs in delivering the WG-III contribution to the IPCC Sixth Assessment. You will have overall responsibility for ensuring the scientific integrity of WG-III products.

You must have a PhD (or equivalent) in a discipline relevant to climate change mitigation, or equivalent professional experience. A strong scientific record as evidenced by publication, experience of planning, leading and managing research activity, leading teams and motivating research staff are essential. A record of conducting research and/or studies in a field relevant to climate change mitigation reflected in innovation and impact in terms of discipline, profession or recognition is essential. You should also have experience of participating in international collaborations, be committed to working in an interdisciplinary environment and have an understanding of and respect for disciplinary approaches other than your own.

You will have good interpersonal skills, a proactive approach to work and excellent communication skills. You will need to be able to set and work to deadlines and be willing to work under pressure. You must be willing to travel overseas, for periods of up to a week to facilitate workshops and meetings.

This is a fixed term position available up to 31 March 2020, in the first instance with a possibility of extension subject to funding.

Shortlisted candidates will be required to complete an IPCC Conflict of Interest form.
