

NetSuite SuiteSolutions – Bulk Transfers

Description and Terms of Service

Overview of Functionality

Managers need to be able to replenish locations from a distribution center or pull back inventory from locations using a view that allows them to assess the result across multiple locations. The ability to generate transfer orders in bulk from the view eliminates time consuming entry of transfer orders.

A view of the potential locations that inventory would be distributed to, as well as the locations that inventory would be pulled back from is provided. After review and confirmation of the stock in each selected location, a transfer order is generated for each from/to location.

Two distinct scenarios are supported in the SuiteSolution:

1. Replenish Locations: specific stock is available in one warehouse for distribution to a range of locations.
2. Withdraw Stock: specific stock is to be removed from a range of locations and moved via transfer orders to a single location.

Limitations:

1. Transfer orders can only be created between locations within the same subsidiary.
2. Same shipping method and ship date is applied to all of the transfer orders created from a single submission. After generation, details on the transfer orders can be updated.
3. Quantities on the transfer orders reflect the status of inventory at creation. Sales orders and other inventory activities may change the quantities available for fulfillment and receipt.
4. This SuiteSolution does not affect Transfer Order price; the Accounting preference 'Use Item Cost as Transfer Cost' determines the transfer price used when items are received.
5. All standard NetSuite Service usage and governance limits apply.

Terms of Service:

SuiteSolutions are pre-built offerings used to accelerate the delivery of custom functionality into Customer's account. Any custom configurations or code deployed with SuiteSolution is not locked and can be further customized in Customer's account. It is Customer's sole responsibility to review the functionality and limitations enabled by this SuiteSolution item before procuring. Unless specifically agreed in writing in a separate Statement of Work, SuiteSolutions are not supported, maintained or upgraded by NetSuite. In addition, unless otherwise agreed upon in writing pursuant to a Statement of Work between NetSuite and Customer, Customer is responsible for all testing and configuration of all SuiteSolutions. SuiteSolutions can only be deployed to the account of the specific Customer that has procured the SuiteSolution. SuiteSolutions are for Customer's internal use only for use with Customer's NetSuite Service account and cannot be re-bundled and/or shared. Customer may continue to use this SuiteSolution item during the term of their use of the NetSuite Service.

This item shall be considered a Deliverable (as such term is defined in the PS Terms) and is provided to you pursuant to and governed by (in order of preference, as applicable): (i) the Professional Services Addendum to the NetSuite Subscription Services Agreement entered by and between the parties, (ii) the separate NetSuite Professional Services Agreement entered by and between the parties; or (iii) if neither (i) nor (ii) are applicable, the NetSuite Professional Services Agreement found at www.netsuite.com/termservice (the "PS Terms").

The SuiteSolution may include open source software programs licensed under different terms or licensed by a vendor other than NetSuite. To the extent that NetSuite includes open source software in or with the SuiteSolution ("Open Source Software"), the licenses governing such Open Source Software will apply to Customer's access and use of such Open Source Software. Customer agrees to comply with all applicable provisions of the licenses and terms governing Open Source Software. Notwithstanding anything to the contrary set forth herein or in the PS Terms, , NetSuite is not responsible for, and makes no warranties, express or implied, related to Open Source Software and will have no liability for Customer's use of such Open Source Software.
