# Liechtenstein

#### Ratified the European Convention on Human Rights in 1982

The Court dealt with 18 applications concerning Liechtenstein in 2015, 16 of which were declared inadmissible or struck out. It delivered 2 judgments (concerning 2 applications), which found at least one violation of the European Convention on Human Rights.

#### Liechtenstein and ...

Its contribution to the Court's budget

For 2016 the Court's budget amounts to approximately 71 million euros. That budget is financed by contributions from the 47 member States of the Council of Europe in accordance with scales based on population and GDP; the 2016 contribution of Liechtenstein to the Council of Europe's (EUR 326 million) budget is **EUR 361,689**.

#### The Registry

The task of the Registry is to provide legal and administrative support to the Court in the exercise of its judicial functions. It is composed of lawyers, administrative and technical staff and translators. There are currently **679** Registry staff members.



# Noteworthy cases, judgments delivered

## Grand Chamber

## Wille v. Liechtenstein

28.10.1999

Statement by the monarch of Liechtenstein that he would not re-appoint the applicant (then President of the Liechtenstein Administrative Court) to public office again, because of views he expressed in public on the competences of the Constitutional Court.

Violation of Articles 10 (freedom of expression) and 13 (right to an effective remedy)

# Noteworthy cases, judgments delivered

# Chamber

Case dealing with the right to liberty and security (Article5)

### Frommelt v. Liechtenstein

24.06.2006

Applicant not heard in person by the court of appeal prior to its decision to prolong his pre-trial detention (lack of equality of arms).

Violation of Article 5 § 4

### Cases dealing with Article 6

Right to a fair hearing/trial

### Schädler-Eberle v. Liechtenstein

18.07.2013

Relying on Article 6 § 1, the applicant complained that the administrative court, which had decided her case in the first instance, had not held a public oral hearing, in which evidence could have been taken in an adversarial manner.

No violation of Article 6 § 1

# Steck-Risch and Others v. Liechtenstein

19.05.2005

Applicants not given an opportunity to have knowledge of and comment on the observations submitted by the opposing party in proceedings before the Administrative Court.

Violation of Article 6 § 1

Right to a fair trial within a reasonable time

#### von Hoffen v. Liechtenstein

27.07.2006

Excessive length of criminal proceedings Violation of Article 6 § 1

# Noteworthy cases, decisions delivered

### Steck-Risch v. Liechtenstein (No. 2)

11.05.2010

Domestic courts refused to grant reopening of the national proceedings following the Court's judgment in the case of Steck-Risch and Others v. Liechtenstein.

Application declared inadmissible as incompatible *ratione materiae* with the provisions of the Convention.
