# **Litigation Powerhouses**

Litigation Powerhouses is Law360's inaugural ranking of the top firms for litigation. For the purposes of this survey, litigation includes:

- Bankruptcy litigation

To be counted as a member of the litigation group in this survey, an attorney must spend at least 75 percent of his or her time on litigation matters, as defined above.
