

2016/17 donation guidelines

LICENSING CONDITIONS AND CODES OF PRACTICE (LCCP)

The Gambling Commission's revised Licensing Conditions and Codes of Practice, below, came into force on 8 May 2015:

Social responsibility code provision 3.1.1

Combating problem gambling

All Licences

- 1. Licensees must have and put into effect policies and procedures intended to promote socially responsible gambling including the specific policies and procedures required by the provisions of section 3 of this code.
- 2. Licensees must make an annual financial contribution to one or more organisation(s) which between them research into the prevention and treatment of gambling-related harm, develop harm prevention approaches and identify and fund treatment to those harmed by gambling.

Note: An annual donation to RGT fully discharges a licensee's obligations under 3.1.1 (2).

RECOMMENDED MINIMUM ANNUAL RATES OF DONATION

RGT asks all businesses to consider donating a minimum of **0.1% of gross gambling yield** (**GGY**).

DEFINITION: "Gross Gambling Yield" means all gross gambling related income, gross win or gross gambling profit, i.e., total customer stakes less total customer winnings plus fees, commissions, rake, royalty, share or other income from gambling activity (all calculated before the deduction of gambling duty and costs of the operation).

RGT asks all smaller gambling businesses with a gross gambling yield (GGY) of less than £250,000 per annum to donate **a minimum of £250.**

On receipt of your donation, RGT will send you a letter of confirmation and a receipted invoice. **Please note** that for donations of £250 and above you will also receive a 2016/17 donor certificate and the Gamble Aware logo. The 2016/17 donor certificate will highlight your financial contribution to funding research into the prevention and treatment of gambling-related harm, to funding harm-prevention approaches and to the identification and funding of treatment to those harmed by gambling.
