





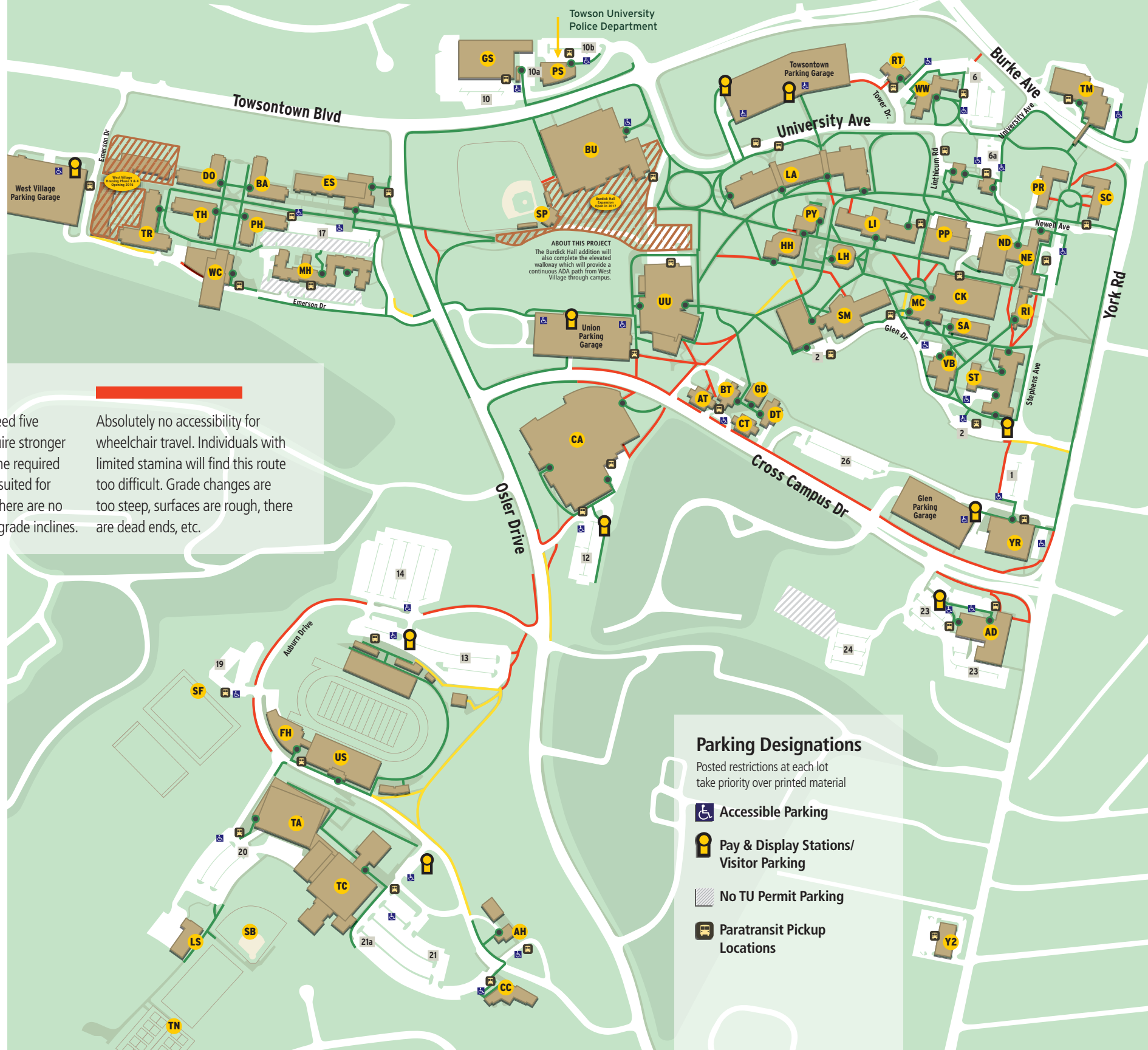
Campus Accessibility

 Indicates accessible paths and walks with no obstructions. Grades typically do not exceed five percent. These routes are generally connected to designated accessible parking lots and building entrances. (See  symbols on map.)

 Indicates routes which exceed five percent grade and will require stronger individuals to accomplish the required grade. Surface may not be suited for wheelchair travel. Usually there are no intermediate rest areas on grade inclines.





 Absolutely no accessibility for wheelchair travel. Individuals with limited stamina will find this route too difficult. Grade changes are too steep, surfaces are rough, there are dead ends, etc.

Accessible Parking

Anyone who displays a valid, state-issued parking placard or license plate for individuals with a disability and a current university parking permit may park in designated accessible spaces. The individual who is the authorized user of the handicapped permit must be a driver or passenger of the vehicle. Visitors may purchase a university parking day permit at a pay station in one of the visitor lots.

Individuals with a disability placard/plate may park at a stand-alone meter for two time frames without cost if all designated accessible spaces are filled.

Shuttle Buses

The front seats of each campus shuttle bus are reserved for individuals with disabilities. Not all shuttle buses can accommodate wheelchair users; in the event that the regular assigned vehicle isn't lift equipped, transportation can be arranged through the university's paratransit service. Shuttle buses that are lift equipped provide transportation to the Towson City Center building.

Paratransit Service

The university's paratransit service provides scheduled pickups to students, faculty and staff with permanent or temporary disability needs who are registered with Disability Support Services. Paratransit vans are equipped with a wheelchair lift and will make pickups at any campus location that is accessible safely by vehicle. Guests may also request paratransit service for their visit. Shuttle buses that are lift equipped provide transportation to the Towson City Center building.

During the fall and spring terms, paratransit service is available around the clock with the exception of 6 a.m.–4 p.m. on Saturdays and Sundays. During breaks, minimester and summer sessions, service is available Monday–Friday from 8 a.m.–4:30 p.m. Transport will be provided within 30 minutes of the requested pickup time. Paratransit service can be requested by calling 410-704-7433 (RIDE). If you require ongoing service, regularly scheduled pickups can be arranged by providing Parking and Transportation Services with your schedule. Paratransit services are not available when the University is closed or during certain hours at times when no shuttles are in operation.
