Dear President Obama:

We, the undersigned organizations and individuals, write to express our deep concern regarding efforts by the Department of Justice to undermine legislation in the last Congress that would have strengthened the Freedom of Information Act (FOIA) and likely are continuing to undermine FOIA amendments proposed by this Congress.<sup>1</sup> We urge you to repudiate the positions taken by the Justice Department and instead publicly and unequivocally endorse the bipartisan FOIA Improvement Act, which was unanimously passed by the Senate on March 15, 2016.<sup>2</sup>

The Justice Department's six-page memorandum<sup>3</sup> on H.R. 1211 -- obtained in response to a FOIA lawsuit and recently made public -- stands in stark contrast with your Day One memo on FOIA, which boldly declared, "in the face of doubt, openness prevails."<sup>4</sup> The recently disclosed DOJ memo voices strong opposition to nearly every provision of the FOIA amendments and, notably, repudiates Attorney General Holder's guidance on implementing a presumption of openness by rejecting a verbatim codification of his language.<sup>5</sup> Without these legislative changes, implementation of the FOIA will remain a matter of policy,<sup>6</sup> not a statutory command, too often driven by partisan political concerns.

The Justice Department's positions are at variance with the underlying intent of the FOIA, good public policy, common sense, and the administration's oft-stated position on transparency. That it required a lawsuit by a reporter to uncover the DOJ memo and the secret lobbying by administration officials in opposition to the legislation speaks volumes.
