As one might expect, yesterday's details about the Republican budget were predictable. Stimulus money made the difference for schools. There was hand ringing and warnings about the April 17th revenue projects to the tune that all bets may be off anyway. Much of what all Indiana school professional recognize as unacceptable was included – tuition tax credits, loss of capital fund transfer ability, end of the deghoster and the removal of tiers within the complexity calculation. ESL support held at current levels and kindergarten funds remained unchanged.

I am confident you are well aware of these points and plan to use them in discussions with legislators. Negotiations between the House and Senate may already be well under way. When you are here next week for the IUSA meeting, these items can be talking points with our state leaders.
