Second March for Marriage on Anniversary of SCOTUS Same-Sex "Marriage" Ruling

The Second Annual March for Marriage took place in Washington, D.C. on Saturday, June 25 – the first anniversary of the U.S. Supreme Court's decision in Obergefell v. Hodges, which mandated genderless marriage nationwide and overturned the results of 32 state marriage-protection referenda.



The March kicked off with a rally at noon on the Capitol Grounds. Between 1 and 2 pm, participants marched from the Unites States Capitol to the Supreme Court. The March included bagpipers from the American Society for the Defense of Tradition, Family and Property.

Speakers at the rally included religious liberty advocate Kassie Dulan, who told the crowd: "Society will tell you that I'm a bit of a dying breed," but "there are hundreds of thousands, if not millions, of young people across America" who believe in natural marriage.

The rally opened with a prayer by Archbishop Timothy Broglio of the Archdiocese for Military Services, who prayed for the victims of the Orlando attack and their families. Bishop Broglio told LifeSiteNews that so-called "gender-neutral" bathrooms go against common sense. "And, of course, common sense is the least

common thing around. It's problematical for the privacy of women; it's problematical for everyone, I think."

Father John Oliver of the Orthodox Church in America found a ray of hope in the success of sexual radicals. Father Oliver reasoned: "If America is in moral decline, if respect for human dignity runs cold,

if our discourse is coarsening, if basic kindness is withering under rampant individualism, if sexual confusion is the new norm, if secularism increasingly defines our laws and institutions, if traditional marriage and family are falling from public favor.... It is also slipping toward the very conditions in which the early Christian faith thrived."

In a statement released prior to the march, Brian Brown – president of both the National Organization for Marriage and World Congress of Families – explained that the goal of this year's march is "to protest the unprecedented and egregiously incorrect ruling of the narrow majority in Obergefell, as well as to advocate defense in law for the rights of people of

faith to abide by their consciences and the mandates of their religion when it comes to recognizing or

Interviews with WCF Leaders in New Documentary on Public Education and Home-Schooling

Alexey Komov (WCF Representative in Russia and the CIS) has produced a hard-hitting new documentary on growing totalitarianism in public education and how this can be countered by homeschooling. The film examines public education in countries of the former Soviet Union and shows how NGOs associated with George Soros are smuggling controversial sexuality education into the curriculum.

Norma Mendoza-Alexandry stated: "It was an honor for me to participate on behalf of Family Watch International in the Argentine conference and to be able to warn parents and religious and community leaders of the harms of comprehensive sexuality education (CSE). Our message was well received, and as a result of the conference, our new documentary, "The War on Children," will now to be shown on TV in Argentina to warn even more parents."

Prof. Nazar observed: "Dr. Sarmiento showed the serious long term effects of contraception, including infertility, cancer, stroke, etc. She explained how in vitro fertilization results in the death of dozens of unborn human beings for each successful birth, through selection, disposal or freezing of embryos."

Nazar explained why a 2.1 Total Fertility Rate is below effective replacement levels, even for developed countries, not only due to higher death rates for women (e.g. contraception and legal-abortion related) but also to current trends in family deconstruction, violence, social instability, disabilities, mental health.

World Congress of Families Managing Director Larry Jacobs congratulated Nazar for "raising the natural family banner in South America."

Jacobs told Nazar: "Salta was our first conference in Argentina and only the second in Latin America. WCF may be the first international nondenominational pro-family organization to do an event in Argentina – thanks to your vision, leadership and hard work."

"We are proud to be allied with you in this historic endeavor. We will continue to work together to build on the success of the first WCF Regional Conference in Argentina."


WCF - PROFILES IN LEADERSHIP

This continues our regular feature celebrating the women and men who have contributed to the growing success of the international pro-family movement.

Frank Schubert

Frank Schubert has twice been named America's top public affairs professional and has been a sought-after advisor to corporations, trade associations and other clients, helping them shape public opinion and secure favorable consideration of legislative proposals, regulatory matters and scores of referendum votes.

Then something happened in 2008 that would not only change his public affairs consultancy, but



Proposition 8 gained international attention, shocking people around the globe who discovered that the notoriously liberal electorate in California had voted to uphold traditional marriage.

"As a practicing Catholic, my involvement in social issues consisted of privately supporting various Catholic groups," Schubert said. "But through Proposition 8, my support of marriage became extremely public. The more I came to realize how important the public purposes of marriage are to society, the more convinced I became that marriage should be preserved and promoted, not redefined and marginalized."

Following the Prop 8 campaign, Schubert was recruited by NOM President Brian Brown to serve as the National Organization for Marriage's political director. Together they won many victories including a statewide referendum fight for marriage in Maine (another notoriously liberal state); recall of three state Supreme Court justices in Iowa, including the Chief Justice, for imposing gay 'marriage' in that state; and voter enactment of a constitutional amendment on marriage in North Carolina.

But Schubert's success on marriage created a conflict regarding the future direction of his public affairs practice. Working on pro-family issues put him at odds with the secular left, making some potential clients reticent to hire his company out of fear of being harassed. At the same time, pro-family issues were emerging on ballots and in the public square. Schubert realized that growing his public affairs firm meant he would have to stop working on social issues.

"After much prayer and discussion with my wife, I concluded that it was probably not an accident that social issues in need of competent professional assistance were emerging on the scene at the very same time as I felt a calling to continued on page 11

Maria Hildingsson

Maria Hildingsson was born in Sweden in 1978. She moved to France in 1997 and then to Belgium in 2010. Since 2009 she had been the Secretary General of the European Federation of Catholic Family Associations in Europe (FAFCE), an NGO founded in 1997 which



represents Catholic Family Associations in 16 European countries. FAFCE was granted participatory status with the Council of Europe in 2001.

Mrs Hildingsson, who previously worked for the French Catholic Family Associations (founded in 1905), was entrusted with the task of opening FAFCE's office in Brussels and building its network.

"It has been a tremendous and exciting task, providing the opportunity to meet with top politicians and officials, and presenting them with our proposals on how to make European policies more family friendly. Family is a highly personal topic, and also of concern to all. This makes it a challenge to promote, especially when you're identified as a Catholic in Brussels," says Hildingsson who was designated one of the 2015 Catholics of the Year by Vatican Insider because of her pro-family work.

Among her achievements in Brussells, the best-known is Mrs Hildingsson's contribution to the defeat of the Estrela Report in 2013, in which she and her organization played a key role.

The Estrela Report sought to establish abortion as a fundamental right in EU and promoted compulsory sexuality education in primary and secondary schools, over the objections of parents, students and educators. It also promoted a fundamental right to abortion, access to contraception and highly criticized sexual education material from the World Health Organization Regional Office in Europe that includes teaching

The Estrela Report campaign was not only a great victory, it also helped mobilize NGOs and continued on page 11

children to masturbate.

Family in America Highlights Economic Consequences of Delayed Marriage

The Family in America: A Journal of Public Policy is the flagship publication of The Howard Center for Family, Religion & Society, a non-profit research center located in Rockford, Illinois. The journal publishes articles which explain that the natural family is the fundamental unit of society, and present research and analysis supporting that proposition.

Each issue of The Family in America features essays by prominent scholars on subjects ranging from a family-centered farm bill to a reevaluation of radical feminism, and from the continued ill effects of divorce and family breakdown to the positive effects of marriage and child-bearing. Each issue also contains a book review section and closes with the ever-popular New Research – brief synopses of the most up-to-date scholarship on family-related subjects.

Here are a few excerpts from a recently featured story in the Winter 2016 issue: "For Love or Money: The Economic Consequences of Delayed Marriage," by Jason Carroll.

"It has been well documented that over the last few decades we have seen a substantial increase in the median age of marriage in the United States. In fact, we are currently at all-time historic highs in these trends. According to the Current Population Survey from the U.S. Census Bureau, the


median age of marriage right now is nearly 29 years for men and 27 years for women."

"It is generally assumed by many that this delay of marriage is a positive trend and that later marriage provides more time for maturation and preparation— especially in regards to economic or career readiness. For these reasons, delayed marriage is actively promoted by parents and others. However, some emerging evidence may challenge this assumption. Particularly when we consider patterns of family formation, family stability, and child well-being, there appear to be some significant trade—offs associated with the delay of marriage. These trade—offs are significant enough, in fact, that the path many young adults are pursuing in an effort to be better prepared for lasting marriage and to have a successful family life is actually producing the opposite of what they intend."

Ruth Institute Statement on DOJ Guidelines to "Ensure the Civil Rights of Transgender Students"

In response to proposed guideline by the U.S. Department of Justice, the Ruth Institute issued the following demurer:

The Ruth Institute objects to these far-reaching Guidelines of questionable legality. Among our chief concerns:

- s These Guidelines, if implemented, will not actually help real children, struggling with unique and complex issues, such as Intersex students and students who experience Gender Dysphoria.
- s The Guidelines permit students to present themselves as "transgender," without the knowledge of their parents, and without any adult input at all.
- s The Guidelines create a class of students called, "Transgender" which is a politically defined and not a medically defined class. The government has no

competency to do such a thing.

s These Guidelines, if implemented, will certainly harm the millions of ordinary children who are not struggling with gender identity issues at this time.

in the US and Europe.

"The ability to dedicate my professional life to pro-family issues has been a tremendous blessing," Schubert said. "Not only do I feel called to these issues, but deepening my own understanding of their importance has helped make me a better man."

grassroots leaders and activists across Europe to an extent never before seen on a pro-life issue. It was clearly a gamechanger in the European context and I am proud to have been part of this battle," says Hildingsson.

Mrs Hildingsson is one of the seven European marriage advocates who have launced the European Citizens Initiative, Mum, Dad & Kids – a European-wide initiative for the protection of marriage and family in the EU, where there's growing the pressure from the LGBT lobby to introduce new definitions of marriage and family.

Mum, Dad & Kids offers an opportunity for the grassroots to express their support for marriage and family, and asks the EU not to pressure member-states on these issues.

"Marriage and family have become a political battleground in Europe and it is shocking to see how European institutions react. This initiative is badly needed to express popular support for marriage and family," says Hildingsson, who is in charge of public relations for the initiative in Brussels.

Ruth Institute Statement on DOJ Guidelines to "Ensure the Civil Rights of Transgender Students"

- s These far-reaching Guidelines from the Federal government encroach on the legitimate prerogatives of states, localities and families.
- s These Guidelines were issued through a "Dear Colleague" letter, which may or may not be legally binding. Indeed, the 23 states that are suing the Department of Justice argue that such a letter is not binding on local schools.
- s School boards are well within their moral and legal rights to decline to participate in the federal government's war against nature.

These Guidelines do not serve the interests of children. Young people are not fully developed in their sense of identity, including their sense of gender identity. Children who are so confused about who they are that they identify as something other than their bodily gender need adult supervision, and greater bodily privacy, not less of each. They would benefit from the supervision and privacy afforded by use of a single stall or staff bathroom.

The public schools have no business enlisting small children in an ideological crusade of any kind. Creating a day to day living environment that implements the most controversial plank of the transgender political regime does exactly that: enlists the children in an ideological crusade. Certainly, the federal government should not be conscripting every public school in America in an ideological movement, and drafting every public school child in America as its foot soldiers.

School boards are well within their moral and legal rights to decline to participate in the federal government's war against nature.
