

## Workplace Bullying **Clinical and Organizational Perspectives**



Are you or your colleagues stressed out at work? Do you feel degraded, humiliated, embarrassed, or threatened? If so, maybe you are a victim of workplace bullying. Although the problem of workplace bullying is not new, the incidence, prevalence, and severity have worsened in the United States. In Workplace Bullying: Clinical and Organizational Perspectives, Judith Geneva Balcerzak provides an understanding of workplace bullying from a theoretical, clinical, organizational, and public policy perspective. This book is unique in that it approaches the subject of workplace bullying from multiple disciplines.

There are few laws that protect workers from emotional abuse. Individuals who have been victims of workplace bullying may develop severe symptoms and illness, including major depression and suicidal ideation. Some bullied workers have become disabled and are unable to continue working or return to work after taking a leave of absence. Because it is not illegal, workplace bullying is difficult to prosecute and perpetrators are rarely held accountable.

This timely resource will serve as a practice guide for social workers, clinicians, practitioners, consultants, and policy advocates addressing the concerns of workplace bullying. It offers strategies for bullying prevention and intervention, treatment, remediation, and advocacy for those who are or have been bullied in the workplace.





### Macro Perspectives on Youths Aging Out of Foster Care Mary E. Collins


For the past 20 years, there has been increased attention to the circumstances under which young adults leave the foster care system when they achieve age-defined adulthood. In the United States, this is referred to as "aging out" of foster care. Typically, these young people did not benefit from a reunification with their family or a permanent family situation with kin or through adoption.

*Macro Perspectives on Youths Aging Out of Foster Care* offers an extensive look at the issue through a macro orientation. Attempting to balance the primary focus on microsystems, and

consistent with a social work perspective, this book aims to provide a greater emphasis on the larger macrosystems of society, policy, organization, and community. Successful or unsuccessful outcomes of the transition from foster care are heavily dependent on the processes and structures that make up the external environment. Youths exiting foster care may be especially influenced by the circumstances of the larger social context because they often lack the mediating advantages of a strong familial connection. After long stays in the foster care system, they may have limited support, skills, and resources required for a healthy, productive, independent adulthood.


### **Social Work Documentation** A Guide to Strengthening Your Case Recording, 2nd Edition



### Returning Home Reintegration after Prison or Jail Stephen J. Bahr


Did you know that each year approximately 600,000 individuals are released from prison in the United States?

### Harm Reduction for High-Risk Adolescent Substance Abusers Maurice S. Fisher Sr.


In today's society, adolescents are faced with several life-changing challenges—peer pressure, bullying, alcohol and drug abuse, diseases, and engaging in various sexual behaviors.

In Harm Reduction for High-Risk Adolescent Substance Abusers, Maurice S. Fisher shares his experience of helping adolescent clients take charge of their life after negative consequences of substance use or abuse, and empowering young men and women to make better choices and minimize risky behaviors, using harm reductive methods.

Harm reductive methods are used for adolescents who are at higher risk for aggression and violence during three phases: while obtaining the drugs, during active use, and during withdrawal from the substances. Fisher explains harm reduction as an evidence-based method that concentrates on behavior modification and refrains from making moral judgments. He recognizes abstinence-only programs as unrealistic, moral value-laden frameworks based on dishonesty and simplifications. It is not the substance use, but rather the physical, psychosocial, emotional, and often legal consequences of use that lead to terrible consequences among adolescents. The book serves as a good resource for therapists, counselors, and clinicians to help adolescents who have lost control and are signaling for help to get their life back on track and grow into adulthood as successful members of society.


### **Caregiving and Care Sharing** A Life Course Perspective Roberta R. Greene and Nancy P. Kropf

identify various experiences of care and provide an opportunity for students and practitioners to develop their own model as professionals who will be part of a caregiving collective.







The PIE Manual, 2nd edition, complements the Person-in-Environment System: The PIE Classification System for Social Functioning Problems, edited by James M. Karls and Karin E. 
### Money and Psychotherapy A Guide for Mental Health Professionals Richard Trachtman

#### Individuals

Individual book buyers have twenty-one (21) calendar days from the date of the original invoice to return a book to NASW for a refund of the purchase price. The purchaser is responsible for all shipping costs unless NASW made an error. Books must be returned in resalable condition. When returning merchandise, indicate the reason on a copy of the original invoice and ship via a traceable method to the address shown on this document.

#### **College or University Class Cancellations**

NASW Press allows 100% return and credit for all books ordered for a college or university class that has been cancelled.

Written proof of class cancellation on college or university letterhead is required in order to process returns.

#### Institutions, Libraries, Bookstores

- No more than 50% of an order may be returned.
- Only 50% of any item on an invoice may be returned.
- Returns must be received no earlier than 90 days or later than 180 days from original invoice date.
- No cash refund for returns. Merchandise credit only. A credit memo will be issued confirming receipt of the returned items and the credit amount.
- Credit must be used within 120 days of original credit memo date.
- A 20% restocking fee will be applied on all returns.
- Books must be unmarked and in resalable condition.
- Postage/freight must be paid by purchaser.
- An NASW invoice must accompany all returns.
- Denied returns will be handled as follows:
