



Indian Affairs Facilities Management System Webinars

Safety and Condition Assessment Portal General Inspection Creation and Data Entry

Description

The Bureau of Indian Education (BIE) in conjunction with Indian Affairs-Facilities Management System (IA-FMS) will conduct a webinar on **Tuesday, April 26, 2016 at 12:00 EDT** on Safety and Condition Assessment Portal (S&CAP) General Inspection Creation and Data Entry. This one-hour webinar will cover the inspection creation and data entry process for a general facilities inspection in the S&CAP, which is the initial point of entry into IA-FMS for most deferred maintenance work orders. This webinar session is intended for users who will be utilizing S&CAP to enter deficiencies into a general facilities inspection. During the webinar, presenters will discuss the following topics:

- Specifying the inspection sites and locations
- Reviewing the existing deficiencies list for repeat deficiencies
- Entering new deficiencies
- Validating locations
- Submitting an inspection

Safety and Condition Assessment Portal Abatement Plans and Cost Estimating

Description

The Bureau of Indian Education (BIE) in conjunction with Indian Affairs-Facilities Management System (IA-FMS) will conduct a webinar on **Thursday, April 28, 2016 at 12:00 EDT** on Safety and Condition Assessment Portal (S&CAP) Abatement Plans and Cost Estimating. Before deficiencies in S&CAP can be sent to Maximo, they need a cost estimate. Deficiencies associated with a safety inspection also need abatement information in S&CAP before being eligible for cost estimating. This one-hour webinar is intended for S&CAP users responsible for creating abatement plans and estimating deficiency costs. The webinar will cover the following topics:

- Creating abatement plans for safety inspections
- Adding abatement information to deficiencies
- Finalizing abatement information to deficiencies
- Running the abatement correction plan report
- Adding a cost estimate to a deficiency
