# **Candidates Statements**

Rule 18.4 - Each nomination <u>shall</u> be accompanied by a written election statement, authorised by the nominee, relating to the nominee and the position for which nomination is made. The statement shall be more than 200 words but not more than 500 words in length, and <u>shall</u> be accompanied by a photograph of the nominee of a size for reasonable reproduction. **A nomination not accompanied by such statement and photograph shall be deemed to be defective.** 

A person may nominate for more than one position at the election, but shall be elected in the order of National President, National Senior Vice-President, National Secretary, National Treasurer, National Vice-President. A separate Nomination Form is required for each position for which you wish to nominate.
