Nominations cannot be withdrawn after 4:00 pm (ACST) on Friday, 30 September 2016. Withdrawal must be made in writing to the Returning Officer.

Any member desiring to nominate for the above positions can apply either personally or in writing to Jeanette Hill, Returning Officer, for a nomination form. The Returning Officer's contact details are below.

Candidates may include with their nomination form, a statement not exceeding 200 words and in respect of Divisional Branch Councillor members 50 words, containing only the candidate's personal history and only the candidate's policy statement.

**Candidate's statements** must be submitted by 4:00 pm (ACST) on Friday 23 September 2016.
