I LUCAS A HOBBS being duly sworn, depose and say:

1. I have arrested:

SIROIS, MICHAEL

2/25/1994 11 TENNEY RD CHESTER, NH 03036

2. I have information that a crime (or offense) has been committed by the defendant as follows:

RSA: 631:1 FIRST DEGREE ASSAULT (F) RSA: 631:2 SECOND DEGREE ASSAULT (F)

- 1.On 5 Nov 2016, at about 0223 hrs, Officers from the Manchester Police Department were dispatched to the area of 134 Amory St for a reported shooting. This address is that of Manchester Fire Department, Engine 6. Manchester Police Officers Alex Reagen and Brian Fleming were first to arrive at the scene.
- 2.Ofc. Reagen reported that upon his arrival, he observed a male laying on the ground in front of 131 Amory St, which is directly across the street from the Manchester Fire Department. He observed members of the Manchester Fire Department rendering aid to the victim. The victim, who was identified as Jarrod Ean-Dixon, was suffering from apparent gunshot wounds to the abdomen area. Ean-Dixon was transported to the CMC Hospital due to his injuries.
- 3.As members of the Fire Department were rendering aid, Ofc. Reagen was able to locate several witnesses. The first witness he spoke with was identified as Cecelia Fairchild. Fairchild reported that she was inside her apartment located at 124 Amory St A1, when she heard a loud argument occurring outside. Fairchild reported that she then went outside to see Ean-Dixon, whom she is familiar with, arguing with two males and a female. Fairchild described the males as both being white males. One is described as bald with a curly beard, about 200-250 pounds, and of average height. The second male was further described as being skinny, with short hair, and a "pointy face". Officers of the Manchester Police were able to identify the first male as Michael Sirois 2-25-1994. The second male was identified as Jason Gerry 12-01-1994. The female was identified as Kasondra Williams 9-12-1996.
- 4.Fairchild reported that she heard the group arguing about a flag, and heard someone say "why would you bring that to my house". Fairchild reported that the verbal argument turned into a physical altercation when Sirois and Gerry began to push Ean-Dixon. Fairchild reported that the pushing escalated and observed Gerry and Ean-Dixon engage in a fist fight. Fairchild reported that as the two were fighting, Williams went over to break up the fight, by grabbing Gerry and removing him from the fight.
- 5. Fairchild reported that as Williams was holding Gerry, Sirois engaged in a fight with Ean-Dixon. Fairchild reported that she hears Sirois yell to Gerry "I'm about to shoot this kid in 3 seconds". Fairchild reported that Ean-Dixon continued to engage in a fight, and eventually fell to the ground. Fairchild reported that as Sirois and Ean-Dixon were on

the ground, Gerry broke free from William's grip, and ran over and delivered a hard kick to the facial area of Ean-Dixon.

- 6. Fairchild reported that after observing the strike, she hears about 3 gunshots. Fairchild reported that after hearing the shots, she observes Williams bleeding and limping, and believed that Williams was shot. She observes Williams, Sirois, and Gerry run to a white sedan. Fairchild reported that as Sirois was entering the vehicle, she observed him place a black pistol into a holster he had on his right hip. She then observes Ean-Dixon laying on the ground.
- 7.After speaking with Fairchild, Ofc Reagen would speak with witness Michael Robinson. Robinson reported that he was home at 429 Cartier St when he heard a loud argument outside. 429 Cartier St is at the intersection of Amory St. Robinson reported that upon hearing the argument, he walked outside to see what was occurring. Robinson reported that he observes Ean-Dixon arguing with Sirois and Gerry. Robinson reported that the argument became physical when Gerry punches Ean-Dixon in the face. Robinson described the punch as a "sucker punch". Robinson reported that Ean-Dixon and Gerry engaged in a physical fight until Williams came over and broke up the two. Robinson reported that as Williams was moving Gerry, he observed Sirois begin to punch Ean-Dixon about the facial area. Robinson reported that as Ean-Dixon and Sirois are fighting, they fall to the ground. Once on the ground, Robinson observed Gerry break free of Williams, and run over and kick Ean-Dixon in the facial area.
- 8.Robinson reported that after Ean-Dixon was kicked in the face by Gerry, he observed Sirois pull a gun from his waistline while on the ground, and fired 4 shots at Ean-Dixon at near point blank range. Robinson described the gun as a black handgun, and believed that the handgun was a Glock. Robinson reported that after Ean-Dixon was shot, he observed Williams, Sirois and Gerry run to a white BMW. Robinson noted that as they were running to the BMW, Williams yelled out that she had been shot.
- 9.After speaking with Robinson, Ofc. Reagen was able to speak with an additional witness identified as Alexander Wied. Wied reported that he was inside 131 Amory St when he heard the argument outside. Wied reported that upon hearing the argument, he went outside to see Ean-Dixon physically fighting with Sirois. Wied reported that at this time, Ean-Dixon was on the ground with Sirois when Gerry ran up and kicked Ean-Dixon in the facial area. Wied reported that after Gerry kicked Ean-Dixon in the facial area, he observed Sirois remove a black handgun from the holster on his waistline. Wied reported that he then observed Sirois shoot Ean-Dixon 3 times from point blank range. Wied reported that after Sirois shot Ean-Dixon, he observed Williams, Gerry, and Sirois run to a white BMW, then flee the area west on Amory St.
- 10. Witnesses on the scene were able to clearly describe the vehicle. The vehicle was described as a white BMW. Further, witnesses were able to provide the displayed license plate on the vehicle. The license plate was NH 4064979. The vehicle is registered to Kasondra Williams as the sole owner, and is listed as being a 2008 white BMW 528XI.

- 11. The vehicle information was provided to the Manchester Police Department dispatch center. The dispatch center disseminated the vehicle information to include make, model, color, and license plate number to other officers in the area.
- 12.At about 0225 hrs, Officers Michael Dejoy and Robert Bifsha were working together as a two officer vehicle. Ofc. Bifsha reported that he and Ofc. Dejoy were canvassing the area searching for the white BMW bearing NH 4064979. Ofc. Bifsha reported as they were traveling east on Putnam St approaching Dubuque St, he observed the white BMW bearing NH 4064979 facing west on Putnam St at Dubuque St. Ofc. Bifsha reported that he observed a male driver of the vehicle.
- 13.Ofc. Bifsha reported that as the vehicle passed them westerly, he was able to see a female sitting behind the driver and another male sitting in the rear seat, passenger side. Further, Ofc. Bifsha reported seeing a large amount of what appeared to be blood, on the bottom rear passenger's side door.
- 14. The vehicle matched what was reported by witnesses. Further, the vehicle was occupied by a female and two males reported by witnesses. The vehicle also had an amount of blood on the exterior, lower rear passenger's door. Ofc. Bifsha reported that due to the vehicle matching exactly, he conducted a motor vehicle stop of the vehicle. Ofc. Bifsha reported that he activated the emergency lights. Ofc. Bifsha reported that the vehicle turned onto Cartier St, where the vehicle stopped.
- 15.Once the vehicle stopped, the occupants were ordered out of the vehicle. First, the driver was ordered out of the vehicle. The driver was identified as Gerry. Next the rear passenger, on the passenger's side was ordered out of the vehicle. He was identified as Sirois. Ofc. Bifsha reported that as Sirois was exiting the vehicle, he stated "the gun is on the passenger's seat". Finally, the rear passenger behind the driver's side was ordered out of the vehicle. This passenger was Williams. Once Williams was out of the vehicle, she stated that she was shot. Ofc. Bifsha reported that he did see that Williams was bleeding from the left thigh. Ofc. Bifsha then went to Williams to offer aid. Upon doing so, Ofc. Bifsha reported that he observed a black handgun on the rear passenger's seat.
- 16. Through witness statements, Sirois was ultimately taken into custody subsequently charged with first degree assault (NH RSA 631:1). Sirois did purposely or knowingly cause serious bodily injury by shooting Ean-Dixon by means of a deadly weapon, to wit a firearm. Sirois is additionally charged with second degree assault for recklessly causing bodily injury to Williams by means of a deadly weapon, to wit a firearm.
