For the purposes of this authorisation instrument, "Authorised Person" means a member of, or the Secretary to, the Authority, the Liquor and Gambling Commissioner of South Australia or the Commissioner of Police for South Australia and any other person authorised by one of them, proof of which shall be an original letter of authority signed by one of them in respect of me.

I **HEREBY AUTHORISE** an Authorised Person to have access to inspect and obtain copies of:

(a) any credit report, other report, legal or commercial information derived from those reports with a bearing on my credit worthiness, credit history, credit standing or credit capacity;

- (b) any payment information, loan information, cheque account records, savings deposit records, safe deposit box records, passbook records and bank statement sheets pertaining to me;
- (c) any records relating to investigations of my activities conducted by any police force, crime investigation agency or gambling regulatory body of South Australia or another Australia jurisdiction or a like body of jurisdiction outside Australia;
- (d) any court records relating to any present or past civil or criminal court proceedings to which I am or have been a party; and
