I solemnly swear that I was born at *Hallstadt, Rhenish Bavaria* on or about the *14th* day of *March*, 18*69*; that I emigrated to the United States, sailing on board the *Eider*, from *Bremen*, on or about the *7th* day of *October*, 18*75*; that I resided *19 1/2* years, uninterruptedly, in the United States, from *Sept 8, 1880* to *the present time*; that I was naturalized as a citizen of the United States before the *Superior* Court of *Washington*, *King Co*, at *Seattle*, on the *27th* day of *October*, 18*92*, as shown by the accompanying Certificate of Naturalization; that I am the IDENTICAL PERSON described in said Certificate; that I am domiciled in the United States, my permanent residence being at *Monte Cristo*, in the State of *Washington*, where I follow the occupation of *Hotelkeeper*; that I am about to go abroad temporarily; and that I intend to return to the United States *within a year's time*, with the purpose of residing and performing the duties of citizenship therein.
