I, Fred Trump, a NATURALIZED AND LOYAL CITIZEN
OF THE UNITED STATES, hereby apply to the Department of State, at Washington, for a pass-
port for myself, accompanied by my wife and baby,
as follows: Elizabeth Trump, born at Kallstadt, Germany, on the 10th day
of October, 1887; and baby Elizabeth two months
old.

I solemnly swear that I was born at Kallstadt, Germany, on or about
the 14th day of March, 1869; that I emigrated to the United States, sailing
on board the A. J. Eider, from Bremen, on or about the
15th day of October, 1885; that I resided 18 years, uninterrupted, in the
United States, from 1885 to 1904, at Seattle, Wash.; that I was naturalized
as a citizen of the United States before the Superior court of Seattle, Wash.,
at Seattle, on the 27th day of October, 1894, as shown by the ac-
companying Certificate of Naturalization; that I am the IDENTICAL PERSON described in said
Certificate; that I am domiciled in the United States, my permanent residence being at.....
New York, in the State of New York, where I follow the occupation of
Butcher; that I am about to go abroad temporarily; and that I intend to return to
the United States within a year, with the purpose of residing and performing
the duties of citizenship therein.
